
(57) **CLAIM**

The ornamental design for a smart watch with tachymeter, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, right front perspective view of a smart watch with tachymeter showing my new design;  
FIG. 2 is a top, left rear perspective view thereof;  
FIG. 3 is a bottom left perspective view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a front elevational view thereof;  
FIG. 7 is a right side elevational view thereof; and,  
FIG. 8 is a left side elevational view thereof.  
The features depicted by broken lines in FIGS. 1, 2, and 4 have been shown for the purpose of illustrating portions of the smart watch with tachymeter that form no part of the claimed design.
















