

(54) Title: STRUCTURE OF BRUSH FOR EXAMINING UTERINE CERVICAL CANCER

(57) Abstract

Provided with a brush (300) for use in an examination method of uterine cervical cancer which has a brush part (1) formed on a 15 cm-length and 2.5 mm-diameter soft plastic grip (2), the brush (300) including: a 1.2 cm-length screw wire being provided with the 5 mm-diameter brush part (1) formed thereon, wherein the screw wire with the brush part (1) is inserted lengthwise in the grip (2); and a 5 mm-diameter side brush part (1') being formed integrally with the brush part (1) on either side or both sides of the 2 cm-length screw wire.
