

(57) Abstract: Embodiments of the present invention provide systems and methods for facilitating communication of data. A method (600) includes providing quality of service in a network including receiving data, prioritizing the data, transforming the data to generate transformed data, and communicating the transformed data. The data is received based at least in part on a first protocol. The data is prioritized to support a quality of service standard. The transformed data is based at least in part on a second protocol. The second protocol is different from the first protocol.
