

(57) Abstract: The present invention generally relates to log messages (11) processing such that event s cant be detected and alarms can be generated. The system (20) provides for a log manager (13) that is communicatively to various computers (10) to receiv the log messages (11) generated thereform. The log messages (11) are generated by a variety of network platforms. A log managers described herein collect such log data/message using various protocols to determine events. The system (20) is generally configured with the event manager (14) to process the event messages to determine whether an alarm should be generated (analysis) therefrom.
