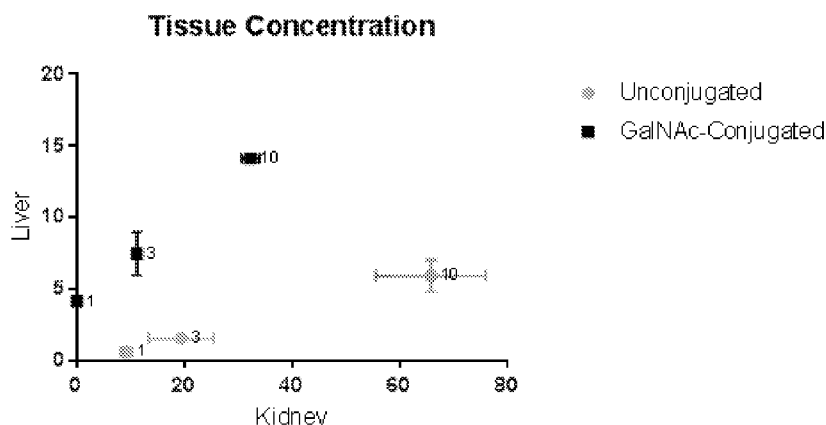

(57) Abstract: Provided herein are compositions and methods for facilitating or enhancing delivery of nucleic acids, such as synthetic mRNAs, into cells or tissues. Such compositions and methods may include use of a targeting moiety-conjugated, such as an N-acetyl-galactosamine (GalNAc)-conjugated, oligonucleotide to facilitate or enhance delivery.
