(57) **CLAIM**

The ornamental design for an eyeglass ear stem, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an eyeglass temple with an ear stem embodying the design of the present invention; FIG. 2 is an end view of the eyeglass ear stem of FIG. 1; FIG. 3 is an end view of the eyeglass ear stem of FIG. 1 from the opposite direction as FIG. 2;


FIG. 4 is a top view of FIG. 1;

FIG. 5 is a perspective view of the opposite side of the eyeglass ear stem shown in FIG. 1; and,

FIG. 6 is a bottom view of FIG. 5.




