

IMPROVEMENT IN COMPARTMENT-CANES.

The Schedule referred to in these Letters Patent and making part of the same.

To all whom it may concern:

Be it known that I, Lucius C. Heylin, of the city of Philadelphia, county of Philadelphia, and State of Pennsylvania, have invented a new and improved "Combination-Cane;" and I do hereby declare that the following is a full, clear, and exact description of the construction and operation of the same, reference being had to the accompanying drawings, making a part of this specification, in which—
Figure 1 is a perspective view of my cane.

Figure 2 is a vertical section of same, showing the different compartments.

Figures 3 and 4 are views showing the pipe and cap

detached from the cane.

The object of my invention is to provide a cane with different compartments, to act as a receptacle for matches, smoking-tobacco, cigars, pipe, and stem.

To enable others skilled in the art to make and use my invention I will now proceed to describe its con-

struction and operation.

I make my cane hollow, and in seven different parts, which I will style as follows: First, cap C; second, pipe P; third and fourth, (although inseparable,) cigarcase S C, and tobacco-pouch T P; fifth, pipe-stem holder P S H; sixth, match-safe M S; seventh, extra cap E C for head of cane when pipe P is in use.

Pipe P is a pipe of ordinary construction, the bowl B of said pipe being coated on the inside with a plaster to prevent its burning out. On the lower part of the bowl is a chamber, N, for inserting the pipe-stem, and also acting as a plug. On the upper and lower parts of

the bowl B is cut a thread corresponding with cap C and cigar-case S C. Parts S C and T P are secured together by a tight-fitting joint, with a partition, P N, between, the lower end of T P being provided with a thread corresponding with part P S H, in which it screws. The opening on the end of T P, which converts with P S H, is closed by a coal C of a set of the provided with P S H. is closed by a coal C. so as to prove nects with PSH, is closed by a cork, C, so as to prevent the smoking-tobacco from entering chamber PS

H. On the lower end of part PS H is cut a thread corresponding with thread in MS, in which it screws, the opening in part PS H, which connects with MS, being closed by means of a plug or partition, PN. Lower part of MS is provided with a ferrule, F.

In removing the pipe P from the cane, extra cap E

C is screwed on to act as a head. Having thus described my invention, its construction and operation,

What I claim, and desire to secure by Letters Patent

of the United States, is-

A cane arranged as herein described, whereby one portion thereof is adapted to be used as a pipe, the handle of which is contained in a compartment formed in the same, and other portions of the body of the cane being provided with receptacles for cigars, tobacco, and matches, the whole constructed as herein described.
