FIG. 4 is a drawing of a right side thereof.

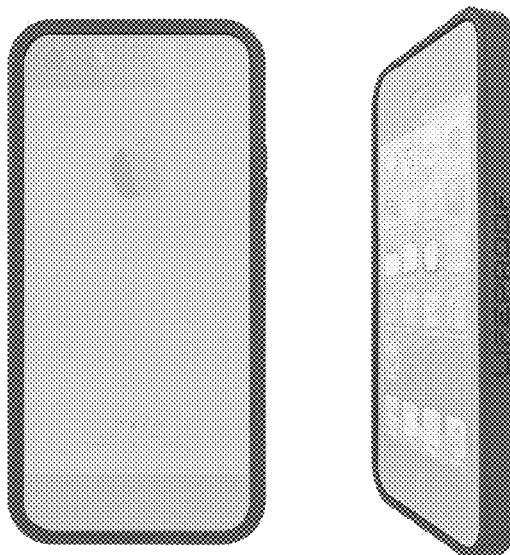
FIG. 5 is a drawing of a top side thereof.

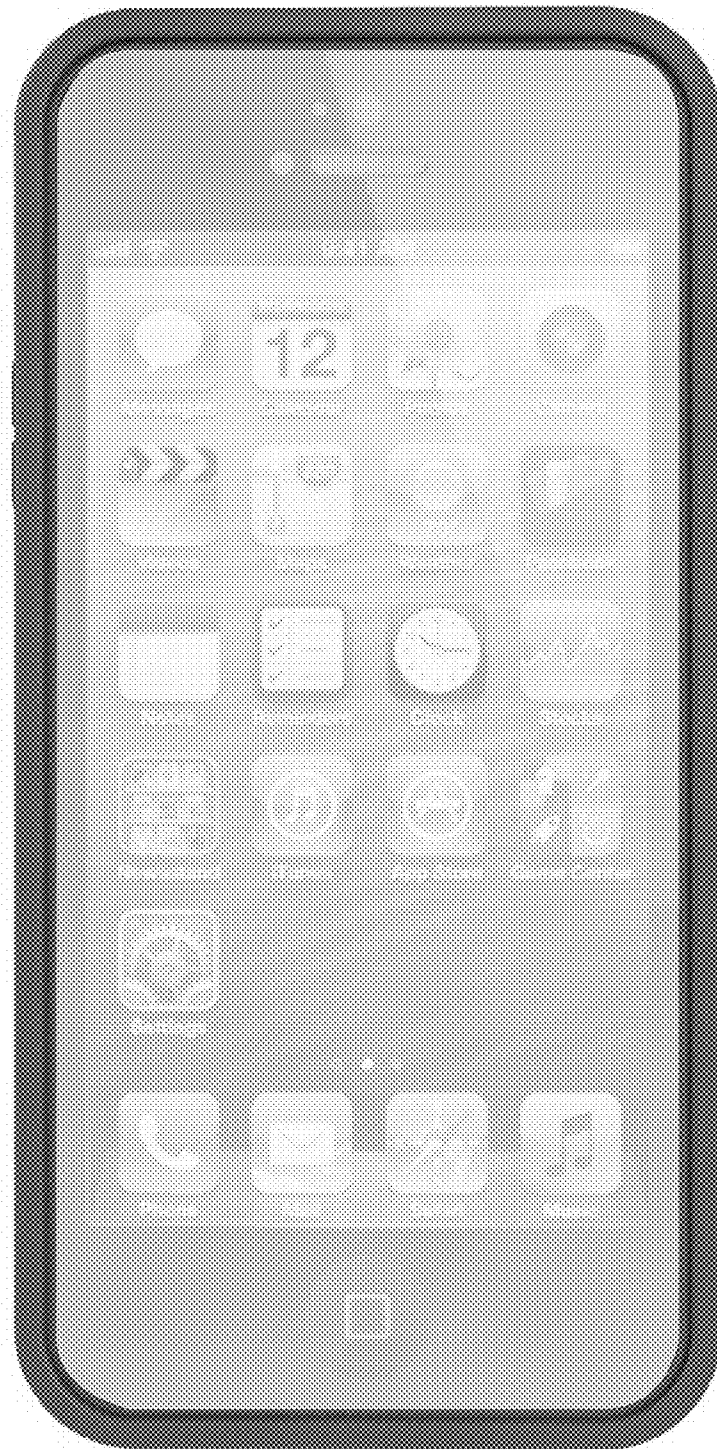

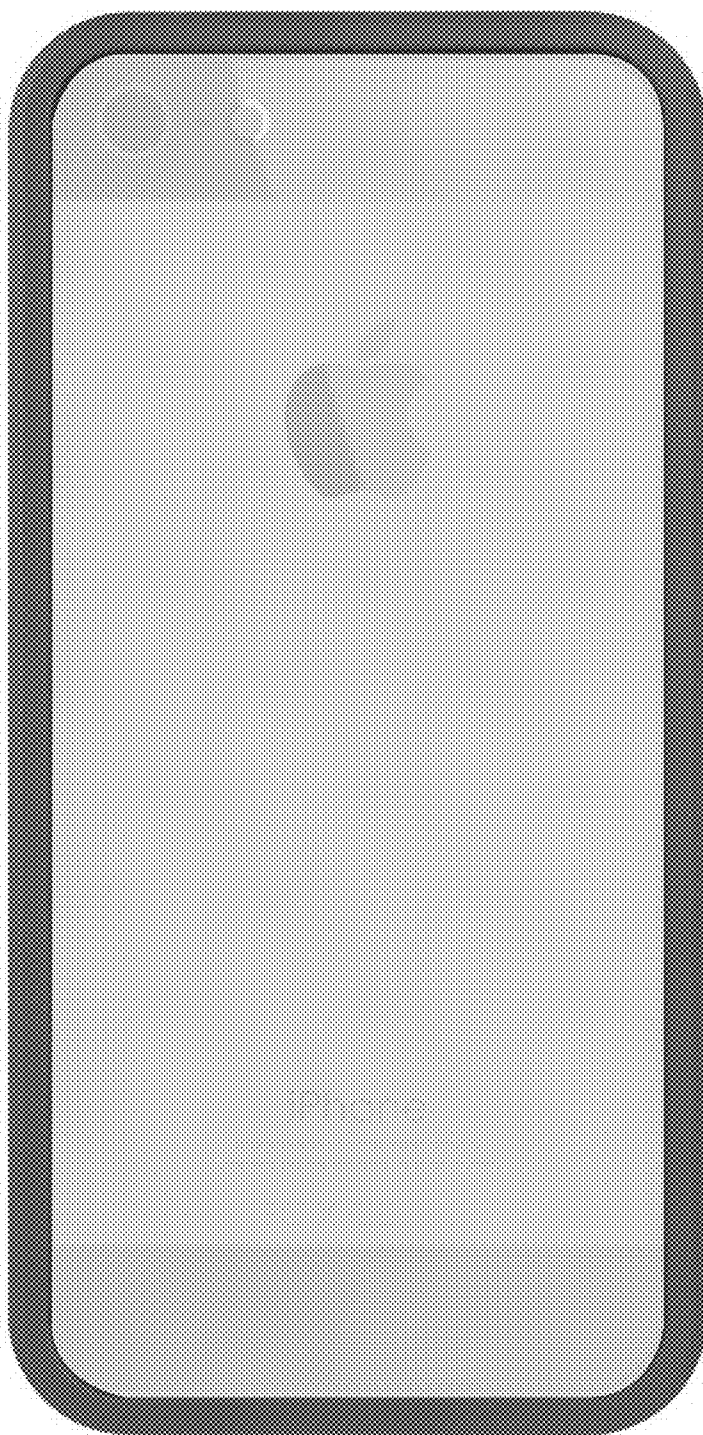

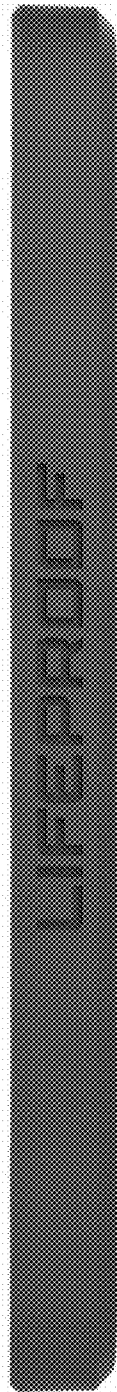

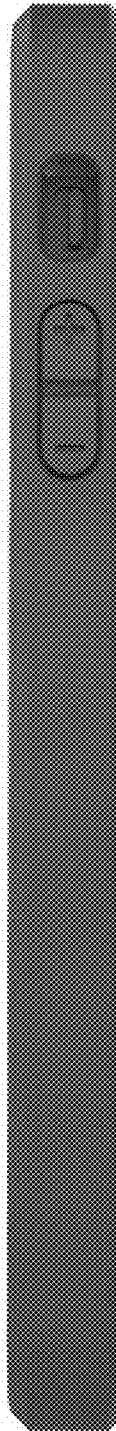

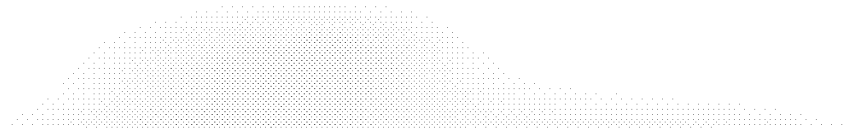
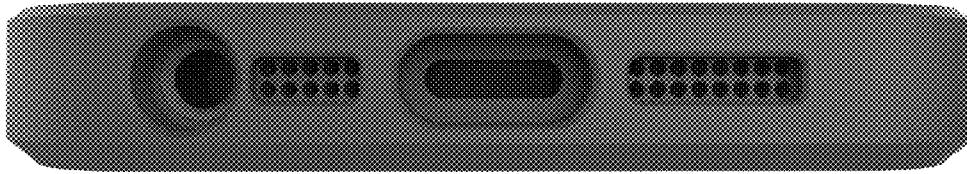

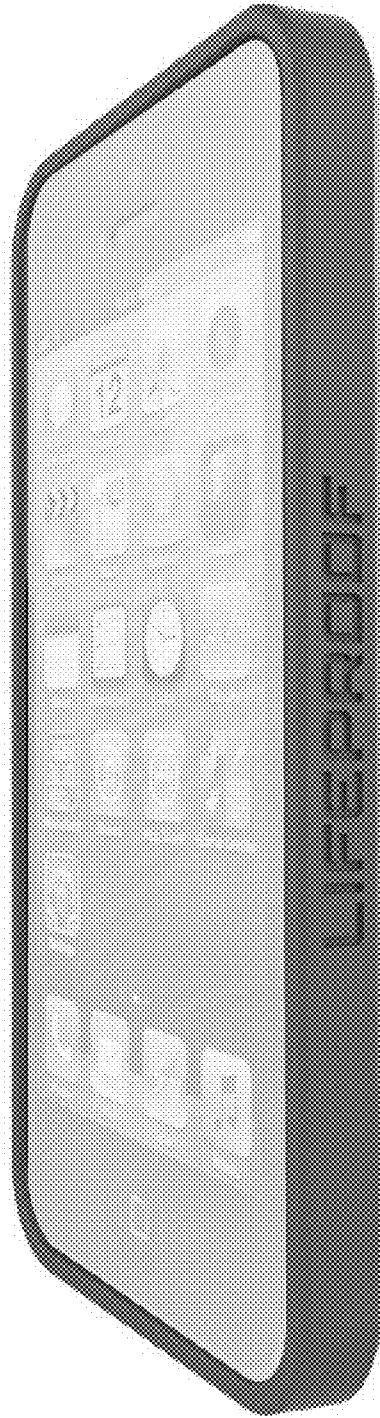
