DESCRIPTION


FIG. 1 is a top plan view of the desk showing the design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a front side elevational view thereof, the rear side elevational view being a mirror image thereof; FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof; FIG. 5 is a perspective view thereof, shown in a first environment of use; and, FIG. 6 is a perspective view thereof, shown in a second environment of use.












