The ornamental design for a wastebasket, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a wastebasket showing our new design;

FIG. 2 is a top plan view thereof;

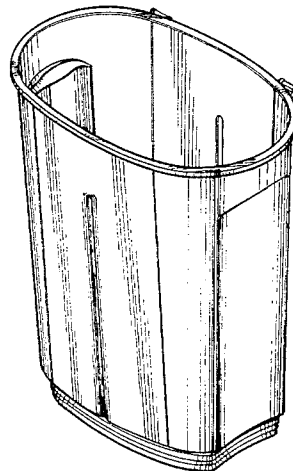
FIG. 3 is a front elevational view thereof;

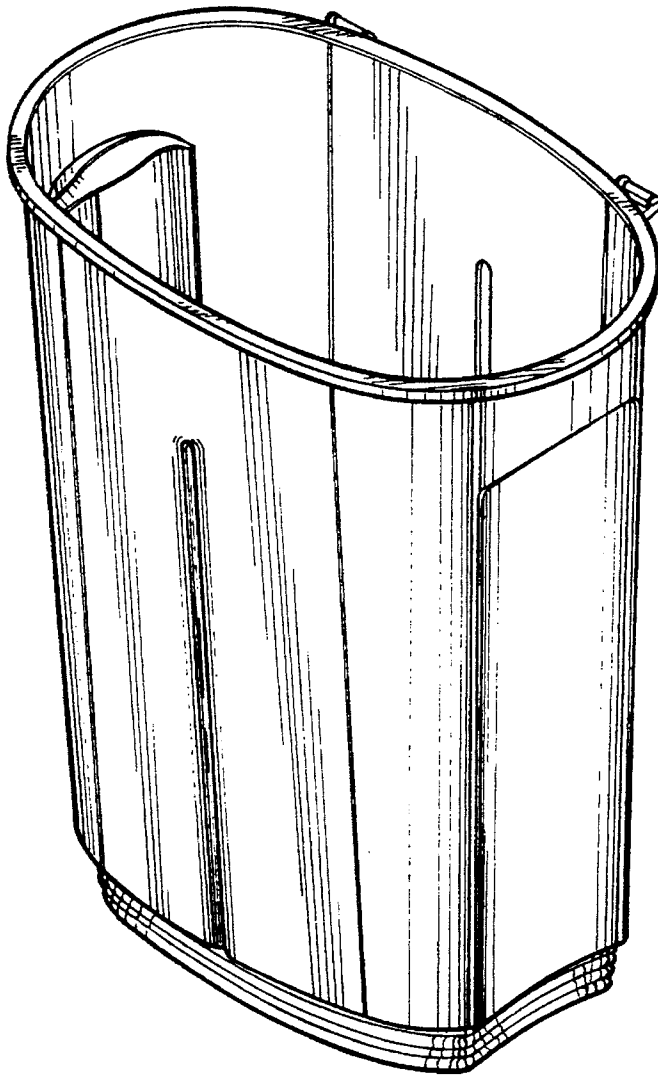

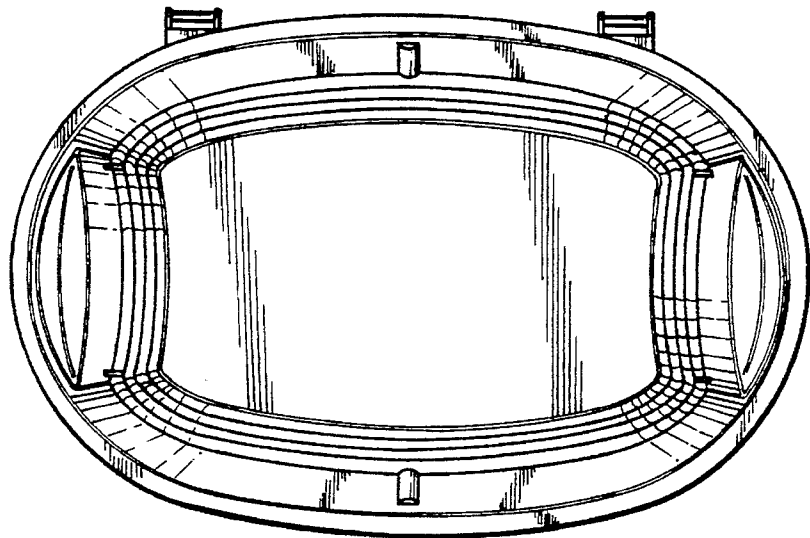

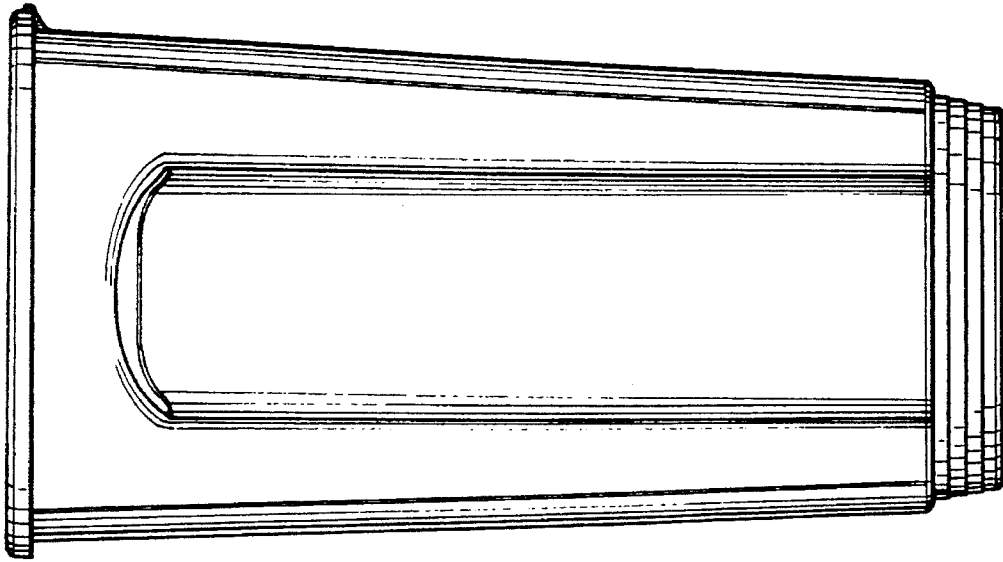

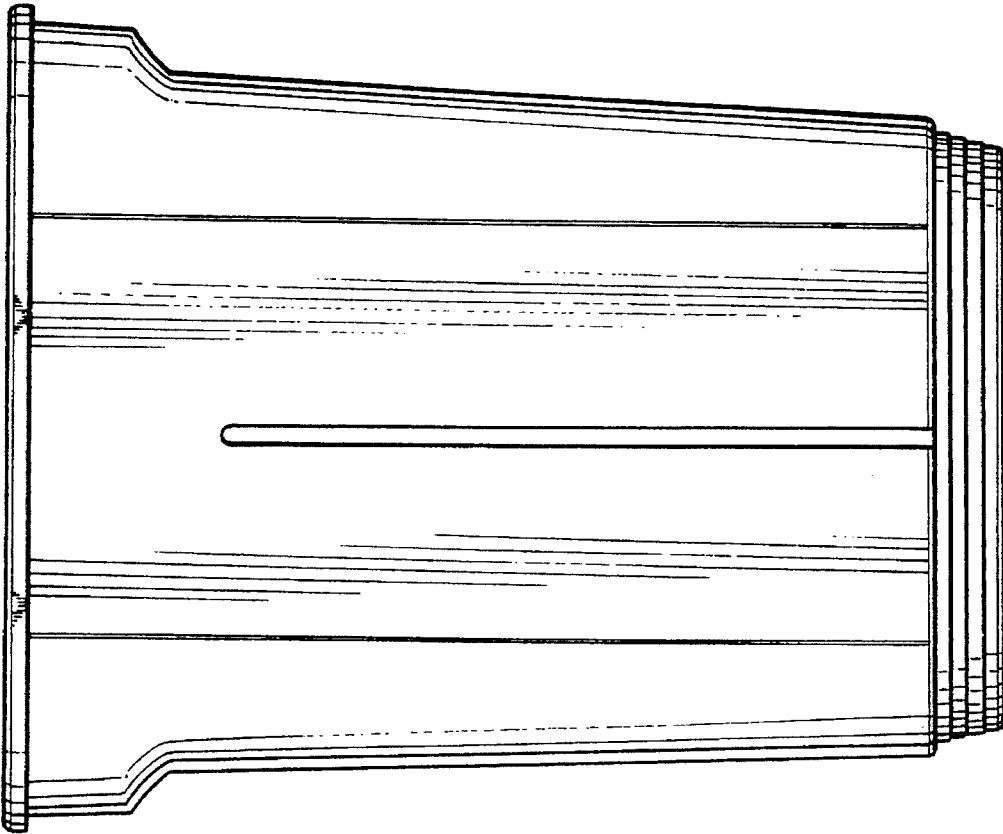

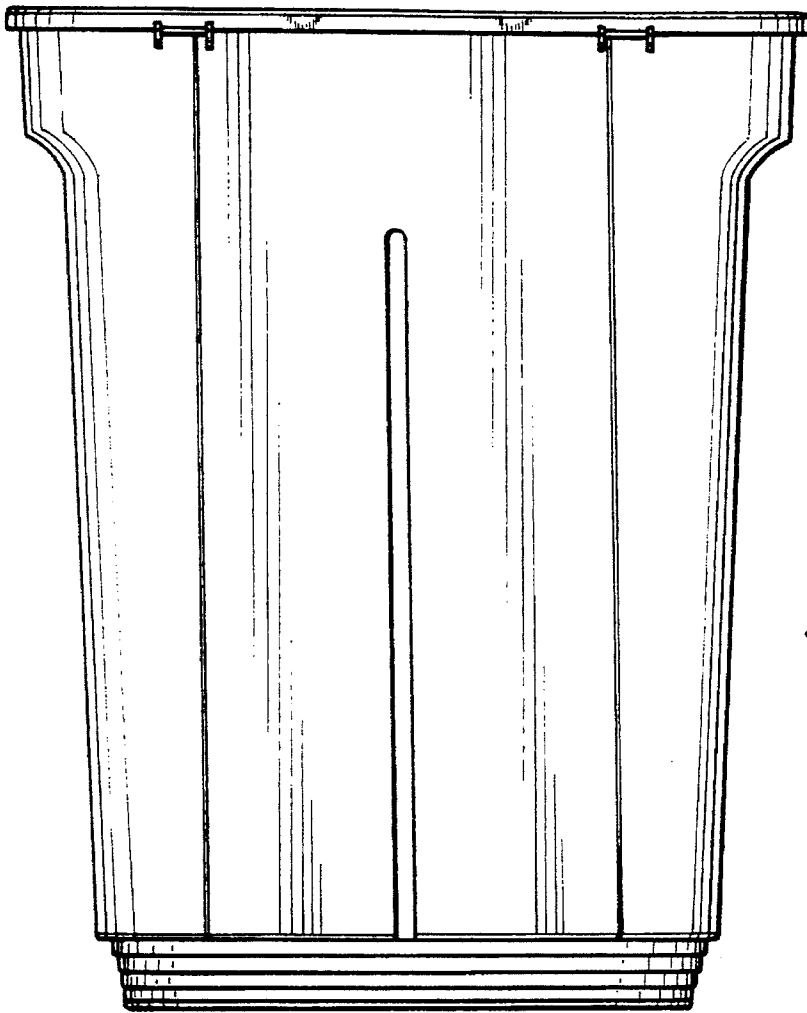

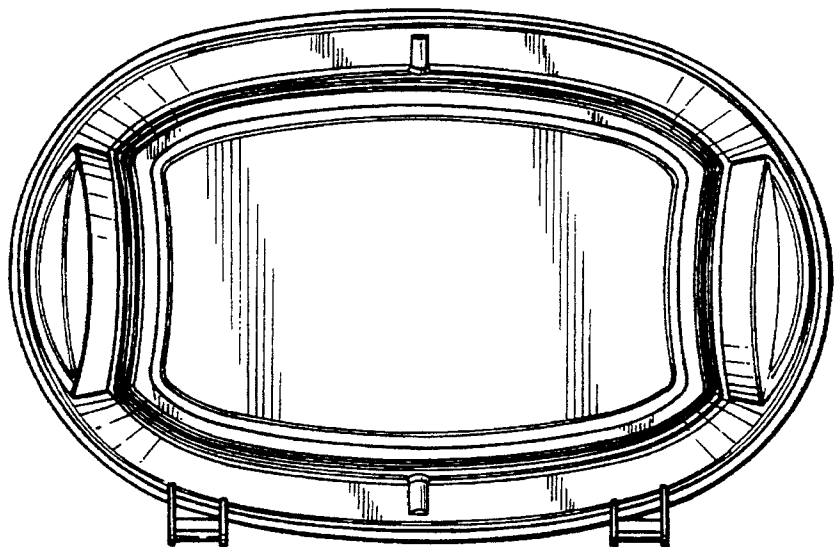
