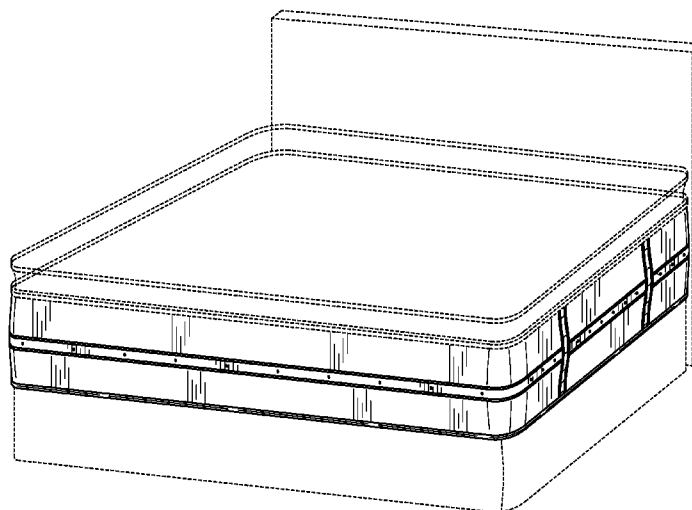
(57) **CLAIM**

The ornamental design for a mattress border, as shown and described.

DESCRIPTION

FIG. 1 is a front and side view of a mattress border, showing my new design;
FIG. 2 is a side view of the mattress border;
FIG. 3 is a fragmentary side view of a mattress border on an enlarged scale; and,
FIG. 4 is a front view of the mattress border.
The broken lines in the drawings are for illustrative purposes and form no part of the claimed design.

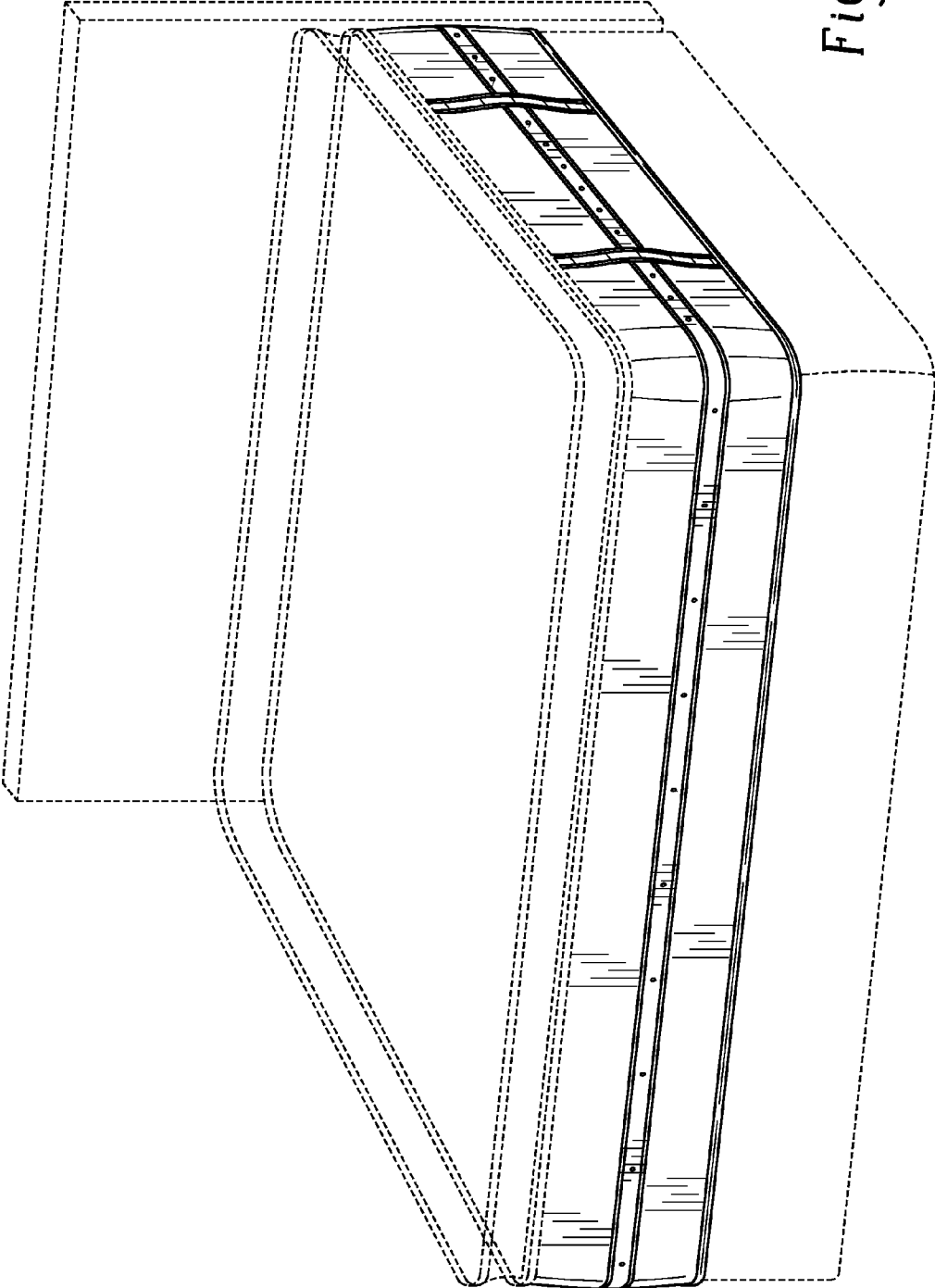

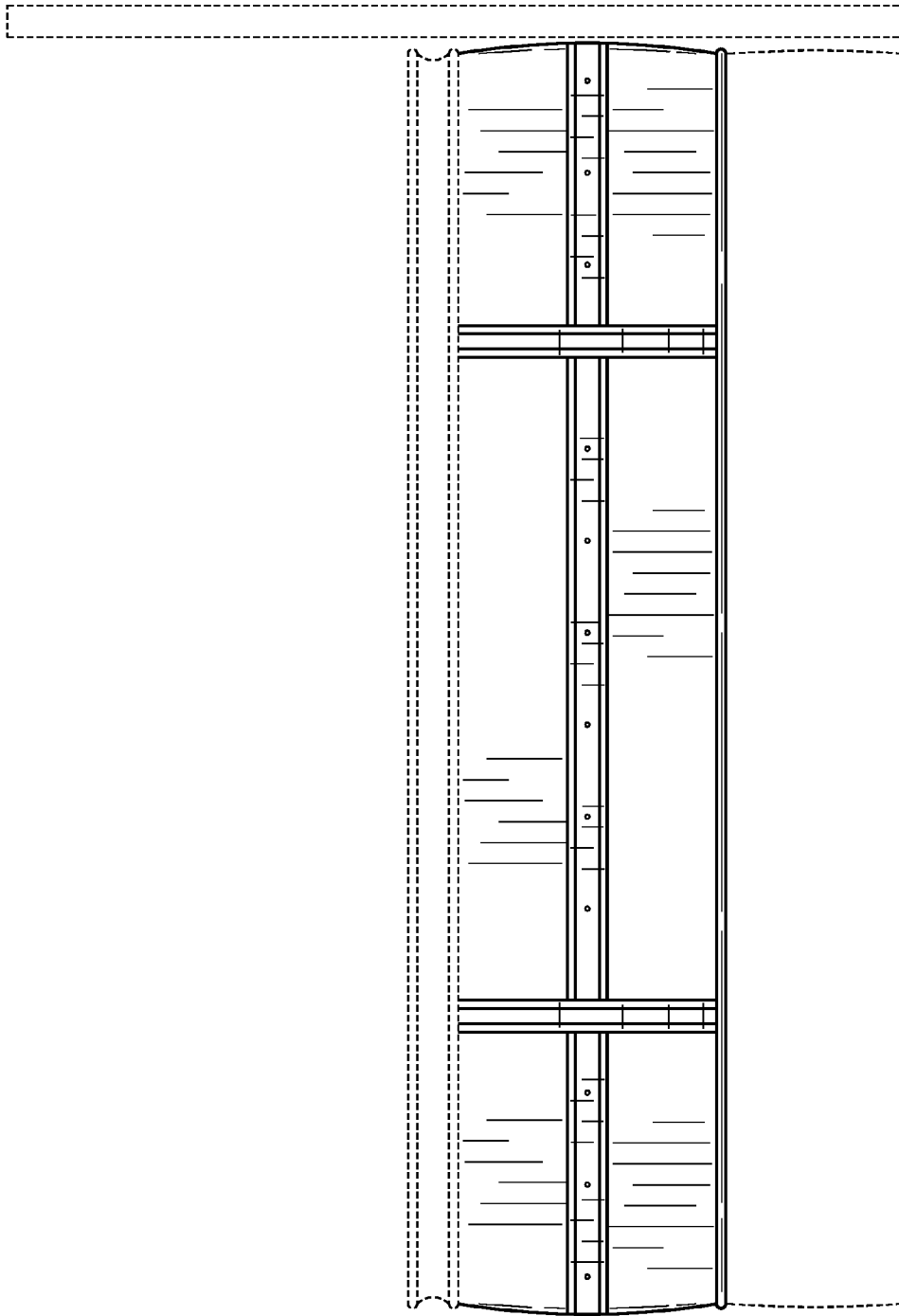

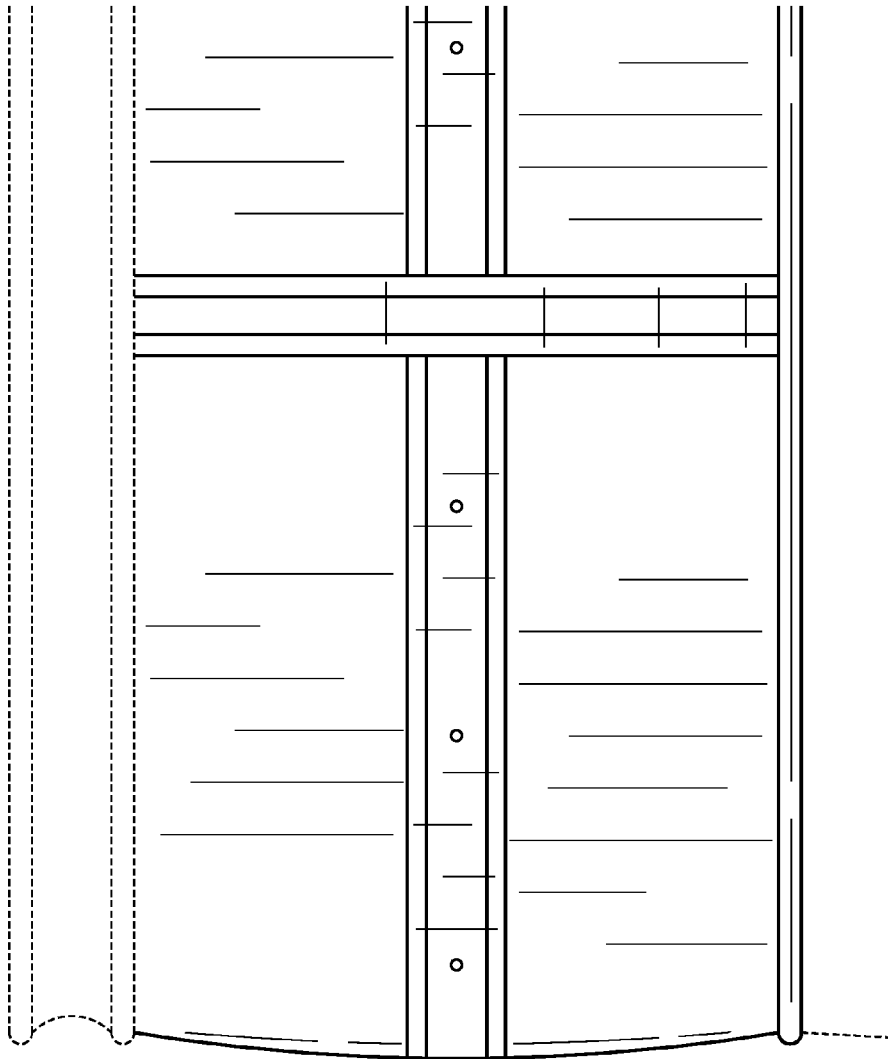

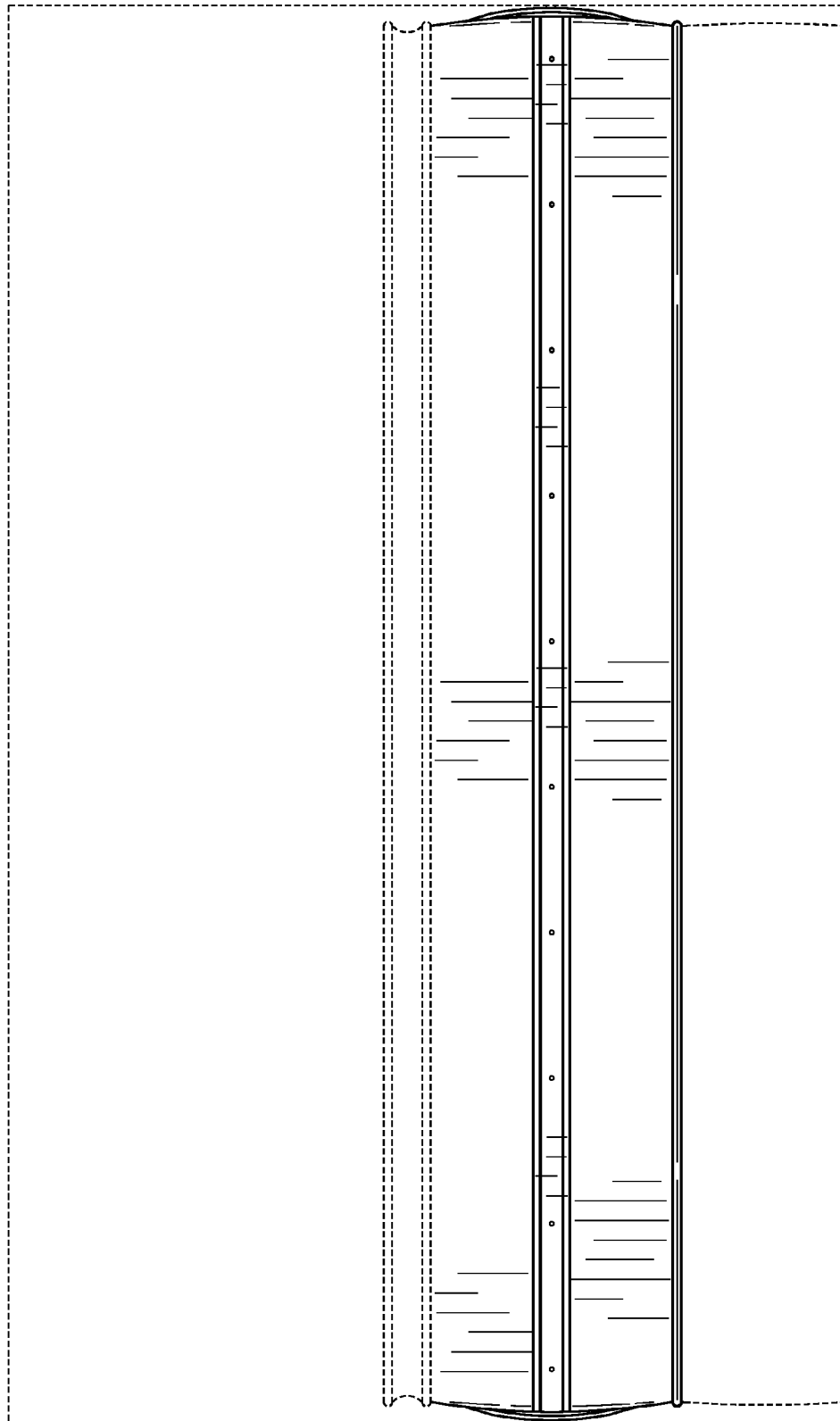
