



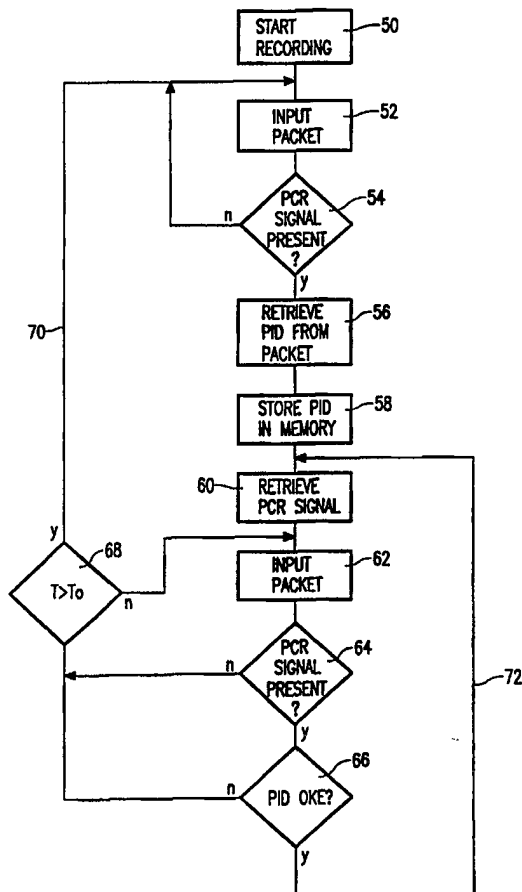

(54) Title: RECORDING OF A DIGITAL INFORMATION SIGNAL ON A RECORD CARRIER

(57) Abstract

The invention relates to the recording of a plurality of programs included in an MPEG transport stream on a record carrier. Time stamps should be derived, using PCR values included in the transport stream. The present invention gives an improved proposal for deriving PCR values from the transport stream.
