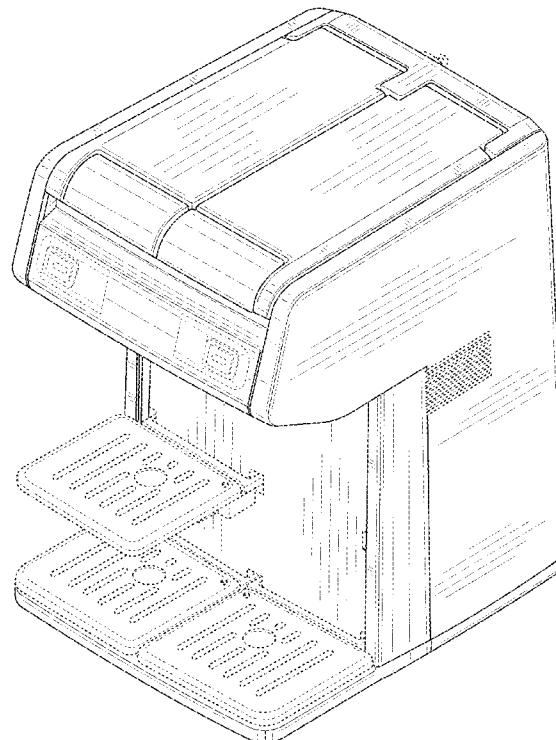
(57) **CLAIM**

The ornamental design for a coffeemaker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view as seen from the top, front and right side of a coffeemaker showing the new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. The broken lines in the drawings depict portions of the coffeemaker that form no part of the claimed design.

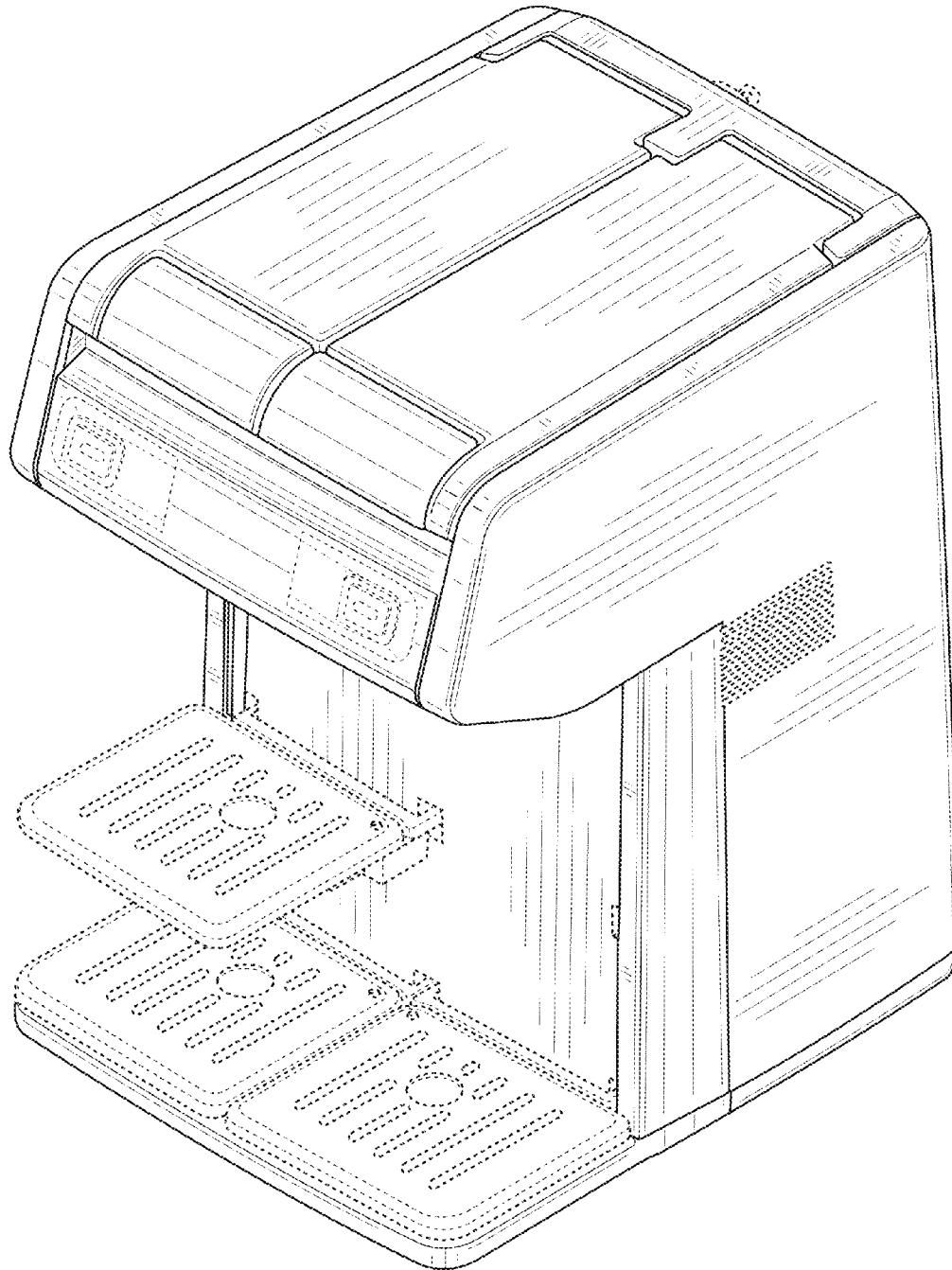

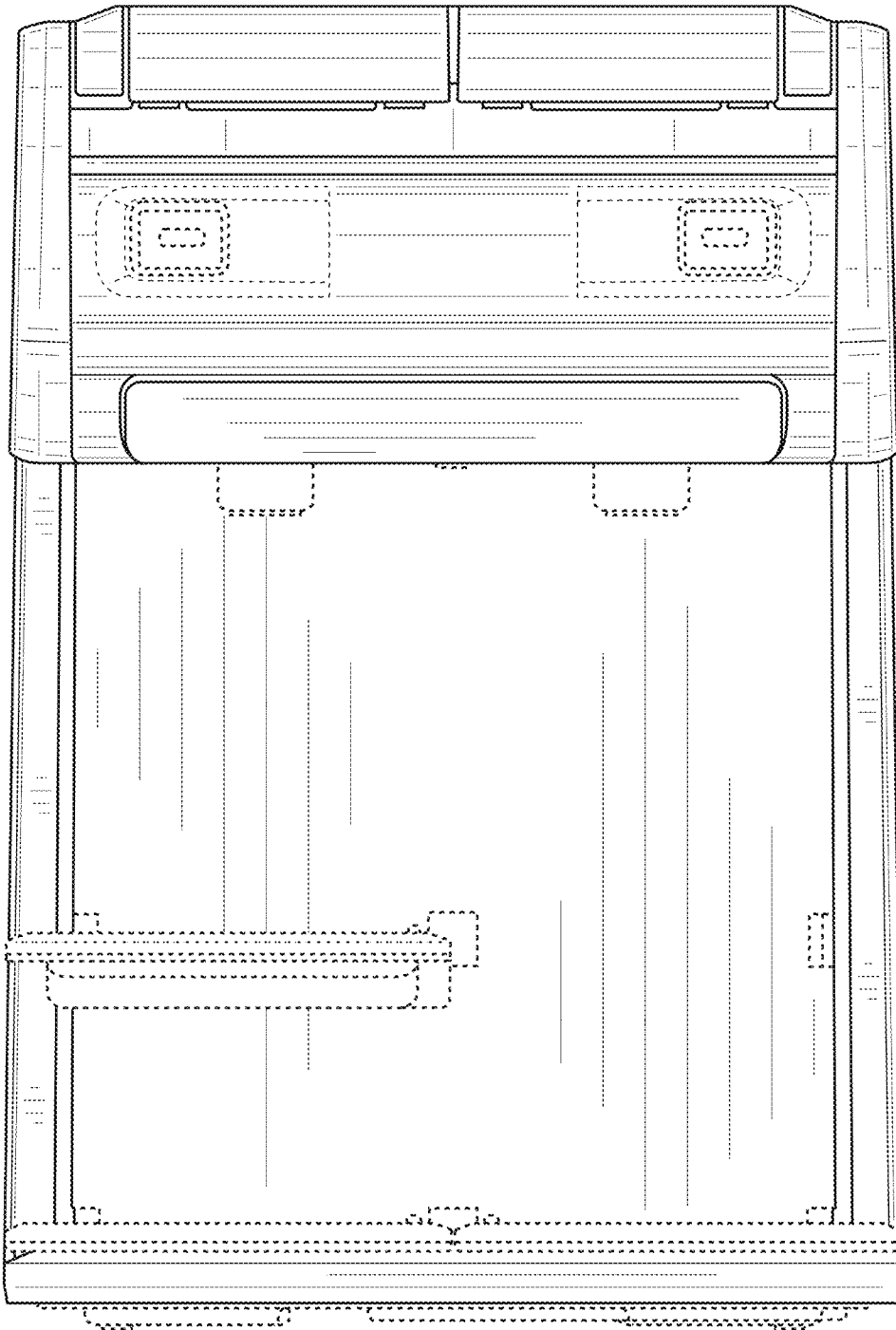

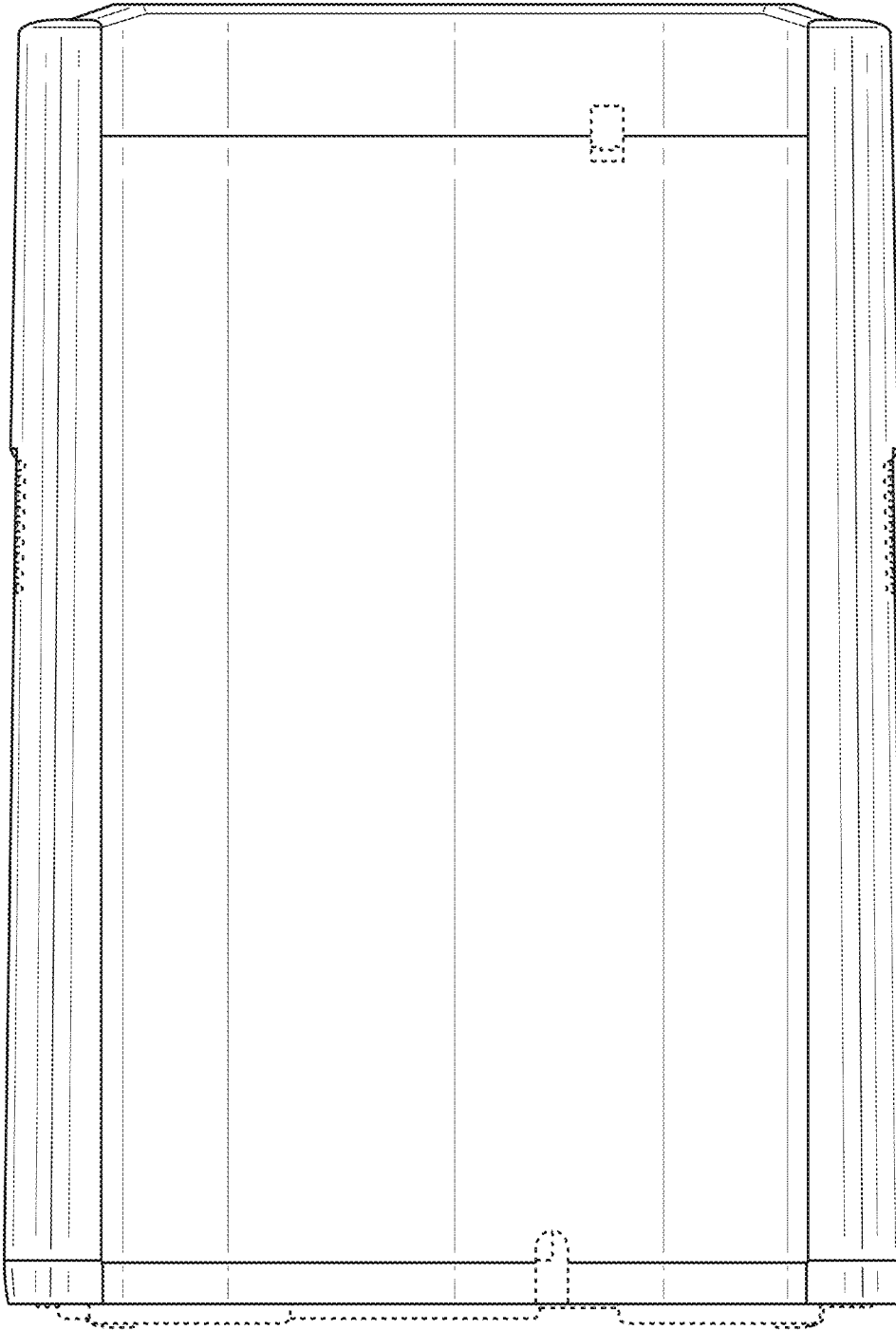

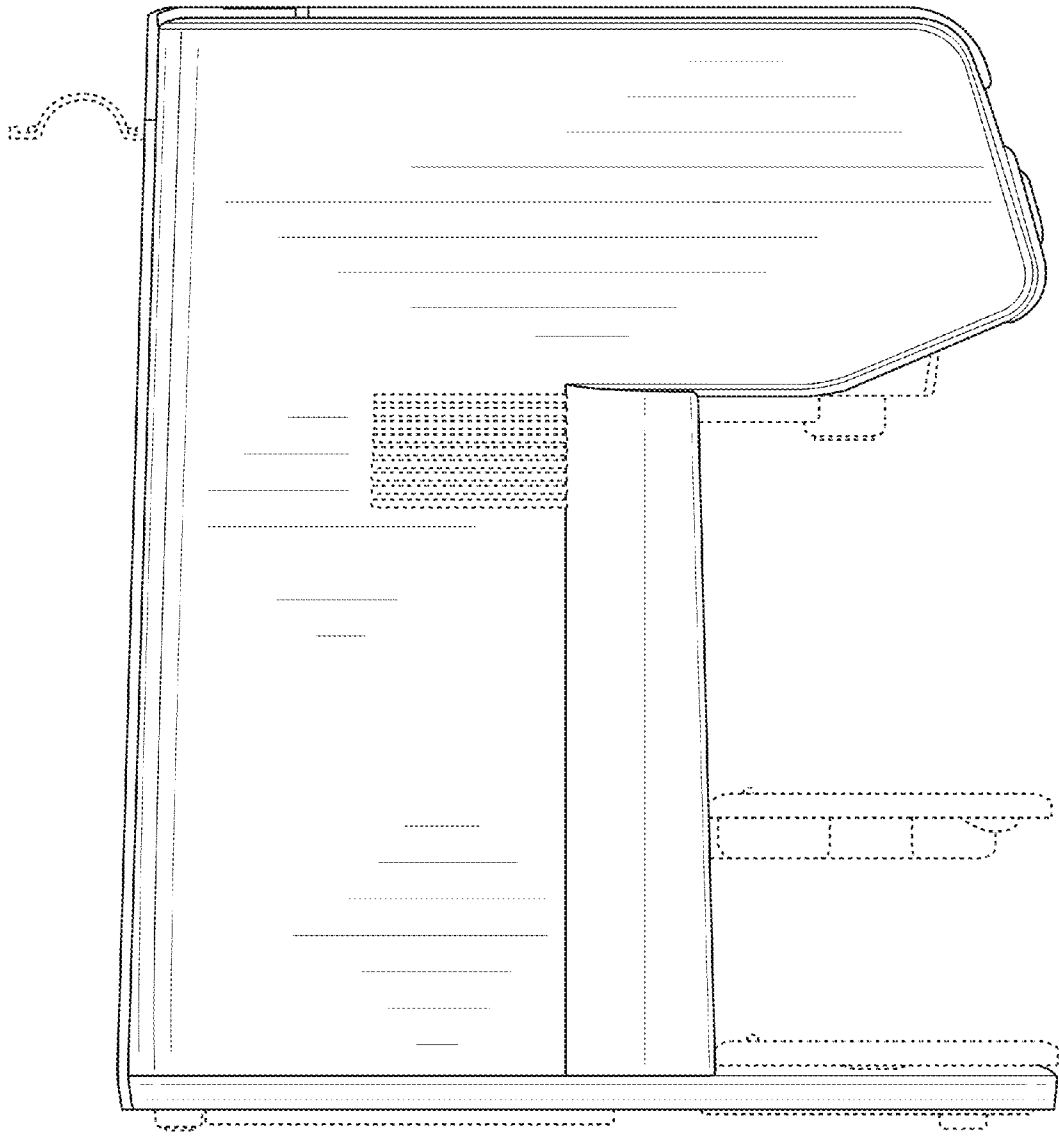

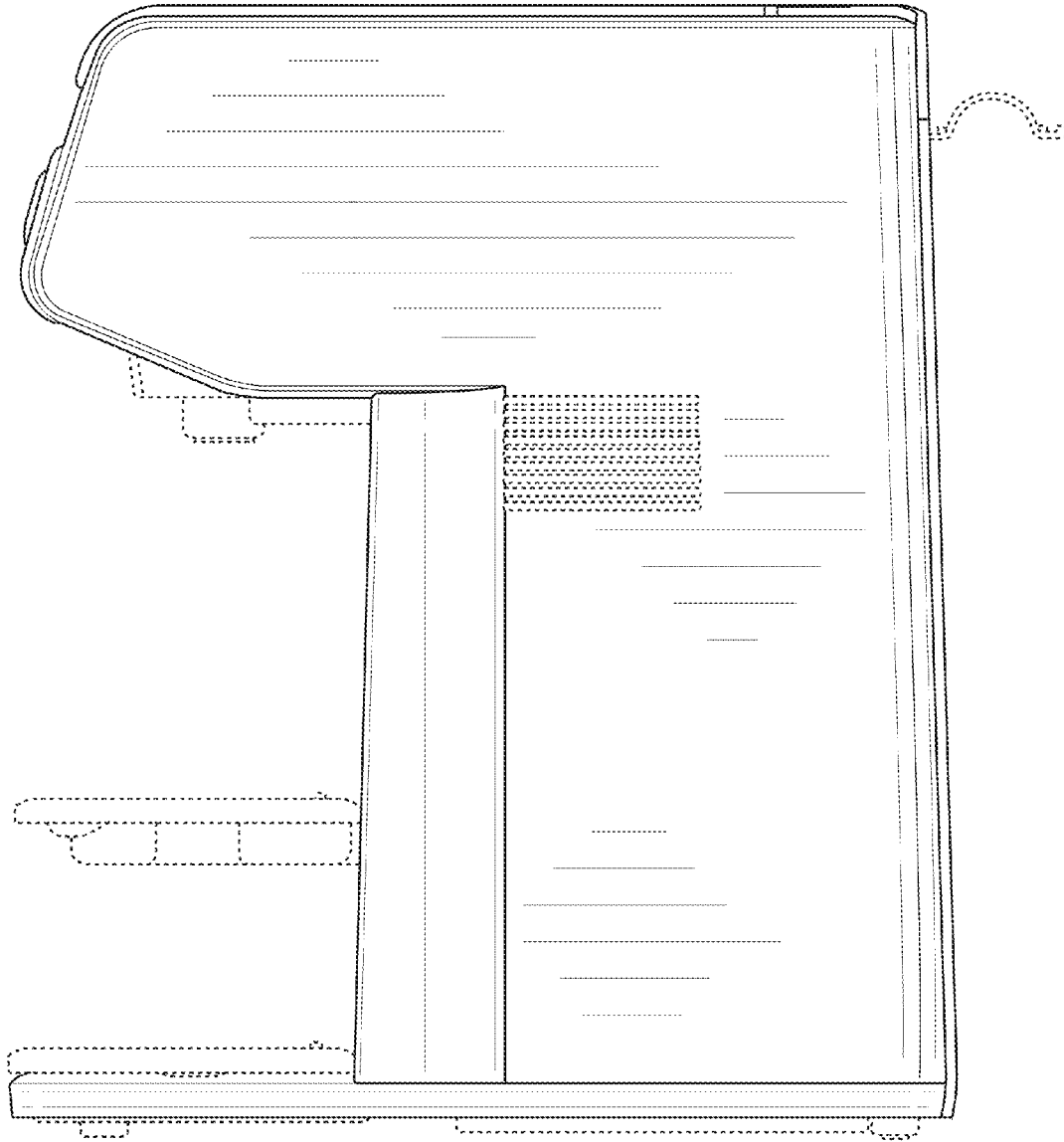

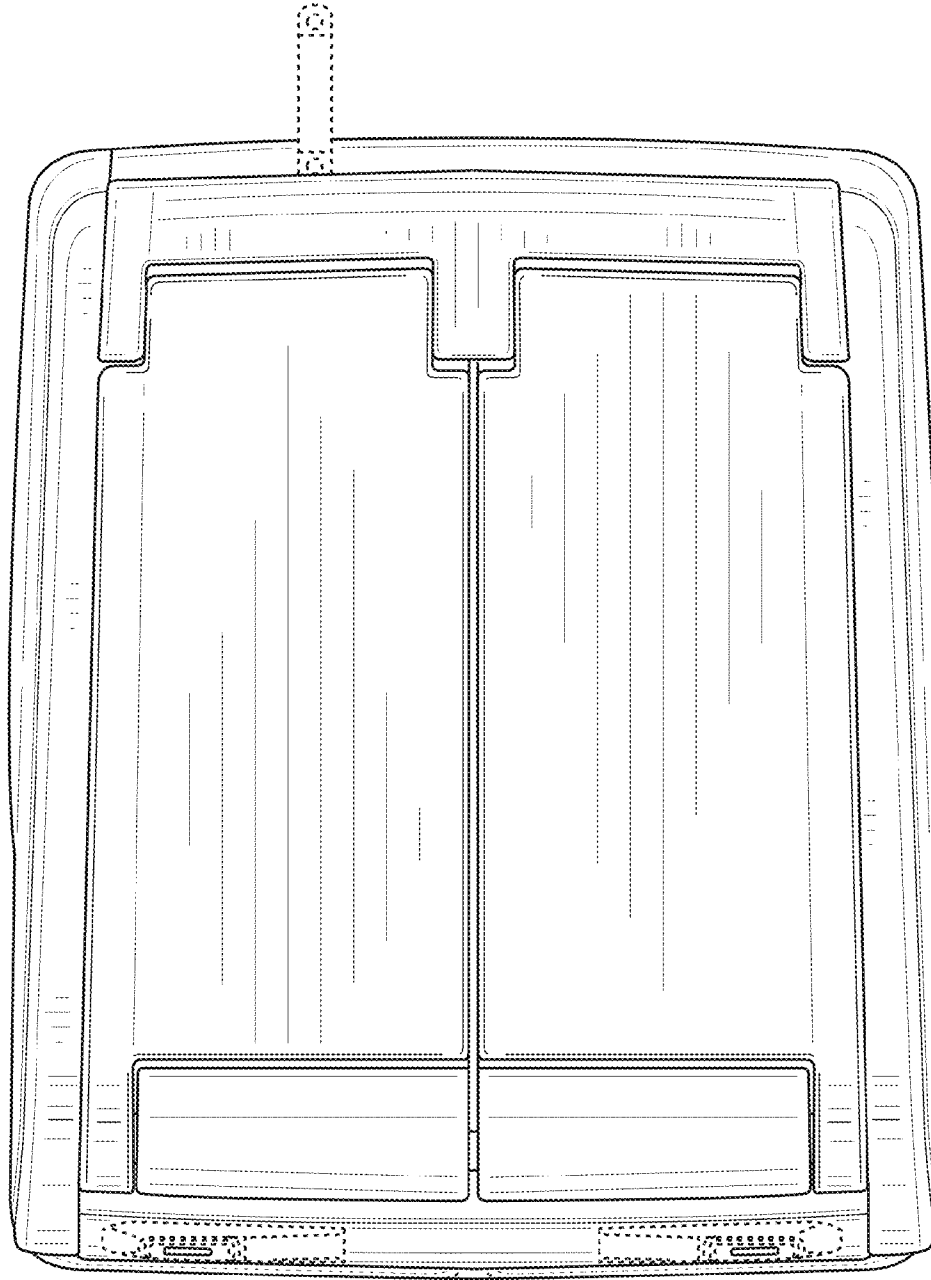

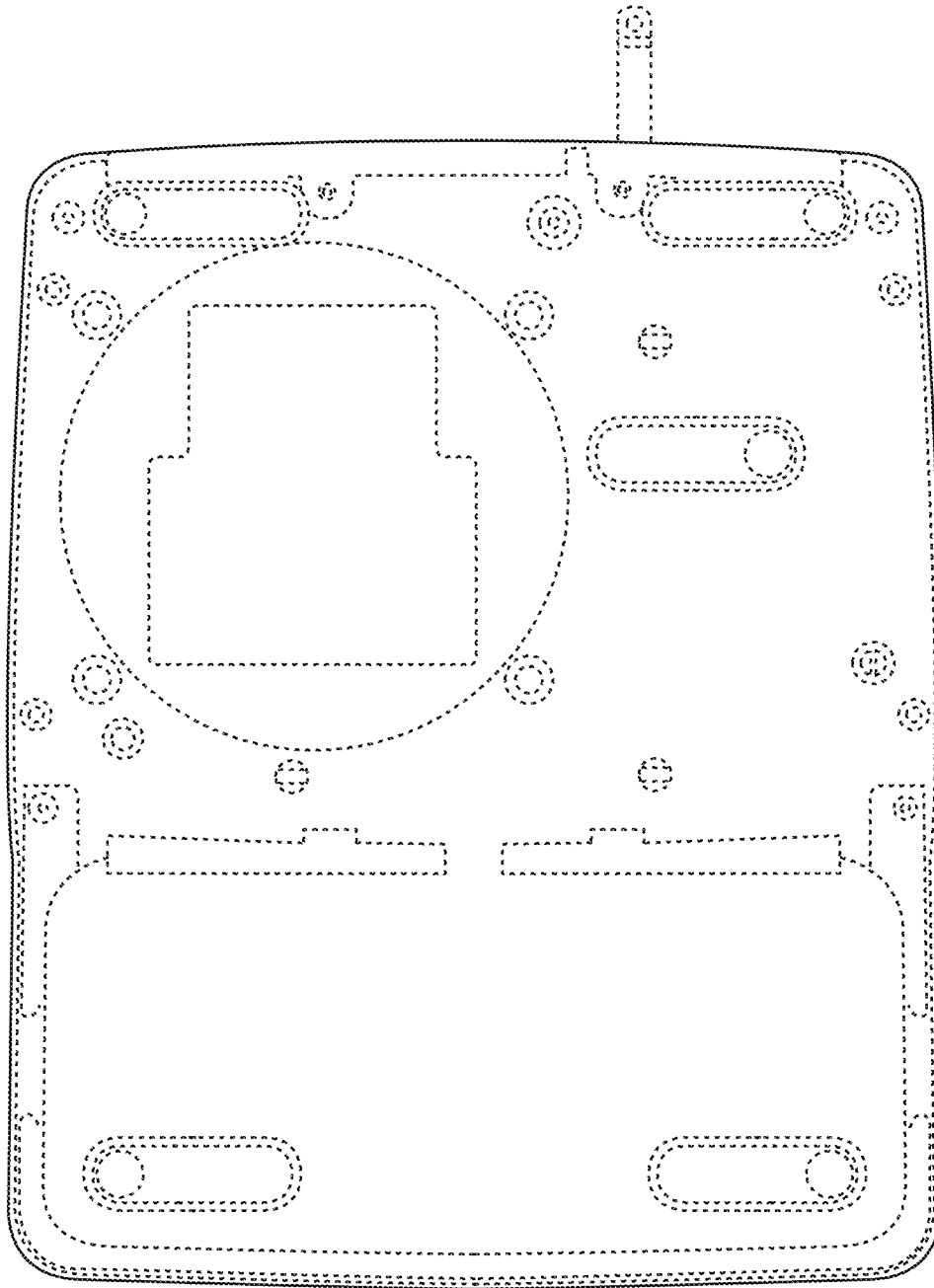
