
(57) **CLAIM**

The ornamental design for a frame for fixing camera, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a frame for fixing camera according to the present design;
FIG. 2 is a rear view of the frame for fixing camera of FIG. 1;
FIG. 3 is a left view of the frame for fixing camera of FIG. 1;
FIG. 4 is a right side view of the frame for fixing camera of FIG. 1;
FIG. 5 is a top view of the frame for fixing camera of FIG. 1;
FIG. 6 is a bottom view of the frame for fixing camera of FIG. 1; and,














