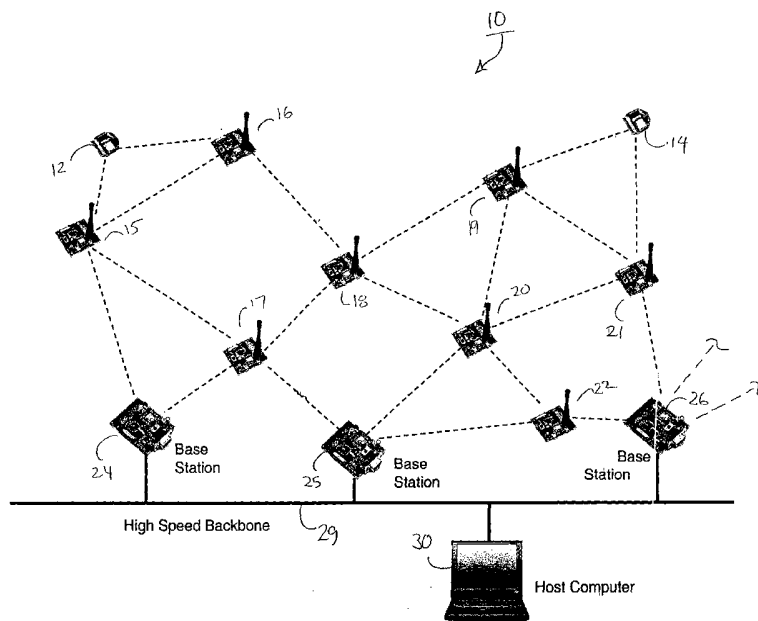

(54) Title: PROTOCOL FOR CONFIGURING A WIRELESS NETWORK



(57) Abstract: A target device joins a wireless network (10) by attempting to locate an existing routing device (15-26) in a predefined neighborhood of the wireless network, designating the existing routing device (15-26) as a master routing device if the existing routing device is located in the predefined neighborhood, where the master routing device is a primary recipient of data from the target device, and attempting to locate end point devices (12,14) in the predefined neighborhood if the existing routing device is not located in the predefined neighborhood.
