(57) **CLAIM**

The ornamental design for a "drinking bottle," as shown and described.

DESCRIPTION

FIG. 1 is a front view of the drinking bottle, wherein the cover is closed and operatively connected to a base portion of the top;

FIG. 2 is a rear view of the drinking bottle;

FIG. 3 is a right side view, the opposite side view being a mirror image thereof;

FIG. 4 is a top view of the drinking bottle;


FIG. 5 is a bottom view of the drinking bottle;

FIG. 6 is a right front perspective view of the drinking bottle; and,














