The ornamental design for a pair of table legs, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pair of table legs in accordance with a preferred embodiment of the present invention;

FIG. 2 is a front view of the pair of table legs shown in FIG. 1, with the back view being a mirror image thereof;


FIG. 3 is a right side view of the pair of table legs shown in FIG. 1, with the left side view being a mirror image thereof;

FIG. 4 is a top view of the pair of table legs shown in FIG. 1; and,






