



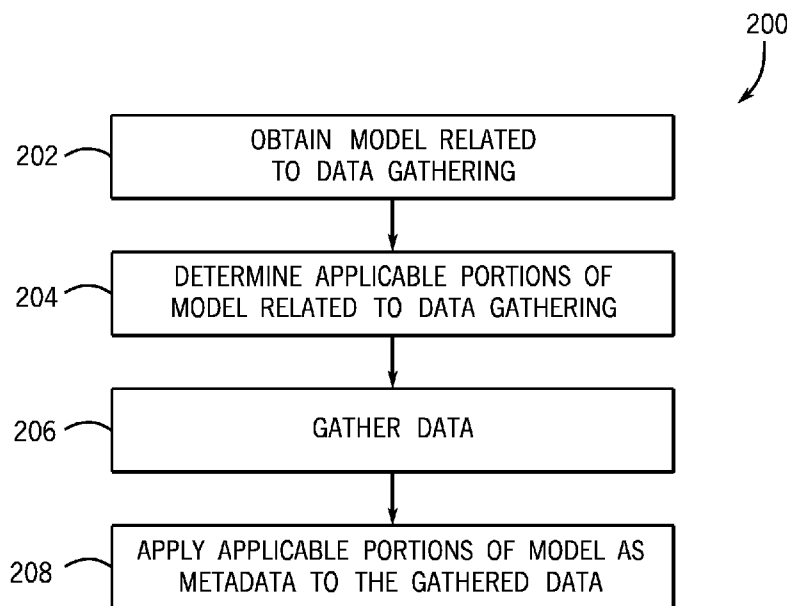

(57) Abstract: A system is provided that includes computer-readable storage configured to store non-destructive testing inspection data relating to a portion of an object that has been inspected. Further, a processor presents a model associated with the object, associates the inspection data with the related portion of the object; and presents an indication of availability of the inspection data on a portion of the presented model. The portion of the presented model relates to the portion of the object associated with the inspection data.
