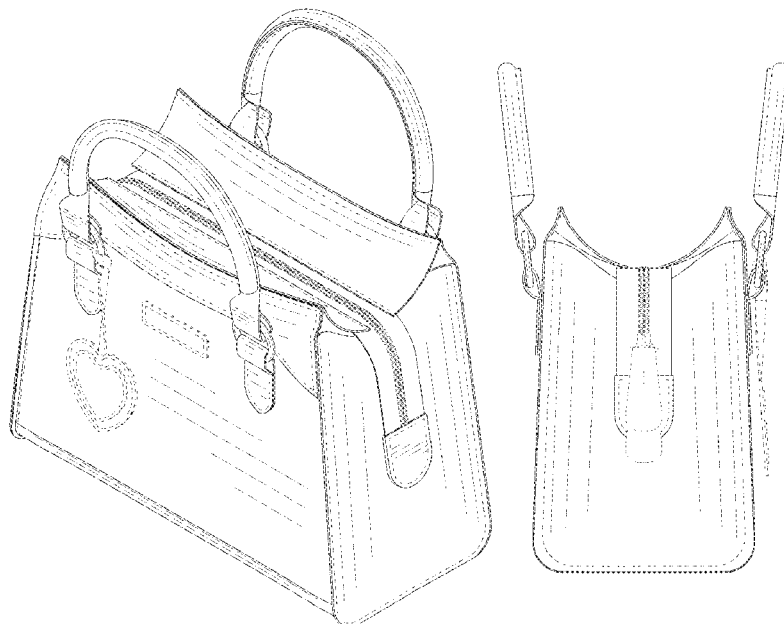
(57) **CLAIM**

The ornamental design for a toy handbag, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a toy handbag, showing our new design;
FIG. 2 is a rear and bottom perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof;

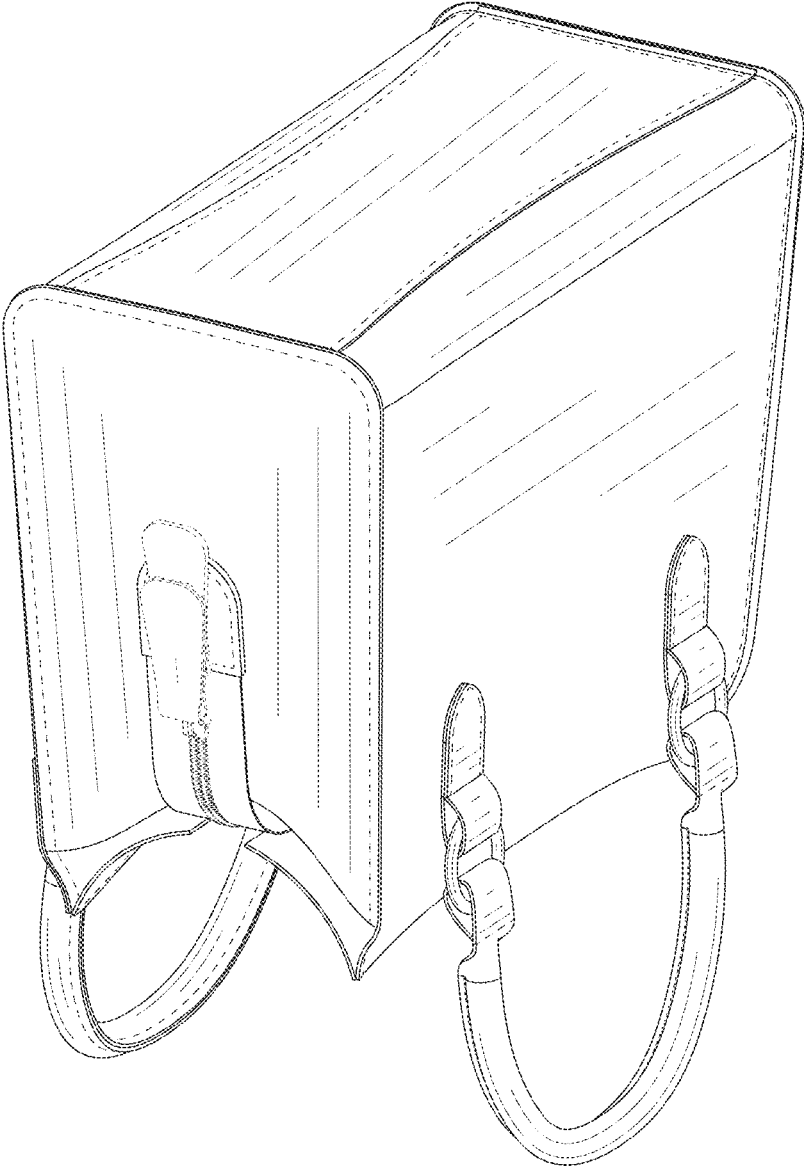

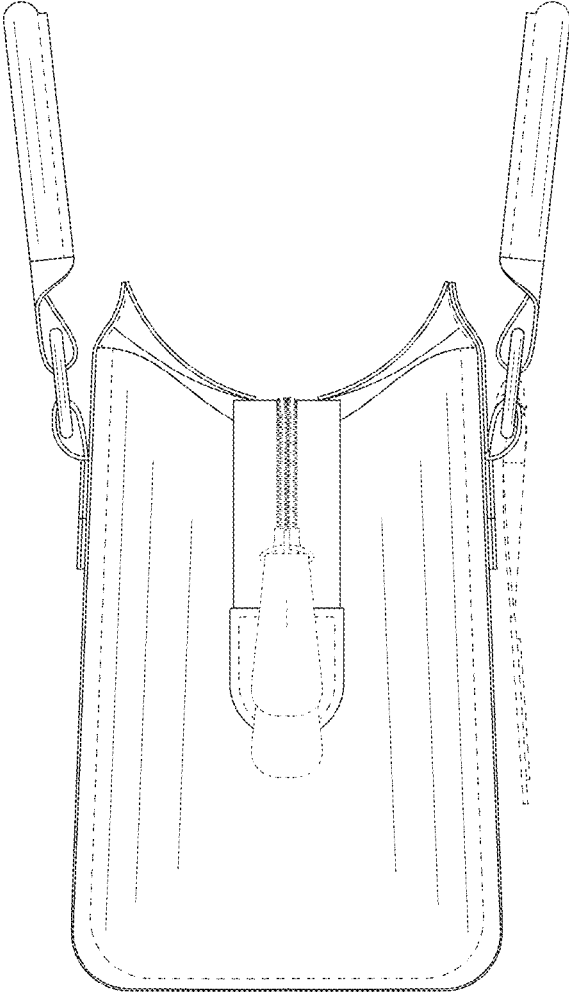

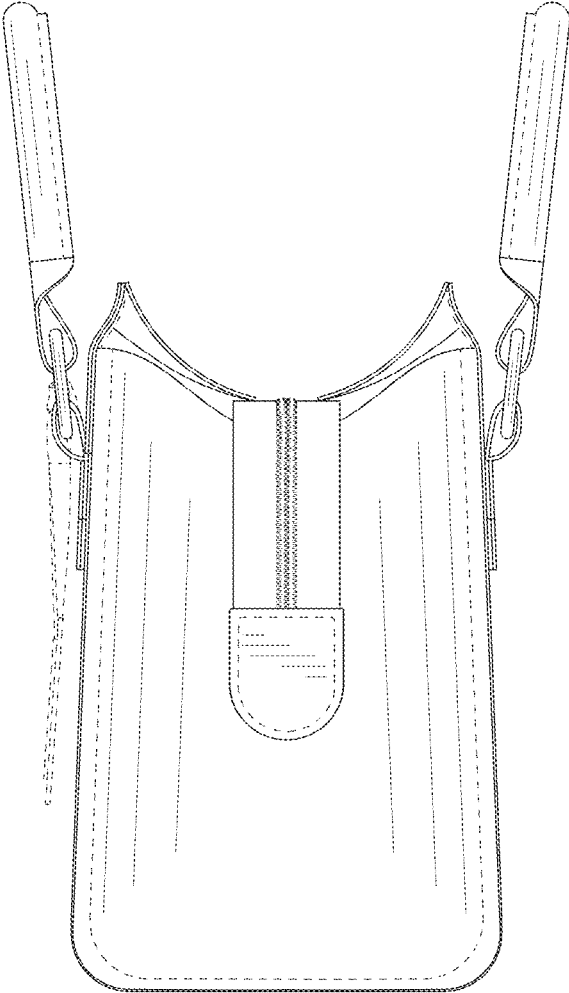

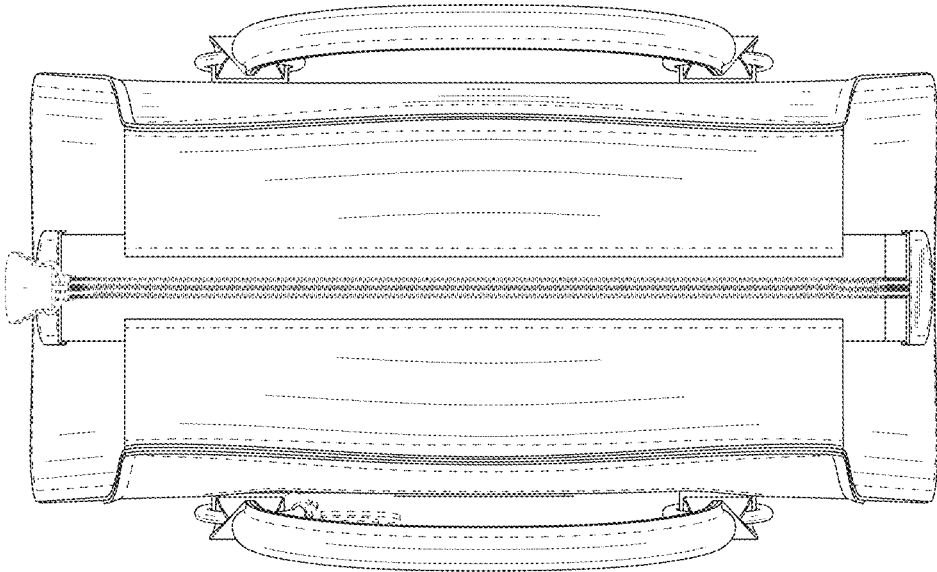

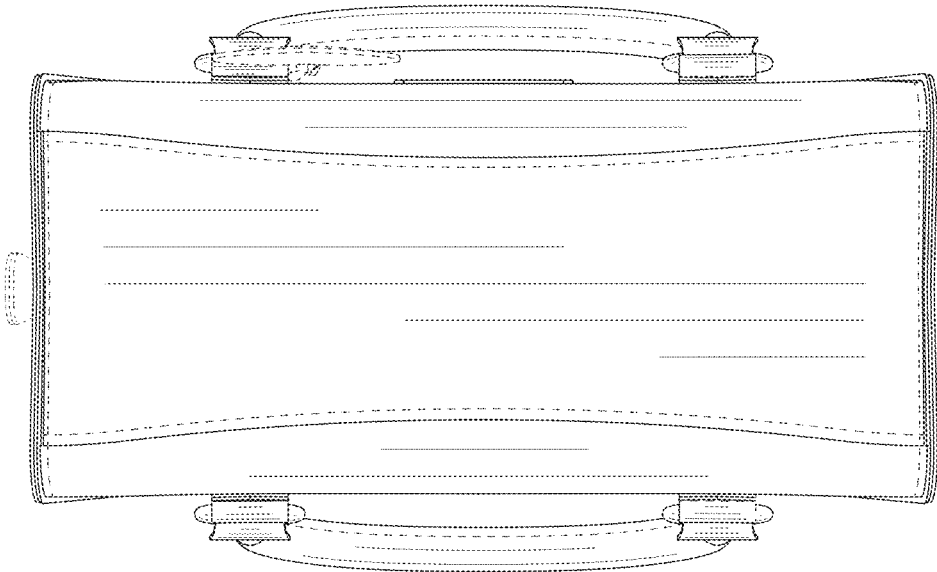
