DESCRIPTION

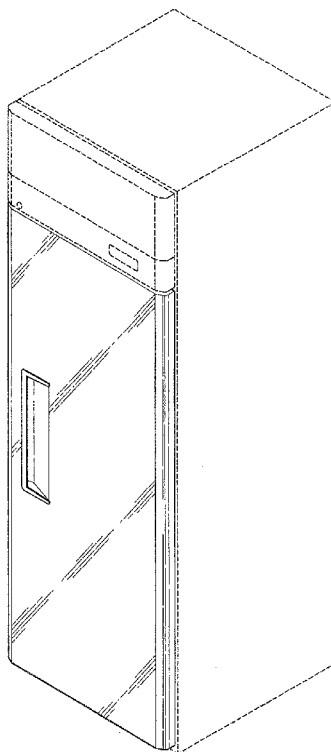

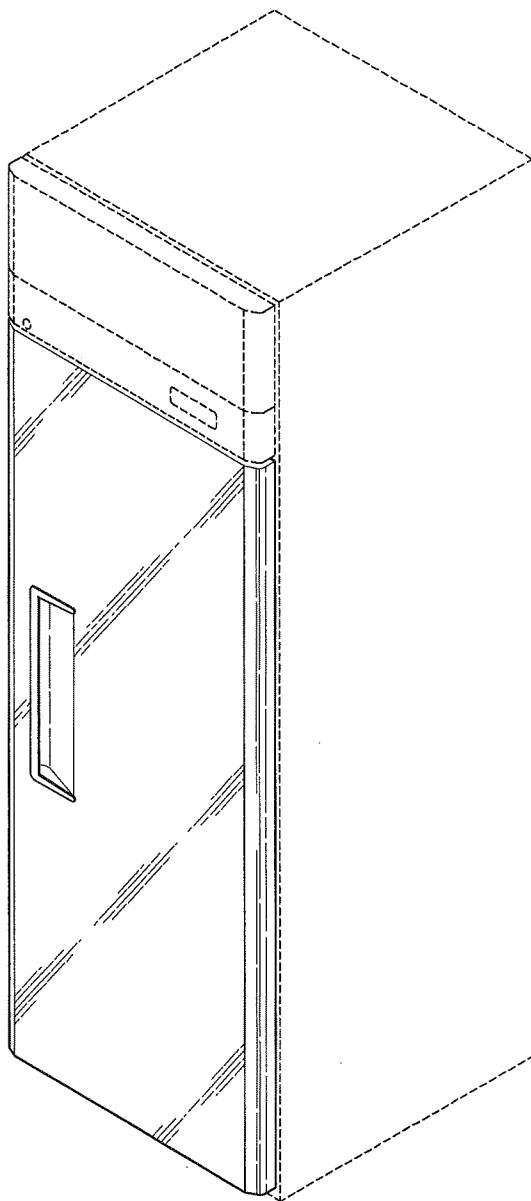

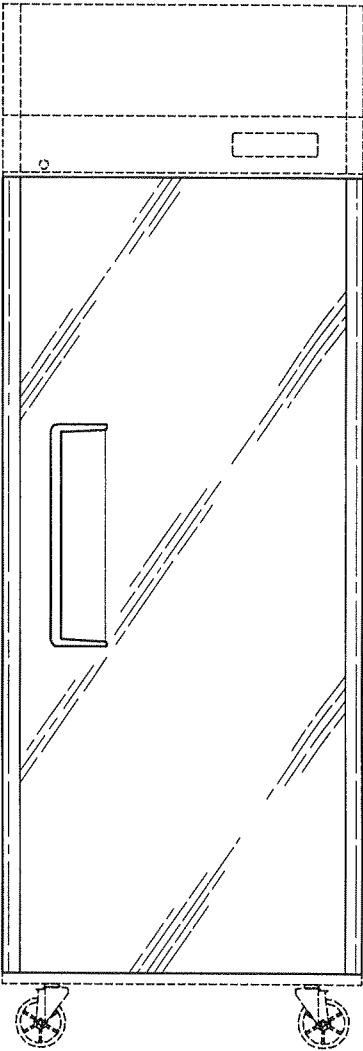

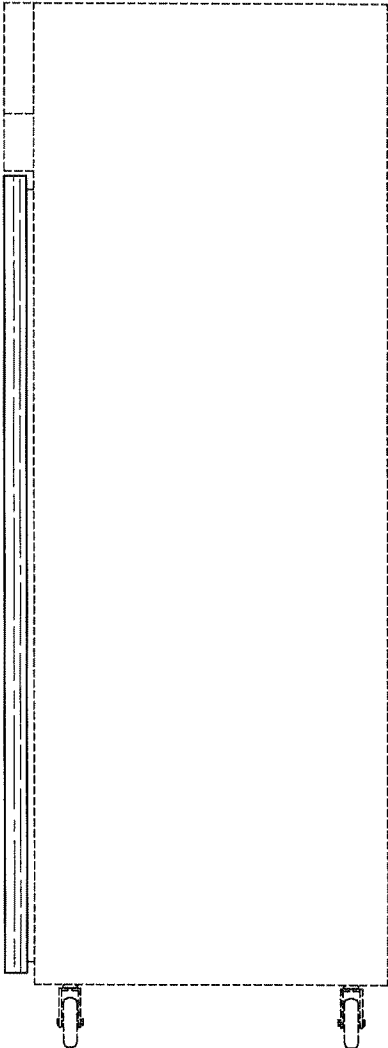

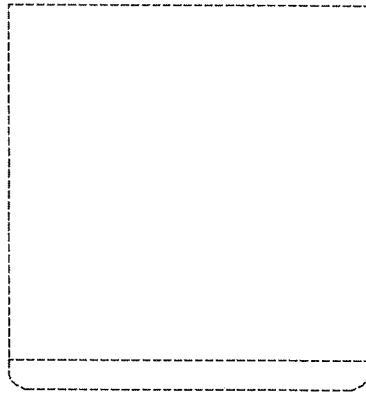
