
(57) **CLAIM**

The ornamental design for a car video recorder, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a car video recorder showing my new design;
FIG. 2 is a bottom, rear and left side perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
















