FIG. 3 is a plan view of the top of the insole shown in FIG. 1. FIG. 4 is an elevation view of the front of the insole shown in FIG. 1.

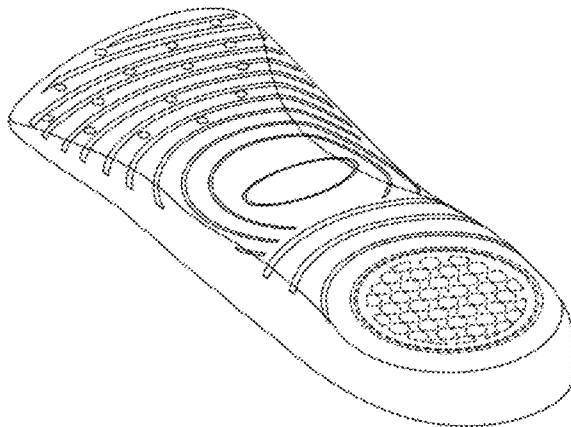
FIG. 5 is an elevation view of the rear of the insole shown in FIG. 1.

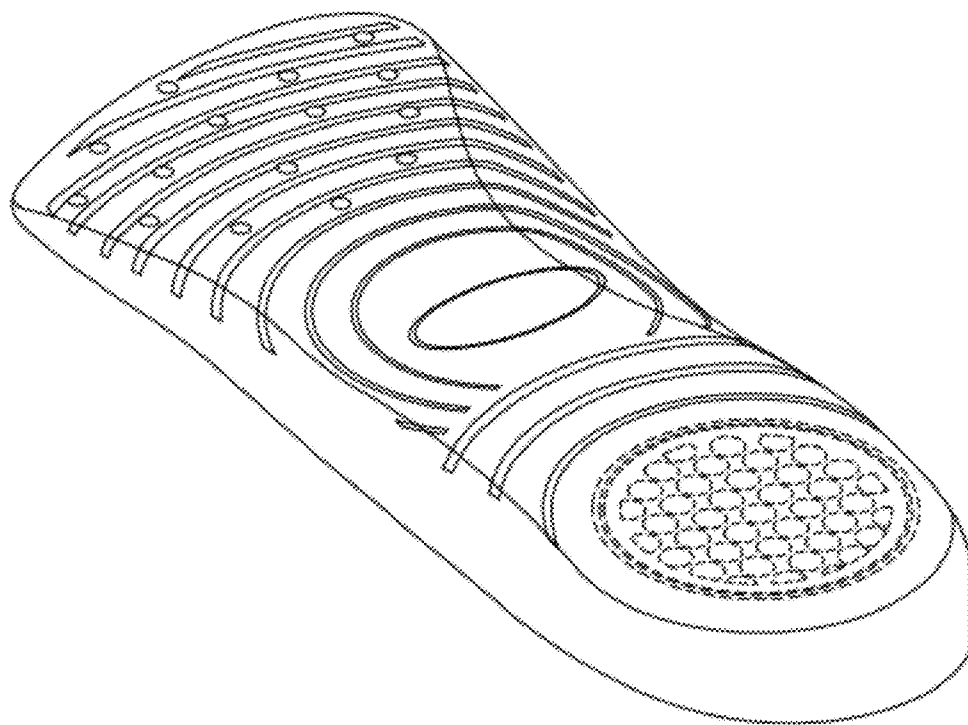

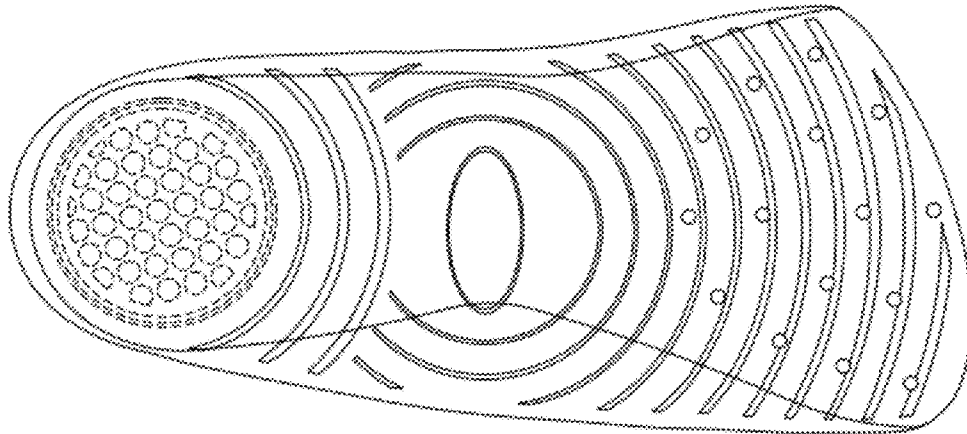

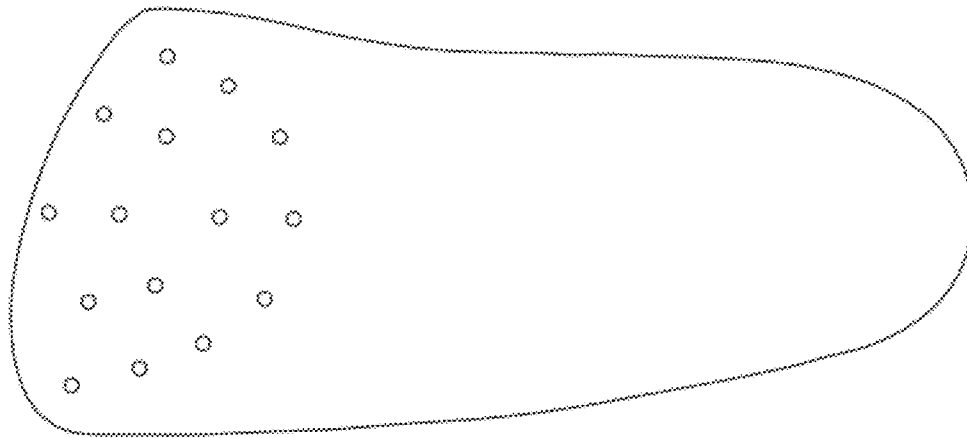

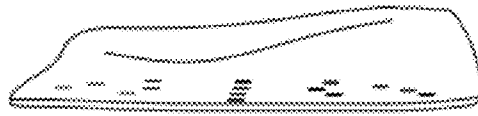

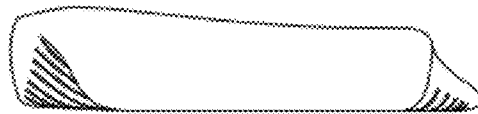

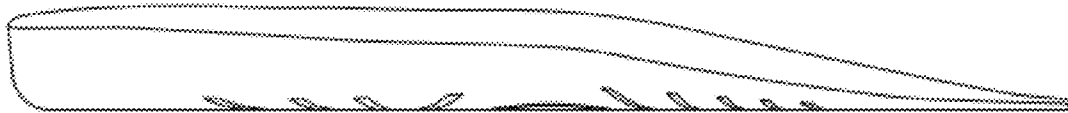
