[57] **CLAIM**

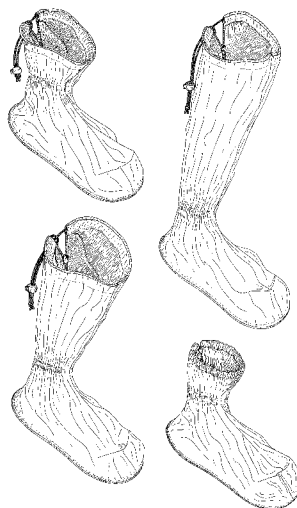
The ornamental design for an overshoe footwear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the first embodiment of an overshoe footwear;

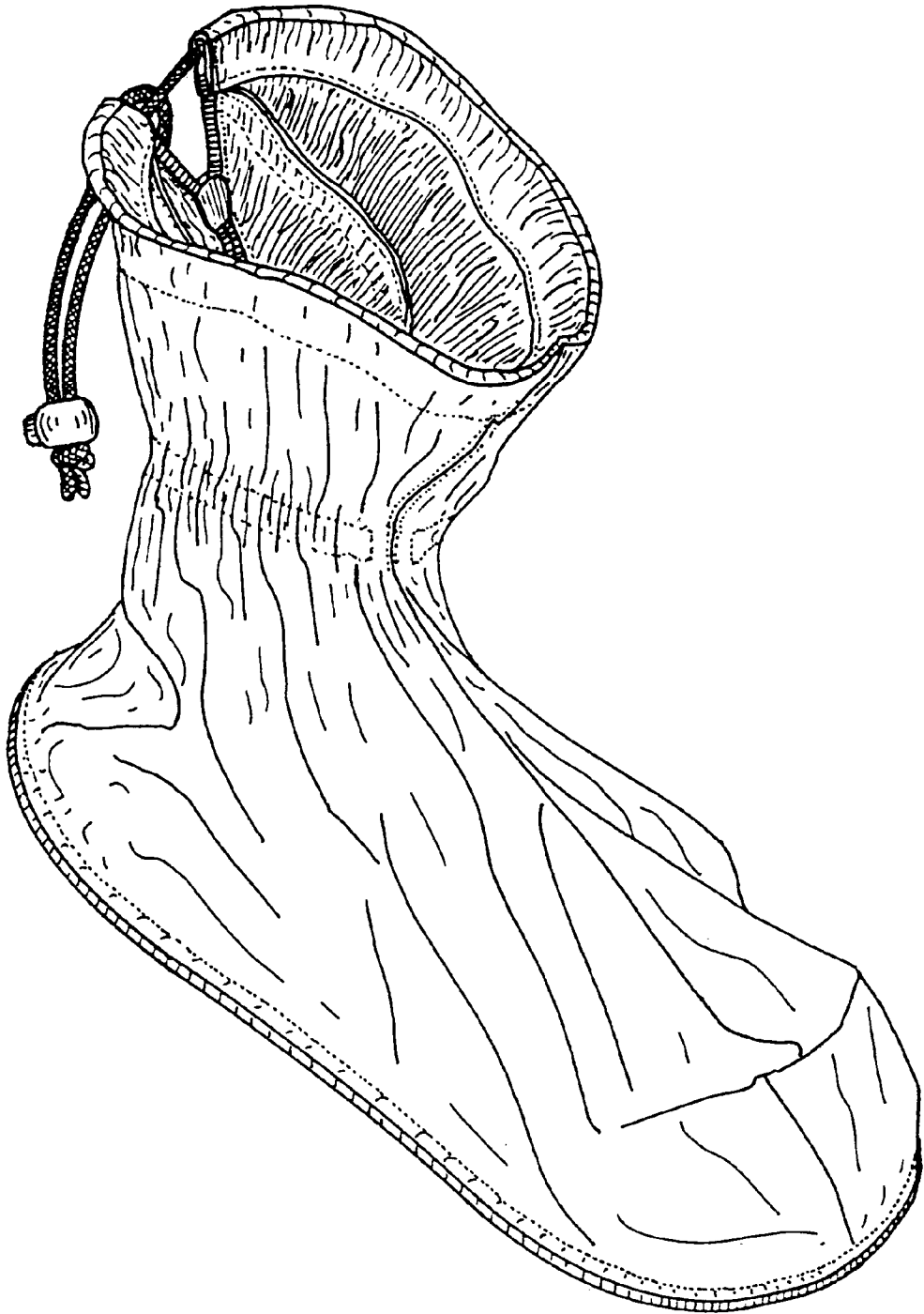

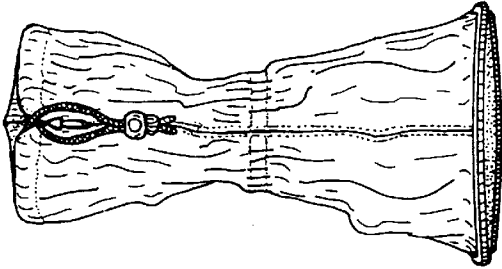

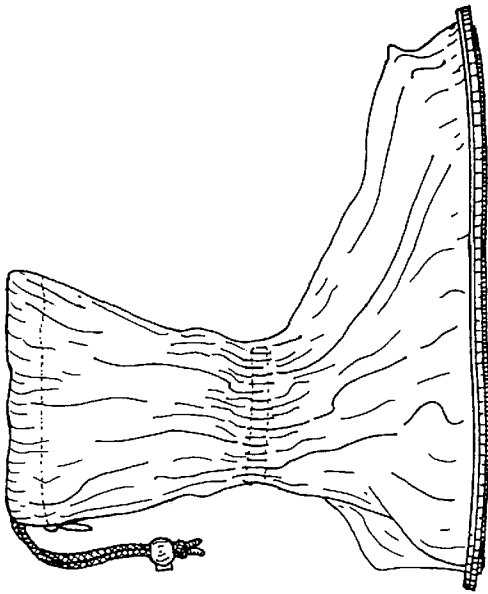

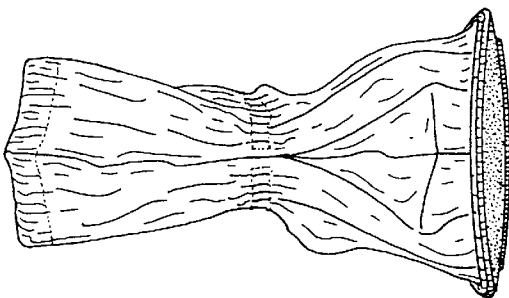

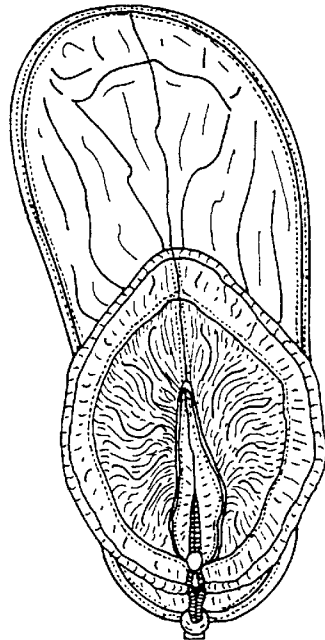

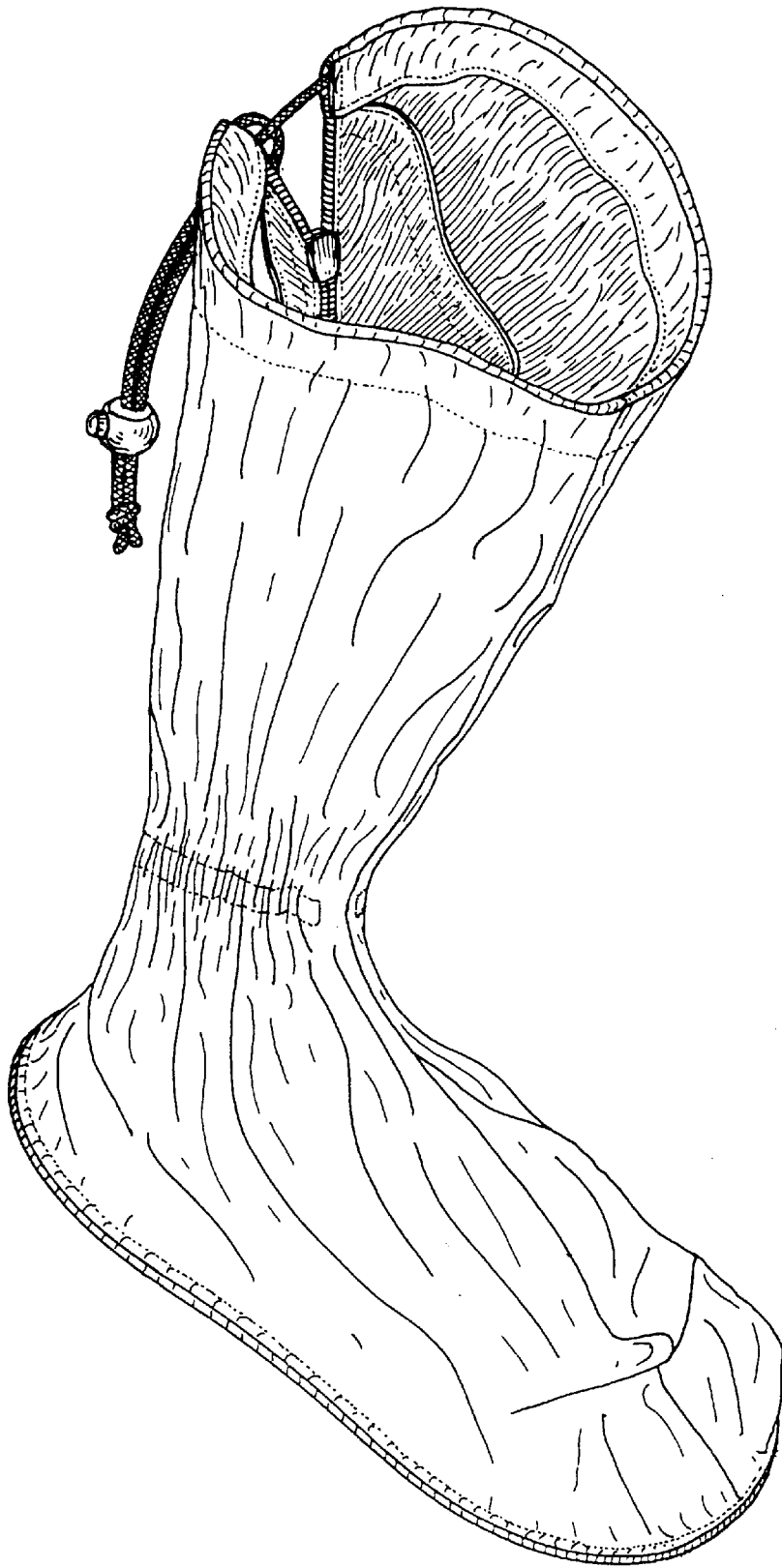

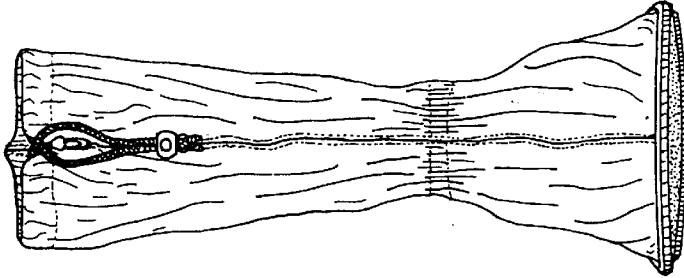

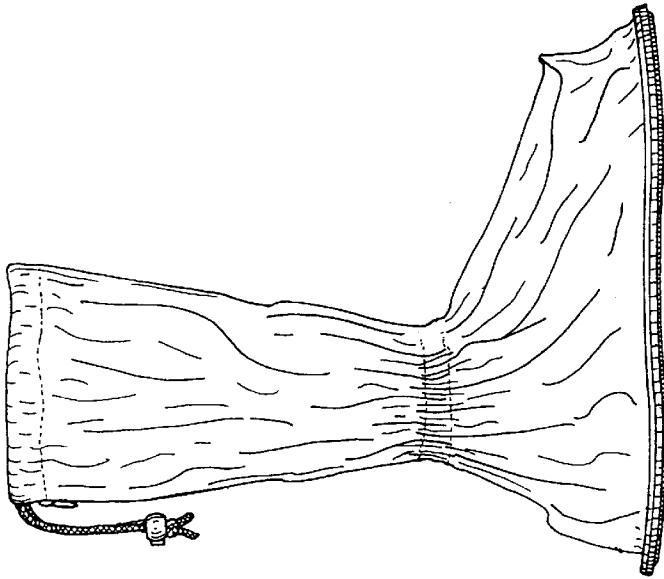

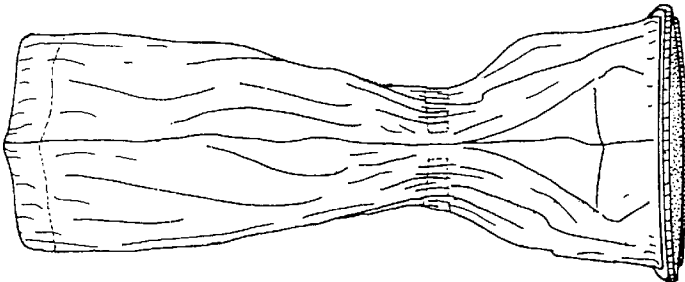

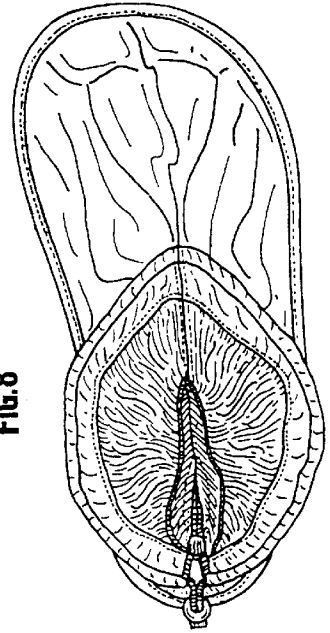

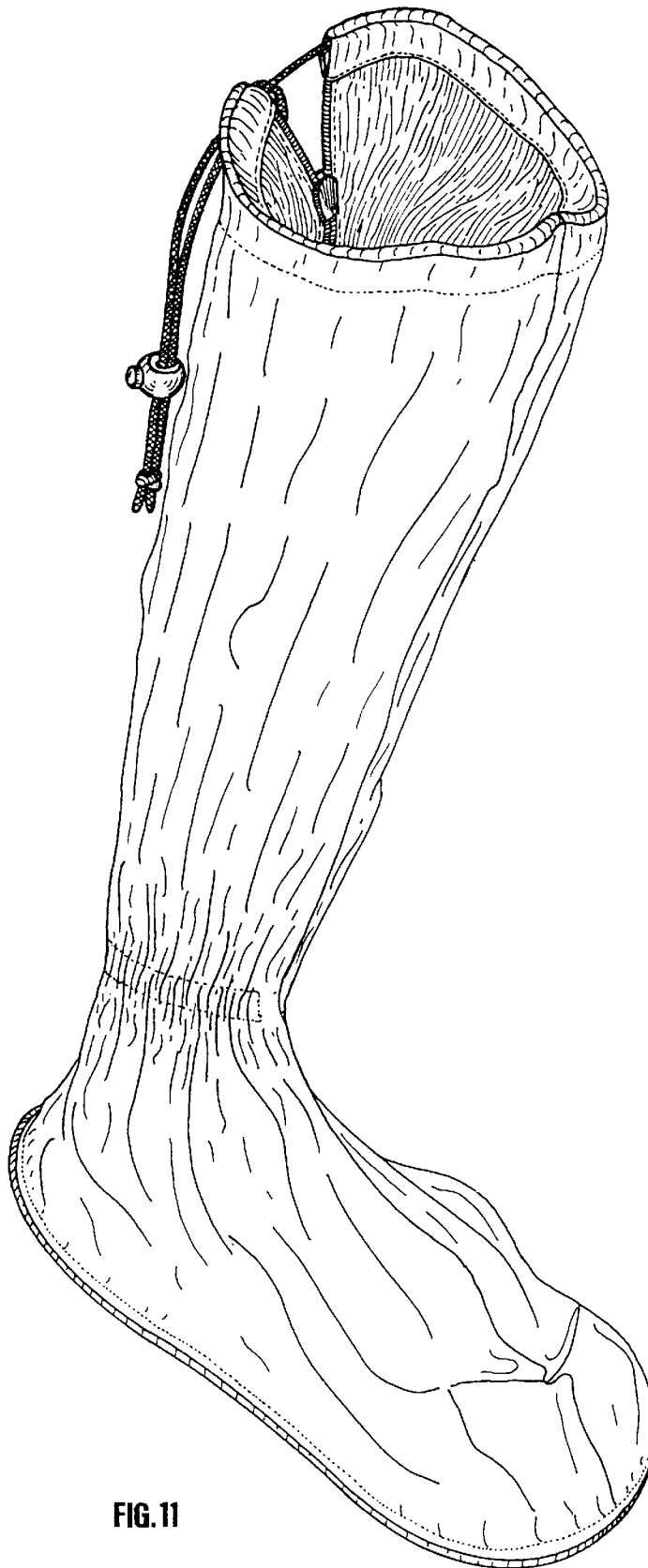

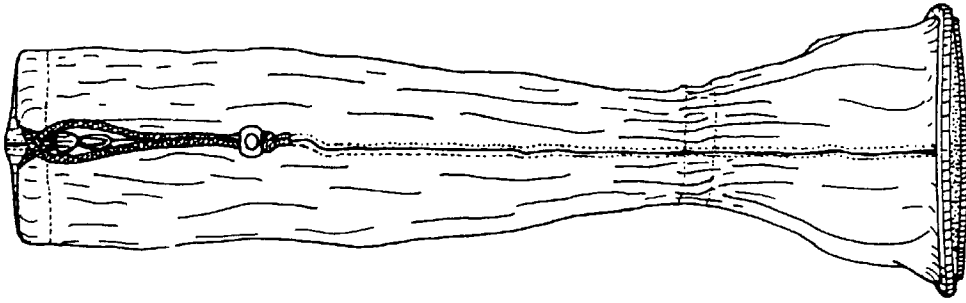

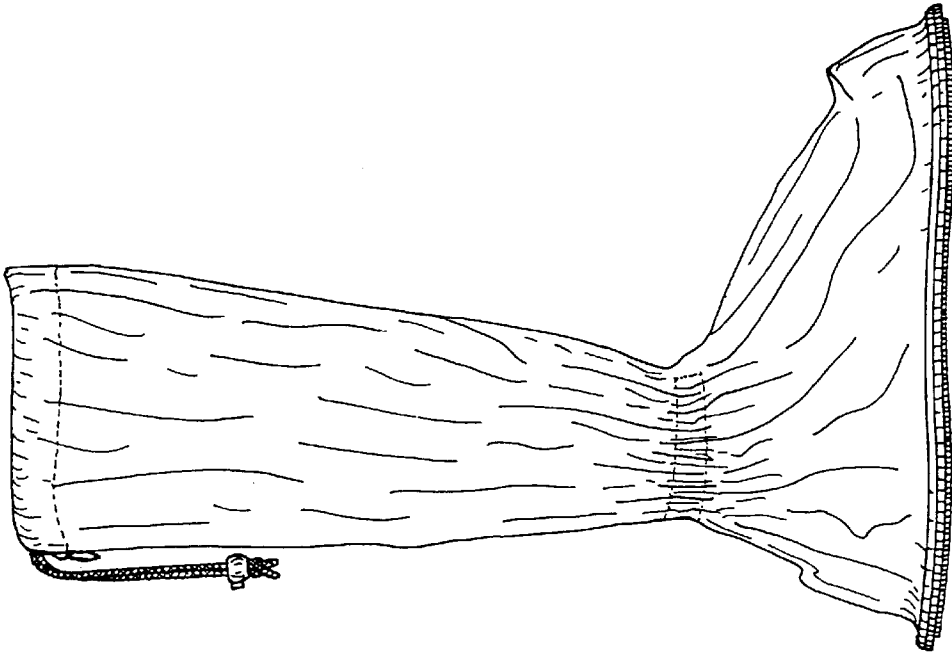

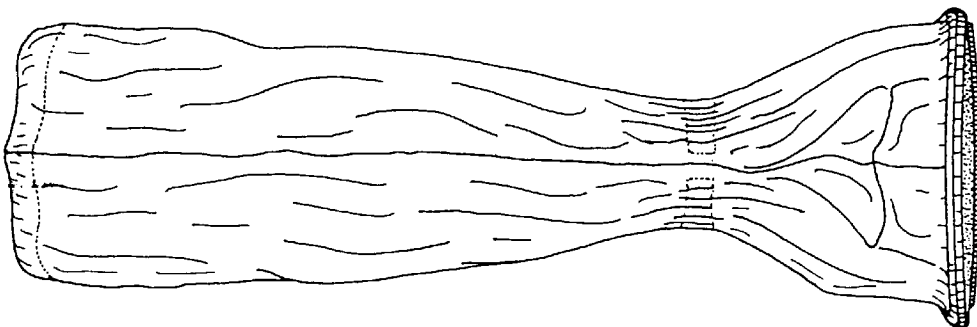

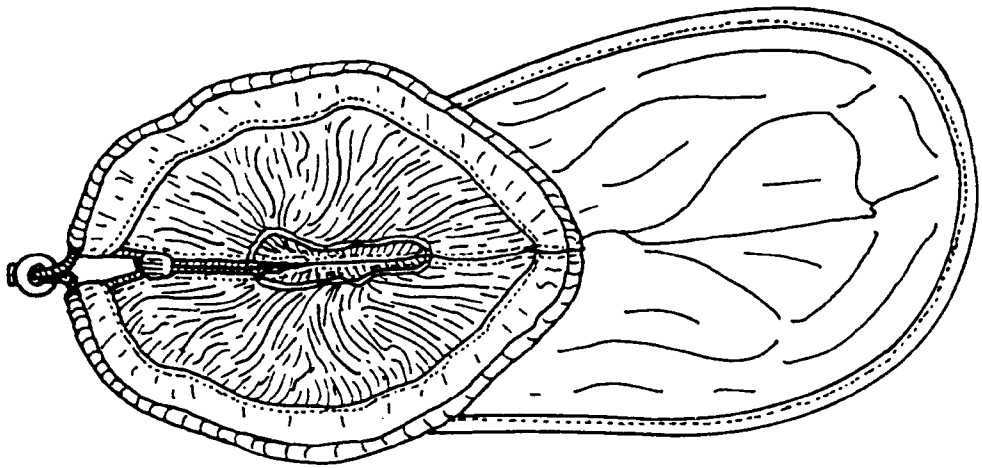

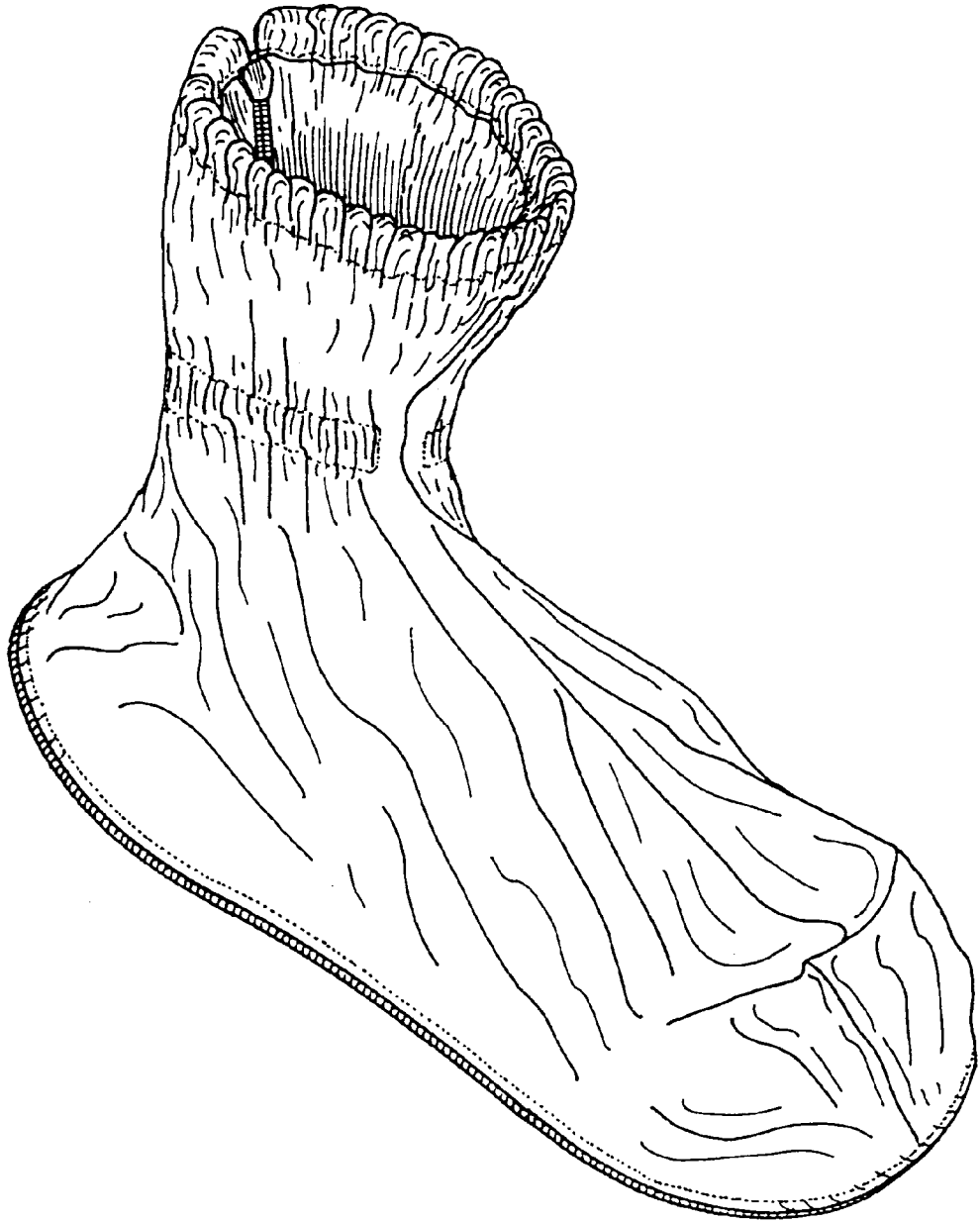

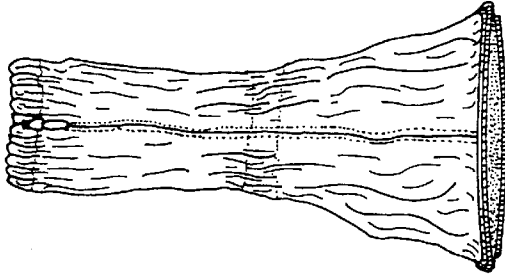

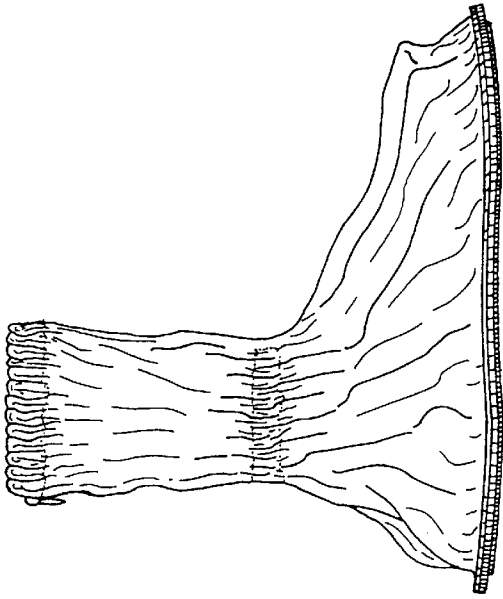

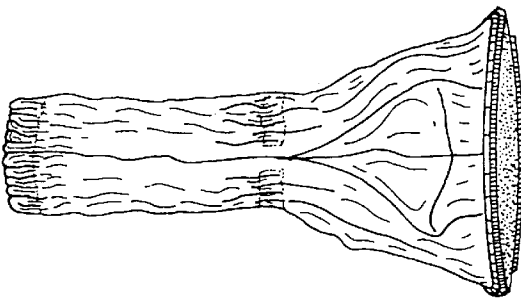

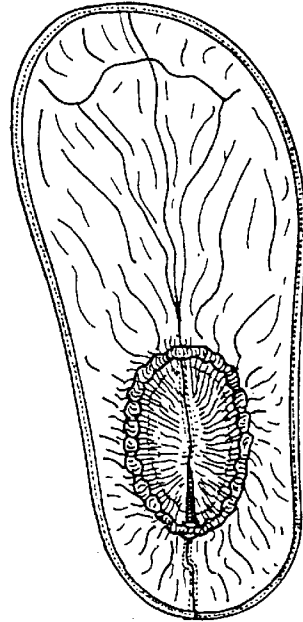

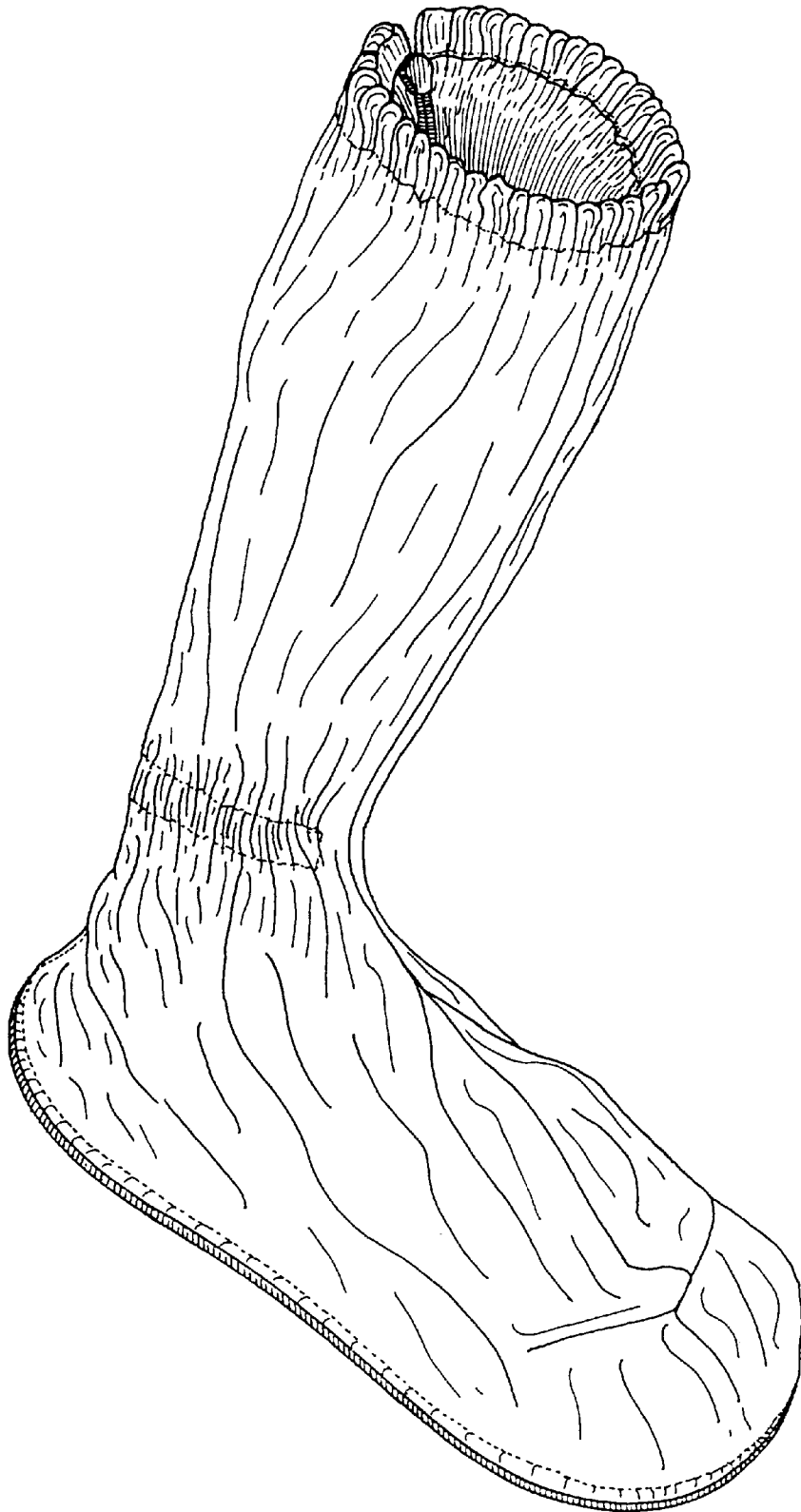

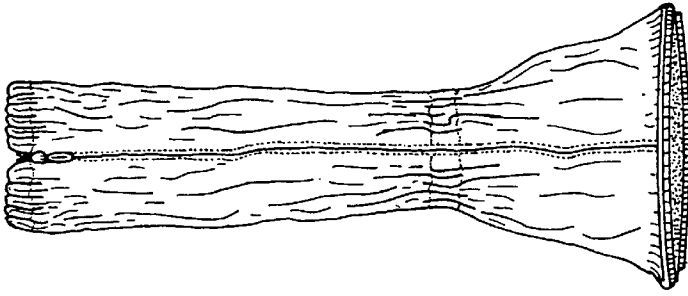

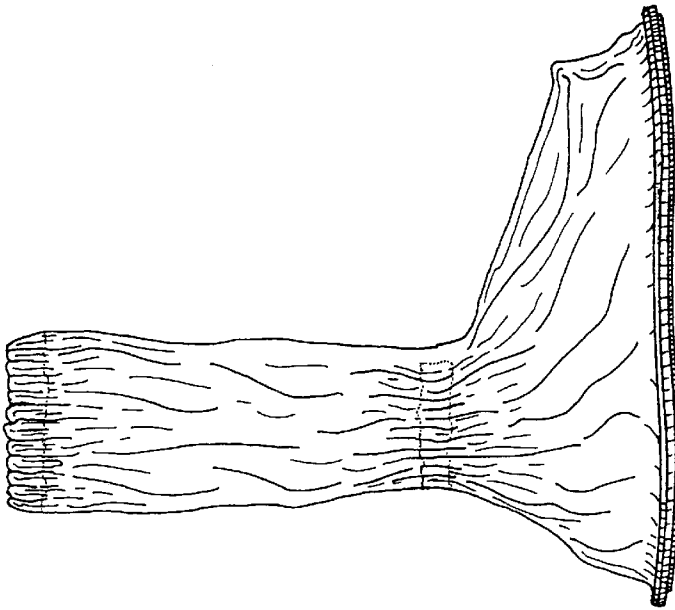

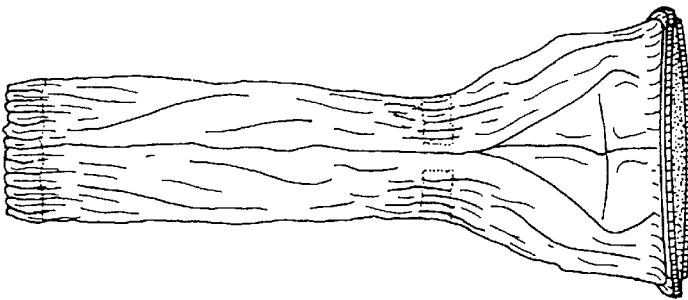
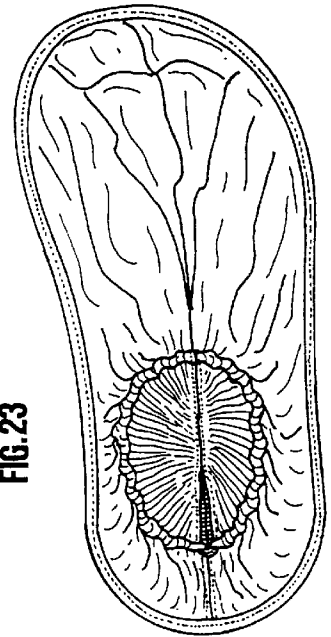

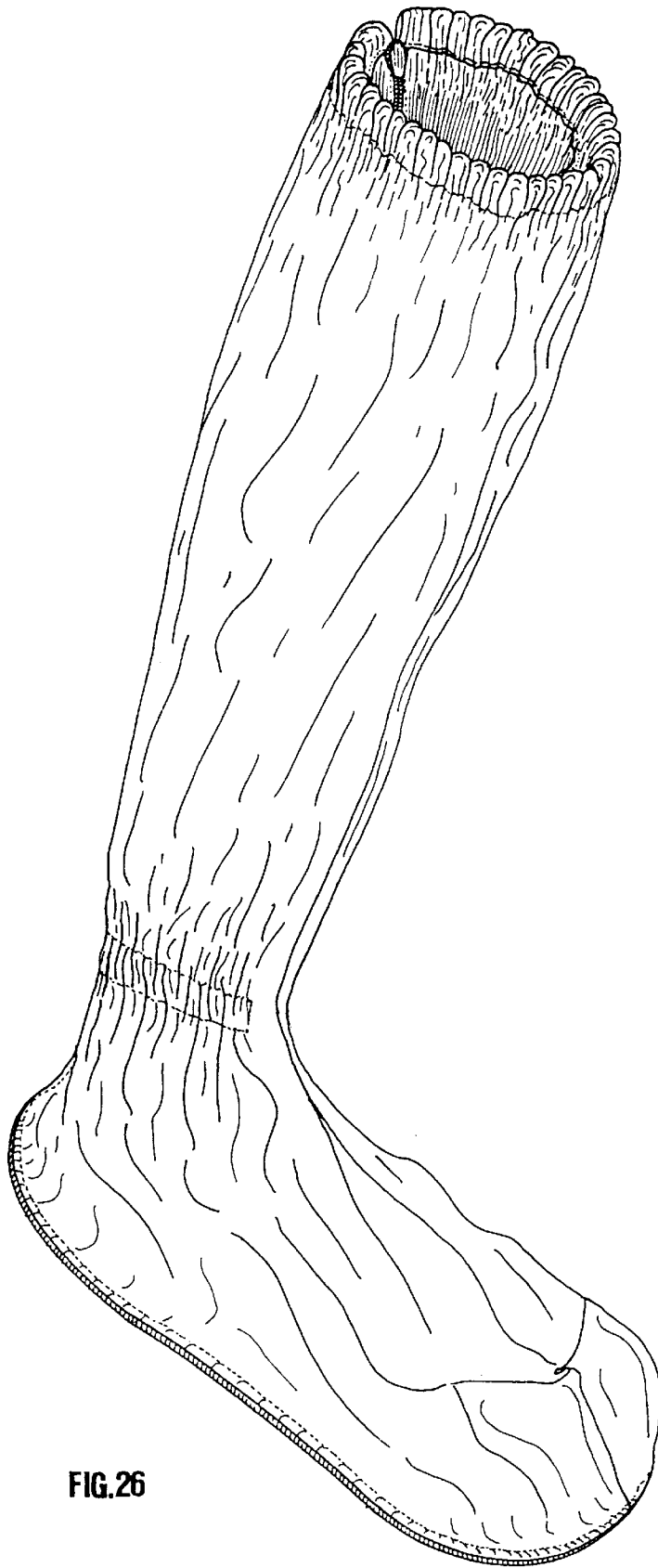

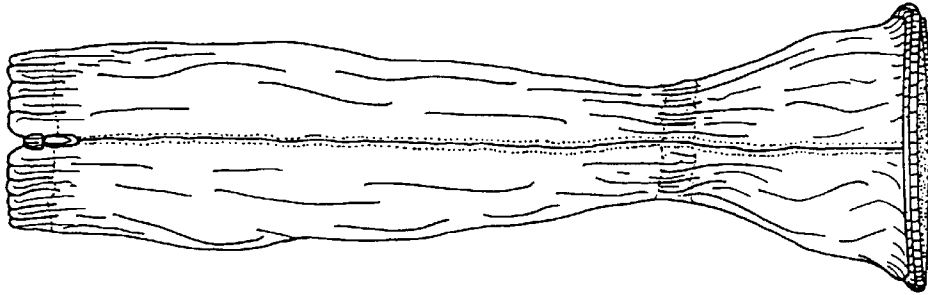

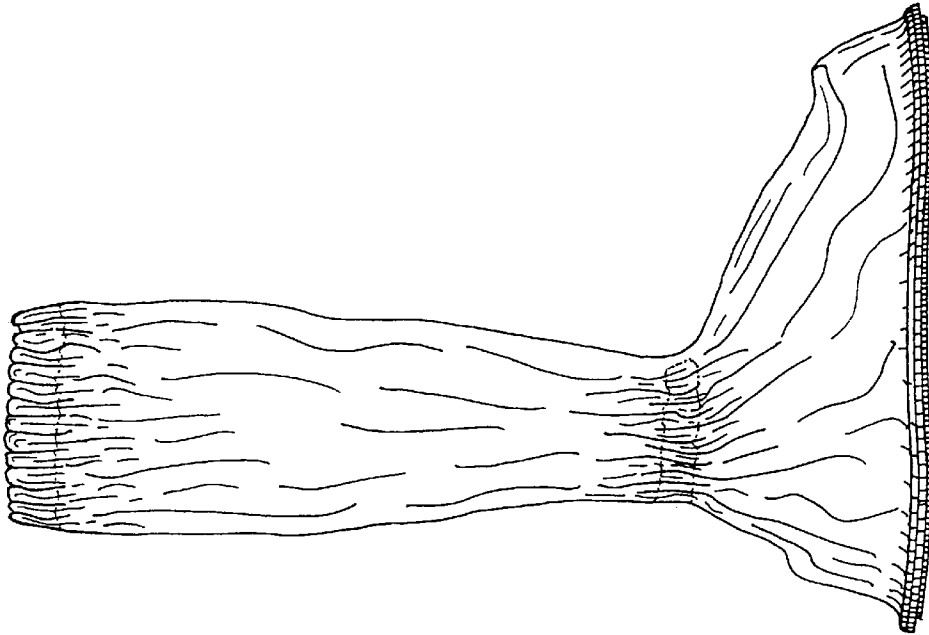

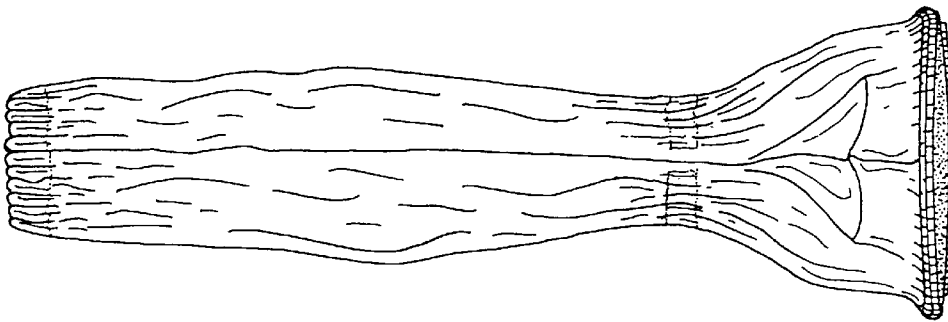

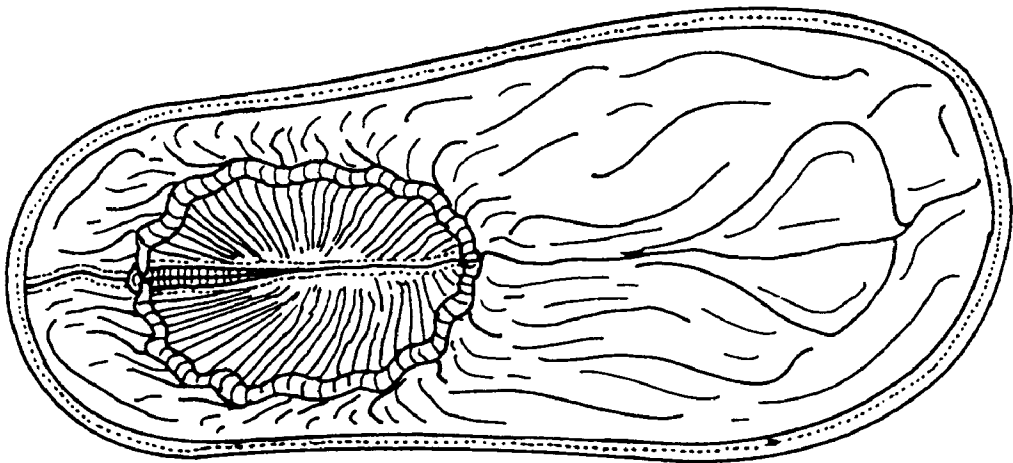
