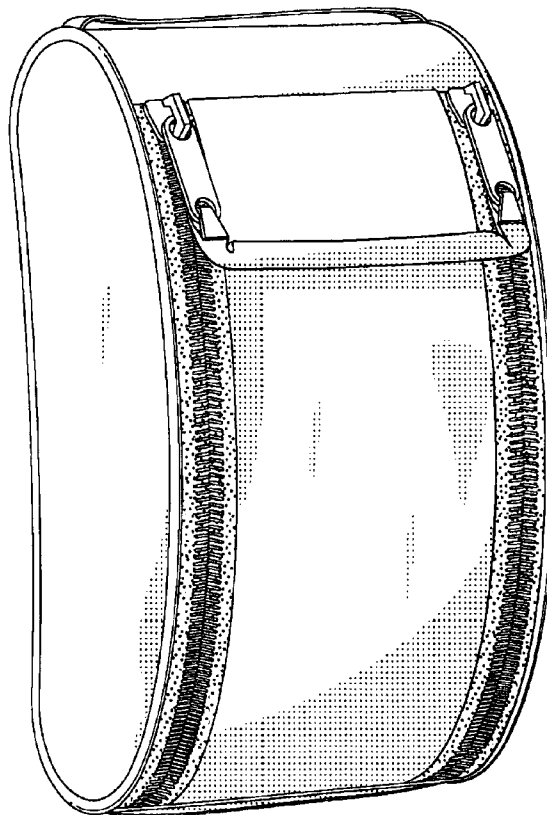

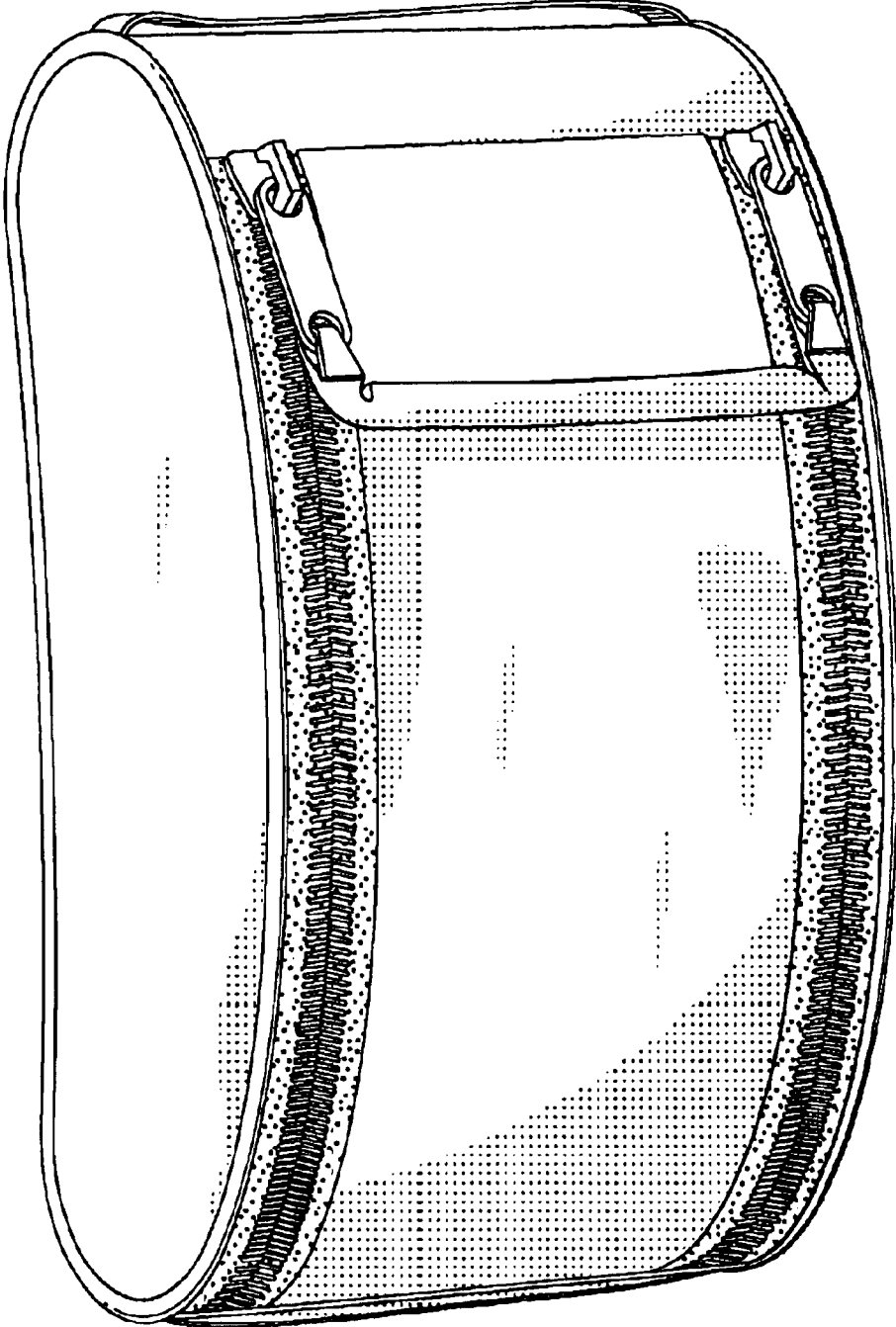
The ornamental design for a pencil case, as shown and described.

**DESCRIPTION**

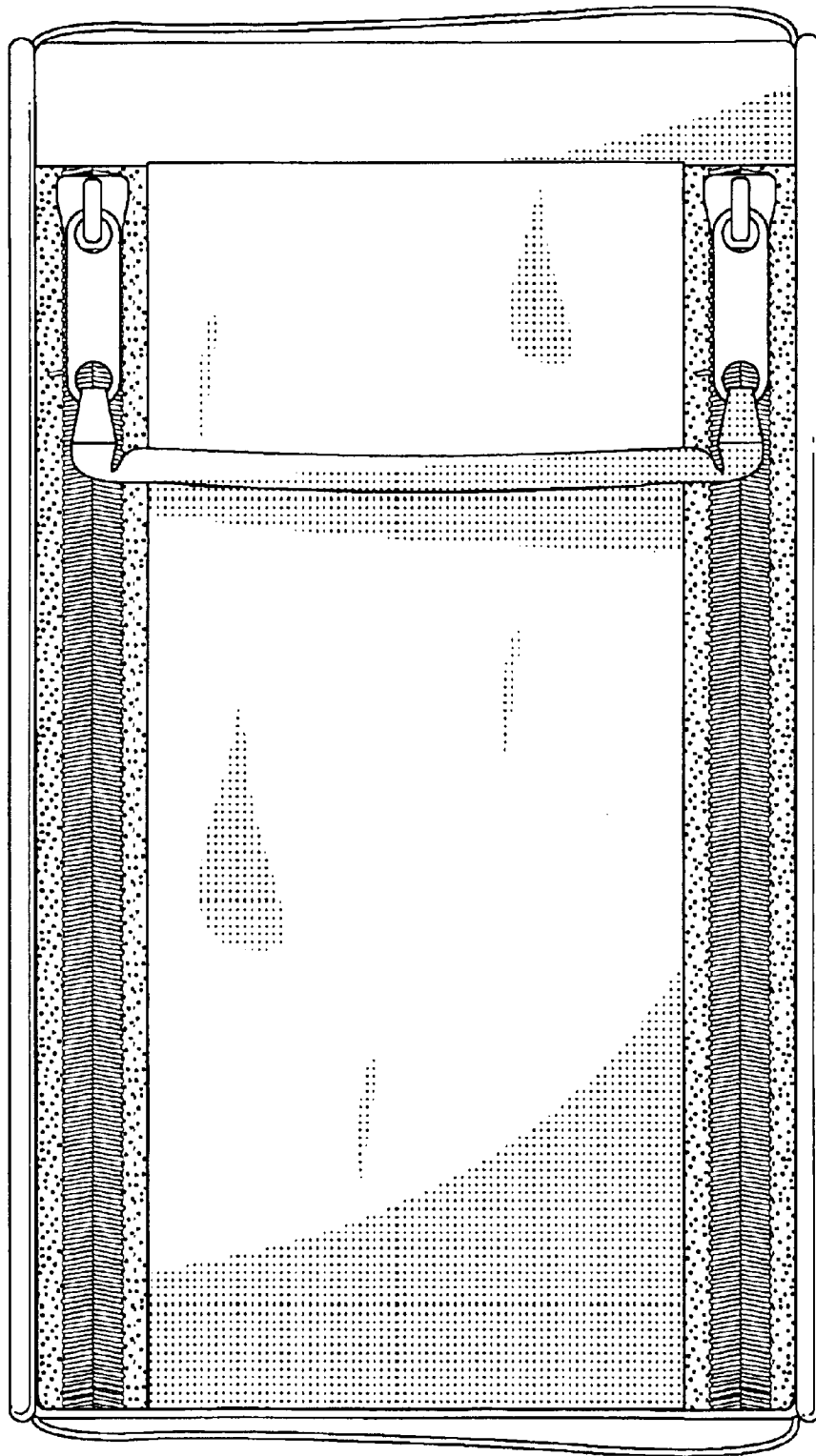
FIG. 1 is a perspective view of a pencil case showing my new design;

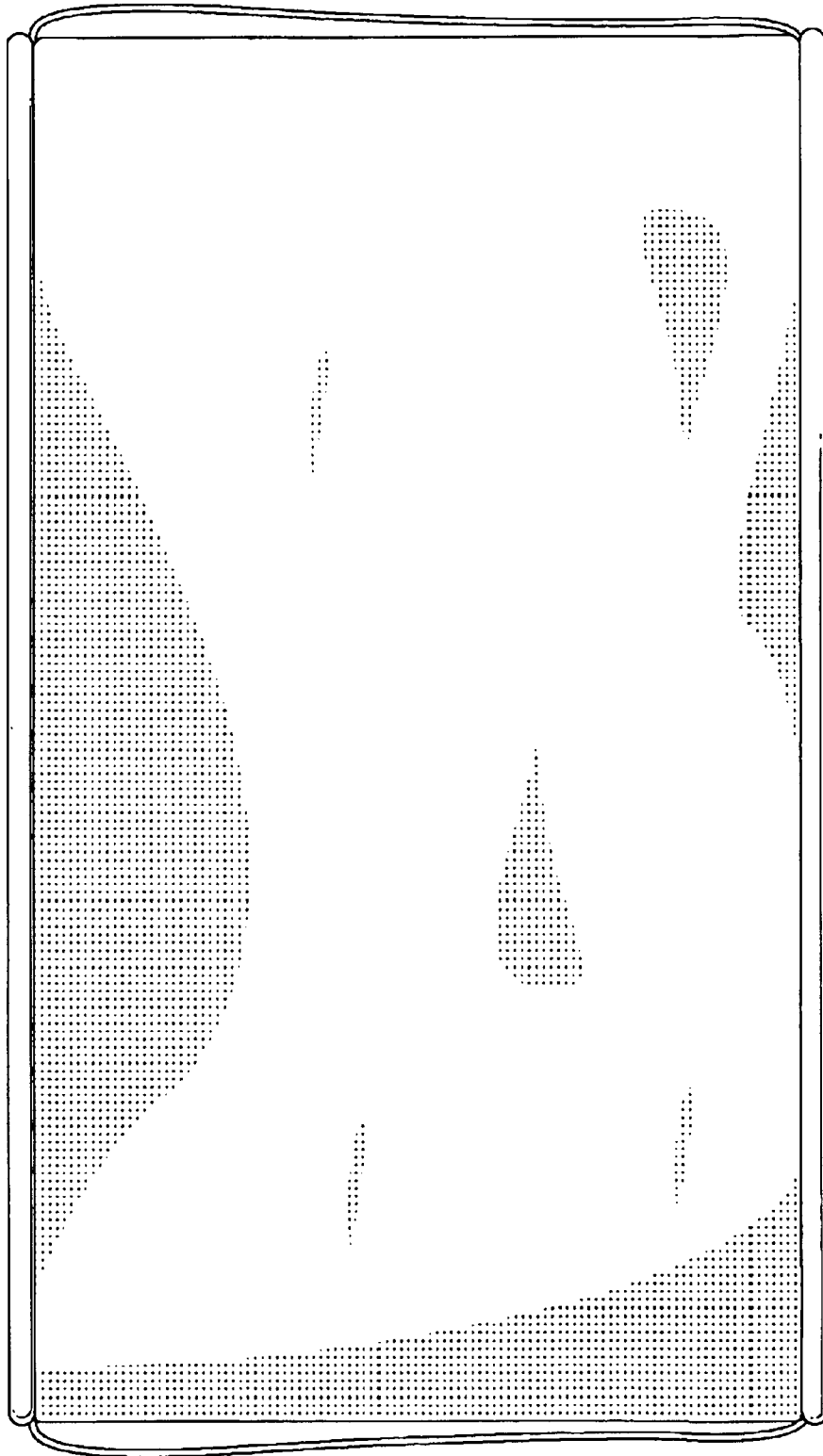

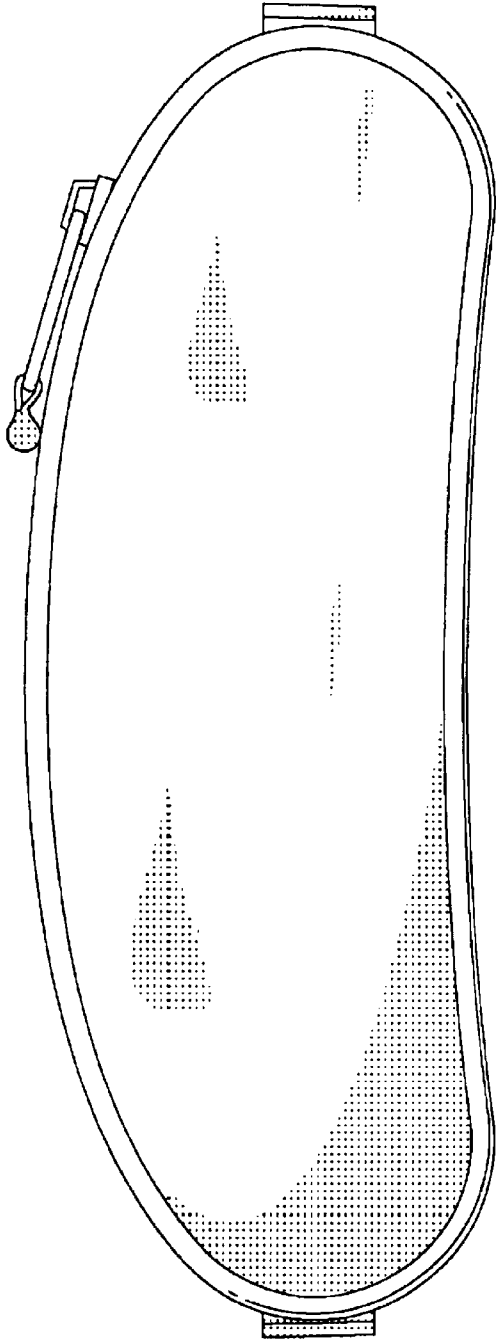

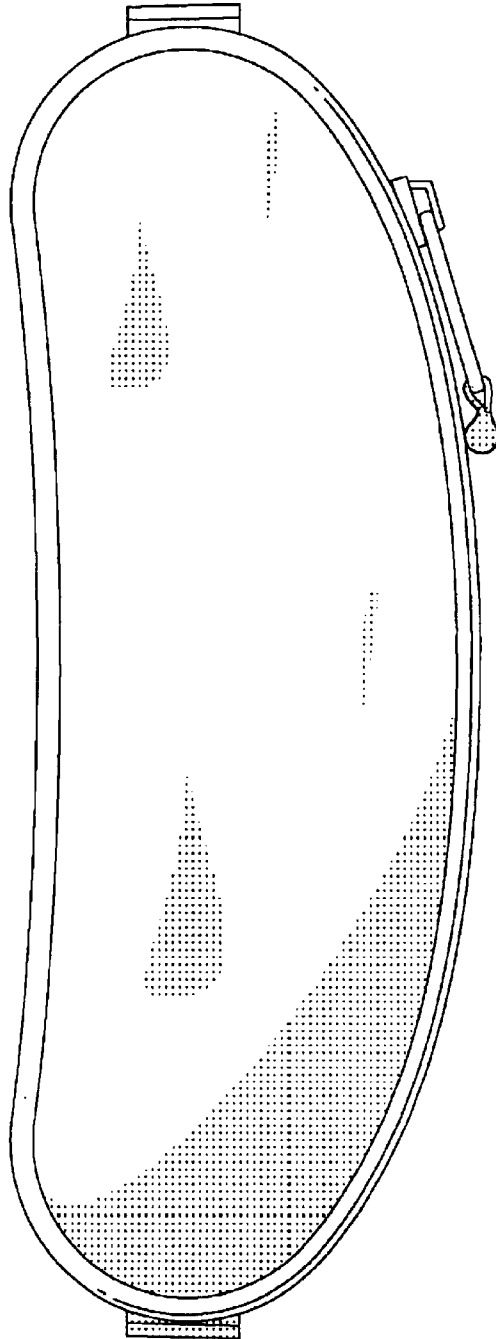
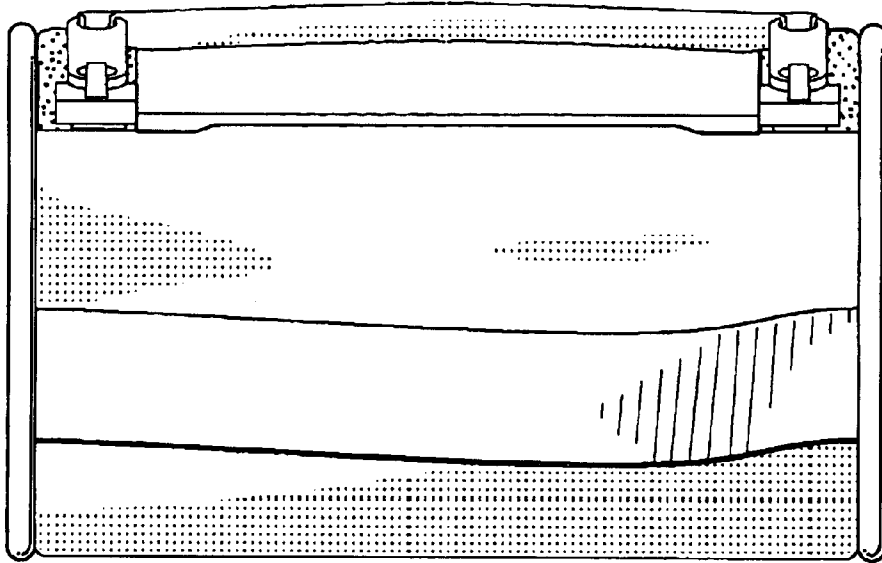
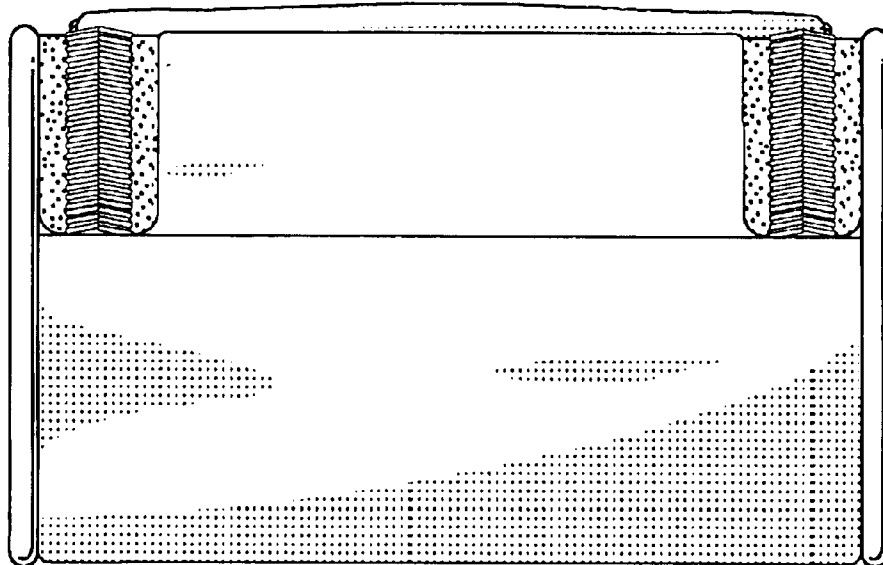
