(57) **CLAIM**


We claim the ornamental design for a model vehicle body, as shown and described.

DESCRIPTION

FIG. 1 is an upper, left, front perspective view of a model vehicle body showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is an upper plan view thereof; FIG. 7 is a lower plan view thereof; and, FIG. 8 is an upper, right, rear perspective view of the model vehicle body.

In the drawings, the broken lines illustrate portions of the model vehicle body that form no part of the claimed design.
















