The ornamental design for a rear door panel for automobiles, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a rear door panel for automobiles according to the present invention.

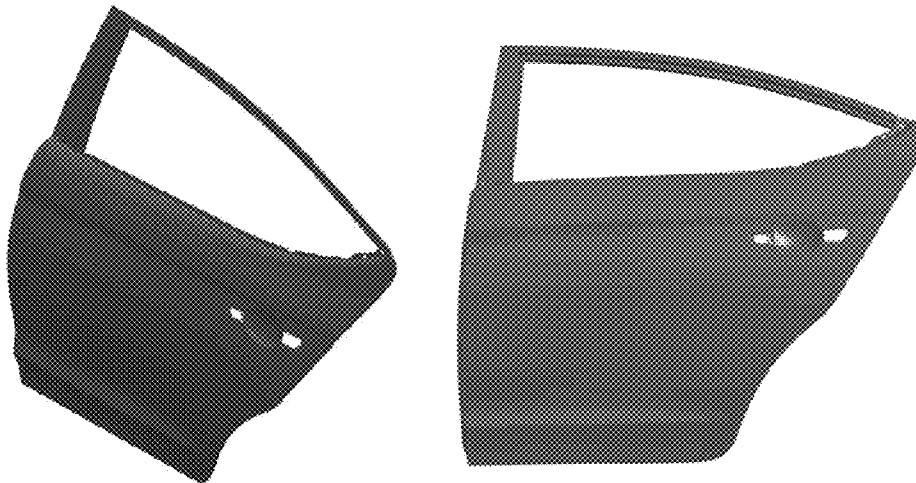

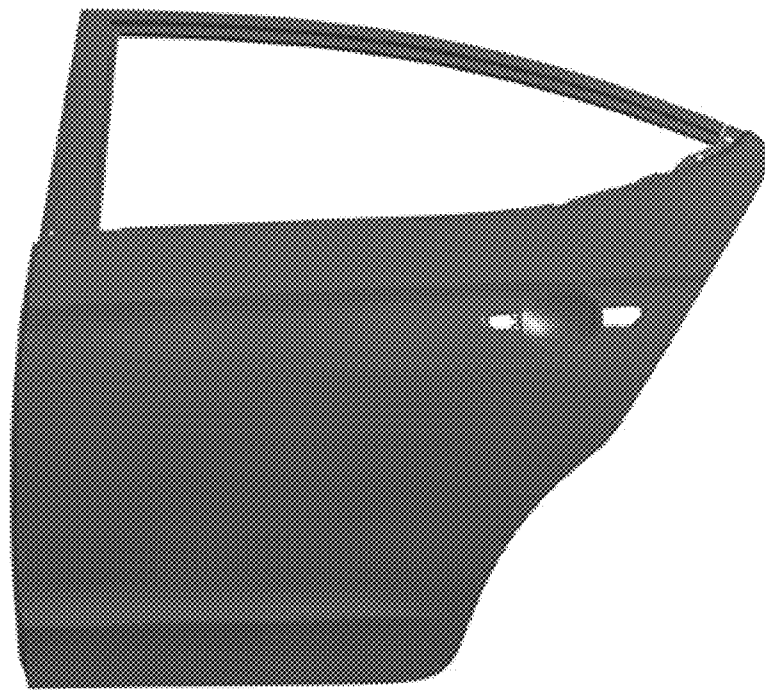

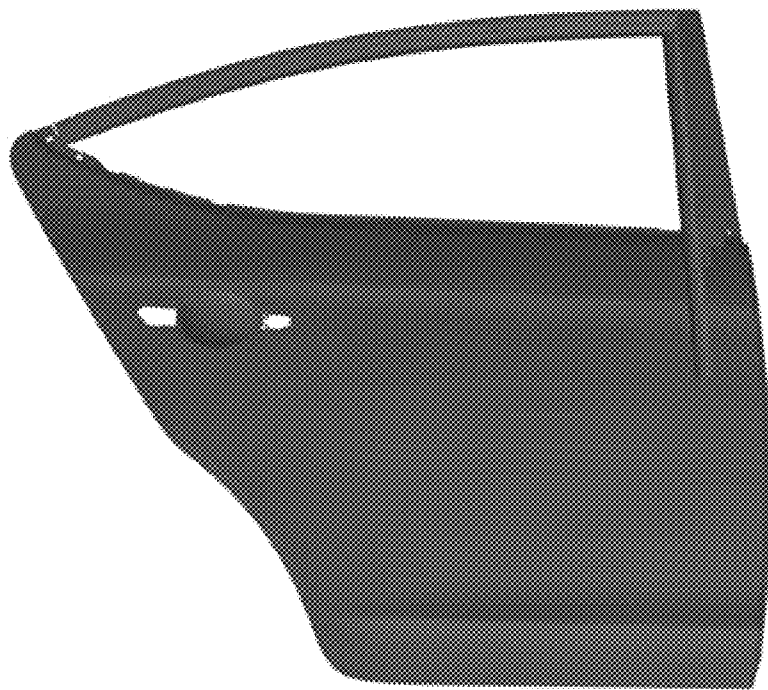
