


(57) **CLAIM**
We claim the ornamental design for a toy vehicle track ramp, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the toy vehicle track ramp; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a bottom perspective view thereof. The broken or dashed lines shown are included for the purpose of illustrating the unclaimed portions of the article and form no part of the claimed design.
















