
(57) **CLAIM**

The ornamental design for a rolling coffee pod drawer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a rolling coffee pod drawer; FIG. 2 is a top view of the rolling coffee pod drawer; FIG. 3 is a side view of the rolling coffee pod drawer; FIG. 4 is a second side view of the rolling coffee pod drawer; FIG. 5 is a third side view of the rolling coffee pod drawer; FIG. 6 is a fourth side view of the rolling coffee pod drawer; FIG. 7 is a bottom view of the rolling coffee pod drawer; FIG. 8 is a perspective view of the rolling coffee pod drawer, with an insert placed in the drawer in open condition; and, FIG. 9 is a perspective view of the rolling coffee pod drawer, with the insert placed in the drawer in half-closed condition.


















