[57] **CLAIM**

We claim the ornamental design for a sole for sports footwear, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevation view of a sole for sports footwear, showing our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front end elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a bottom plan view thereof; and,  
FIG. 6 is a rear end elevation view thereof.








