FIG. 7 is a bottom view of the cleaning accessory basket as shown in FIG. 1;

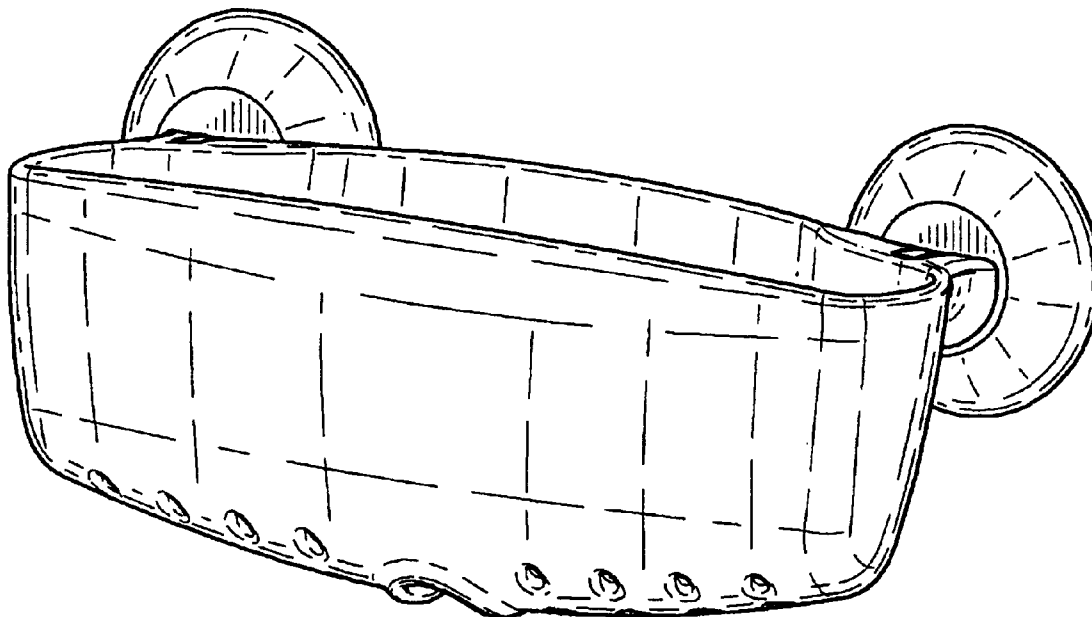

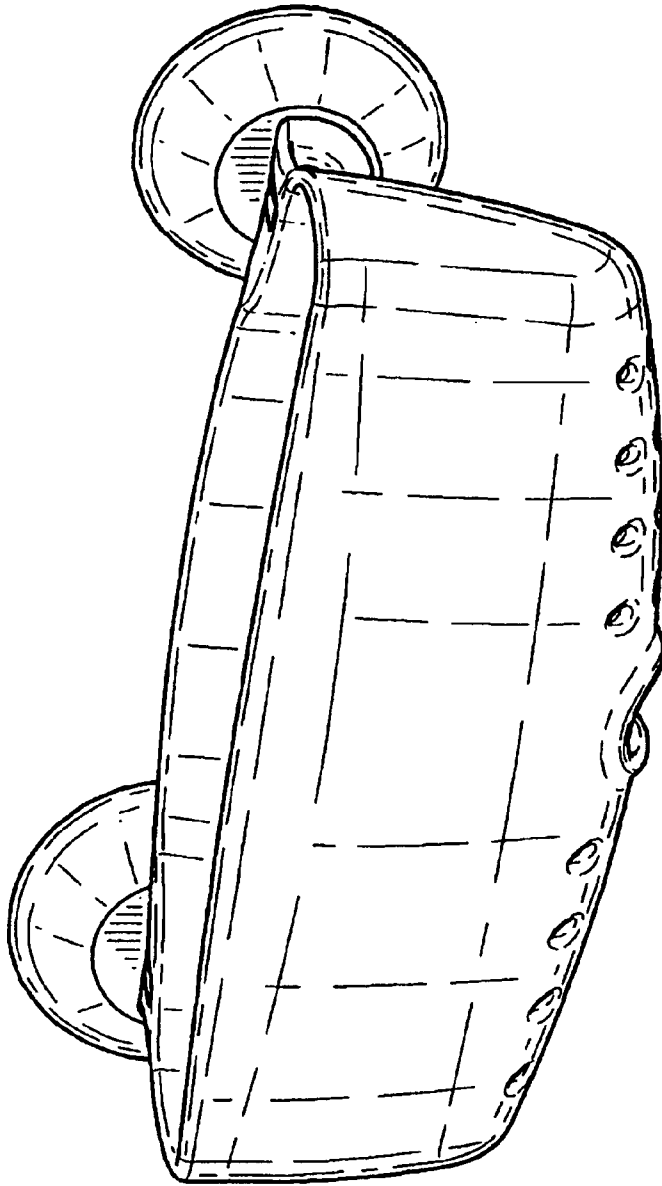

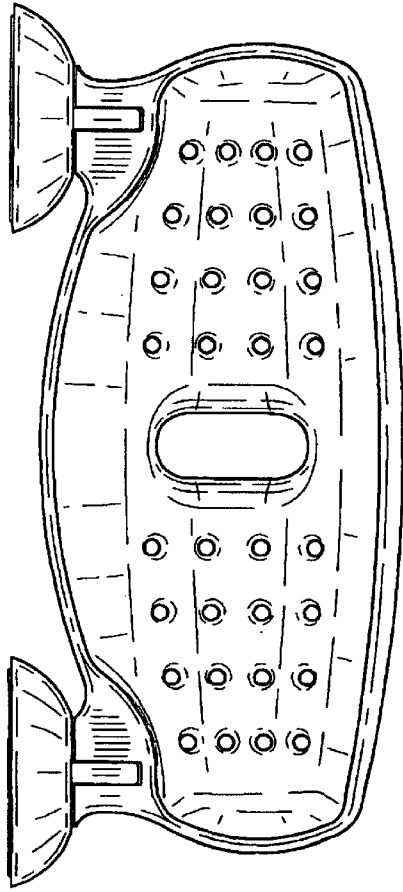

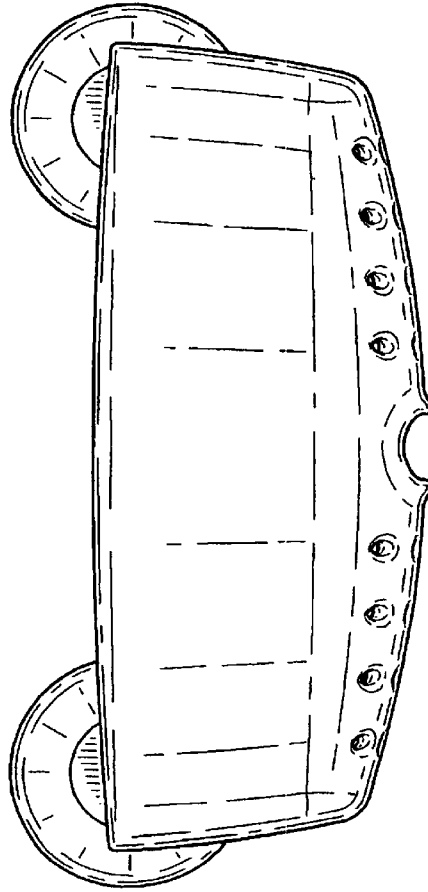

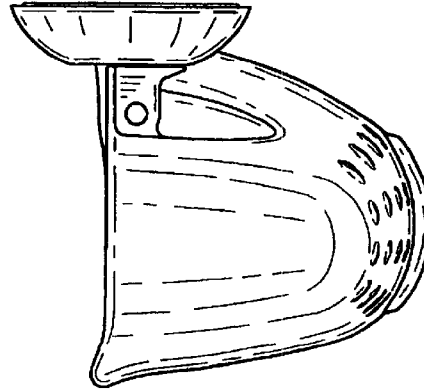

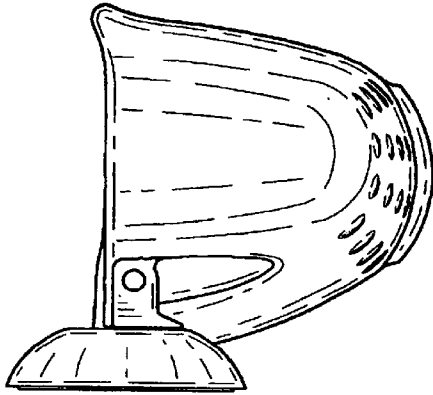

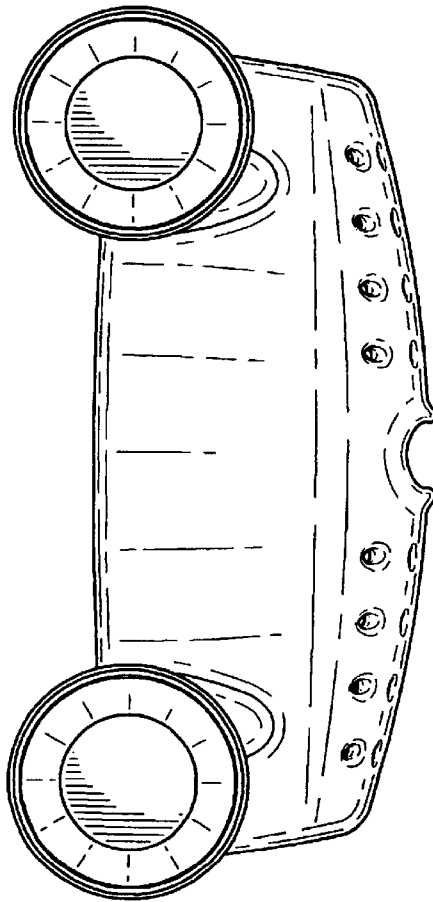

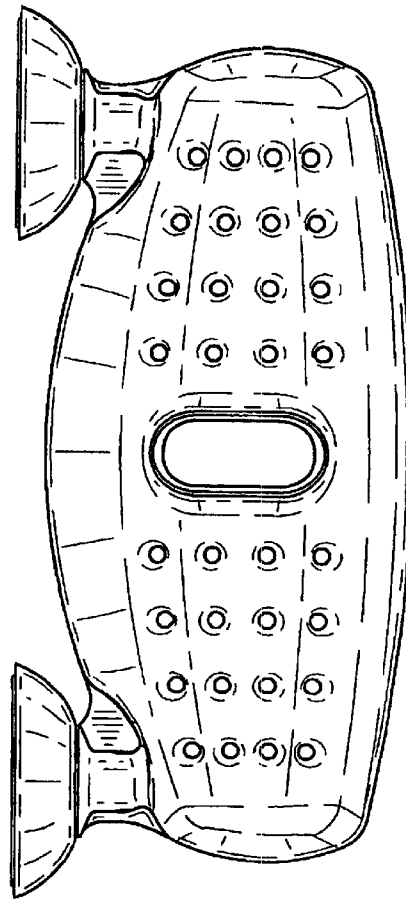

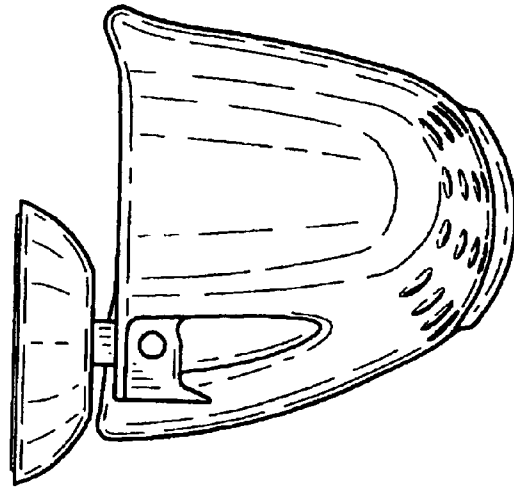

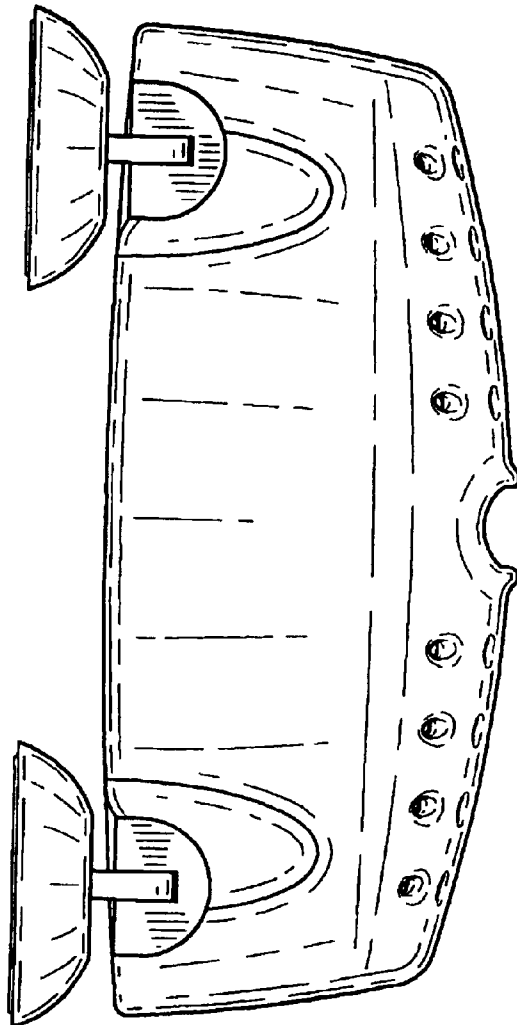
