
(57) **CLAIM**

The ornamental design for a bottle bottom, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a bottle bottom showing our design, the back view being a mirror image thereof;
FIG. 2 is a side view of the bottle, the opposite side being a mirror image thereof;
FIG. 3 is a bottom view of the bottle; and,
FIG. 4 is a bottom perspective view of the bottle.








