The ornamental design for a medical console, as shown and described.


DESCRIPTION

FIG. 1 is a front perspective view of the medical console; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The article is not limited to the scale shown herein. The support arm portion of the medical console is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design. In the drawings, the broken lines depict unclaimed subject matter only and form no part of the claimed design.














