The ornamental design for a rake, as shown and described.

**DESCRIPTION**


FIG. 1 is a first front perspective view of a rake according to our new design;  
 FIG. 2 is a second front perspective view of the rake;  
 FIG. 3 is a first rear perspective view of the rake;  
 FIG. 4 is a second rear perspective view of the rake;  
 FIG. 5 is a front side elevational view of the rake;  
 FIG. 6 is a rear side elevational view of the rake;  
 FIG. 7 is a top view of the rake;  
 FIG. 8 is a bottom view of the rake;  
 FIG. 9 is a right side elevational view of the rake; and,  
 FIG. 10 is a left side elevational view of the rake.  
 The broken lines in the figures are included for the purpose of depicting unclaimed portions of the rake and form no part of the claimed design. The unclaimed handle is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.


















