
(57) **CLAIM**

The ornamental design for a mobile device case, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a first embodiment of a mobile device case showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top elevational view thereof;
FIG. 7 is a bottom elevational view thereof;
FIG. 8 is a front isometric view thereof, as installed on a notepad mobile device and with the case opened;
FIG. 9 is a front isometric view thereof, as installed on a notepad mobile device and with the case closed and fastened;
FIG. 10 is a rear isometric view thereof, as installed on a notepad mobile device and with the case open and fastened;
FIG. 11 is an isometric view of a second embodiment of a mobile device case showing my new design, with the broken lines and shading in each of the views illustrating a solid surface only and forming no part of the claimed design;
FIG. 12 is a front elevational view thereof;
FIG. 13 is a rear elevational view thereof;
FIG. 14 is a left side elevational view thereof;
FIG. 15 is a right side elevational view thereof;
FIG. 16 is a top elevational view thereof;
FIG. 17 is a bottom elevational view thereof;
FIG. 18 is a front isometric view thereof, as installed on a tablet mobile device and with the case opened;
FIG. 19 is a front isometric view thereof, as installed on a tablet mobile device and with the case closed and fastened;
and,
FIG. 20 is a rear isometric view thereof, as installed on a tablet mobile device and with the case open and fastened.






































