(57) **CLAIM**

The ornamental design for a portion of an engine, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a portion of an engine according to the present design;

FIG. 2 is a rear elevation view of the portion of an engine shown in FIG. 1;

FIG. 3 is a front elevation view of the portion of an engine shown in FIG. 1;

FIG. 4 is a left side elevation view of the portion of an engine shown in FIG. 1;

FIG. 5 is a right side elevation view of the portion of an engine shown in FIG. 1; and,

FIG. 6 is a perspective view of the portion of an engine shown in FIG. 1.












