(57) **CLAIM**

The ornamental design for a vehicle wheel hub cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a vehicle wheel hub cover;

FIG. 2 is a back perspective view of a vehicle wheel hub cover of FIG. 1;

FIG. 3 is a bottom view of a vehicle wheel hub cover of FIG. 1;

FIG. 4 is a top view of a vehicle wheel hub cover of FIG. 1;

FIG. 5 is a left side elevational view of a vehicle wheel hub cover of FIG. 1;

FIG. 6 is a right side elevational view of a vehicle wheel hub cover of FIG. 1;

FIG. 7 is a front elevational view of a vehicle wheel hub cover of FIG. 1;

FIG. 8 is a rear elevational view of the vehicle wheel hub cover of FIG. 1;


FIG. 9 is a cross-sectional view of a vehicle wheel hub cover of FIG. 1, sectioned along line 9-9 in FIG. 7;

FIG. 10 is a cross-sectional view of a vehicle wheel hub cover of FIG. 1, sectioned along line 10-10 in FIG. 7; and,

FIG. 11 is an exploded cross-sectional view of a vehicle wheel hub cover of FIG. 1, sectioned along line 10-10 in FIG. 7.






















