The ornamental design for a headlight for a vehicle, as shown and described.



DESCRIPTION

This application contains subject matter related to the following U.S. design patent application: Application Ser. No. 29/455,966, filed May 28, 2013, now U.S. Pat. No. D710,258, and entitled "Vehicle, Toy, and/or Replicas Thereof."

FIG. 1 is a right perspective view of a first embodiment of a headlight for a vehicle according to the design; FIG. 2 is a front view thereof; FIG. 3 is a right side view thereof; and FIG. 4 is a top view thereof. FIG. 5 is a left perspective view of a second embodiment of the headlight for a vehicle according to the design; FIG. 6 is a front view thereof; FIG. 7 is a left side view thereof; and, FIG. 8 is a top view thereof.

The broken lines shown in the figures represent portions of the headlight for a vehicle that form no part of the claimed design.
















