(57) **CLAIM**

We claim the ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an embodiment of a golf club head in accordance with our new design.

FIG. 2 is a rear elevational view of the golf club head of FIG. 1.

FIG. 3 is a top plan view of the golf club head of FIG. 1.

FIG. 4 is a bottom plan view of the golf club head of FIG. 1.

FIG. 5 is a right side elevational view of the golf club head of FIG. 1.

FIG. 6 is a left side elevational view of the golf club head of FIG. 1.

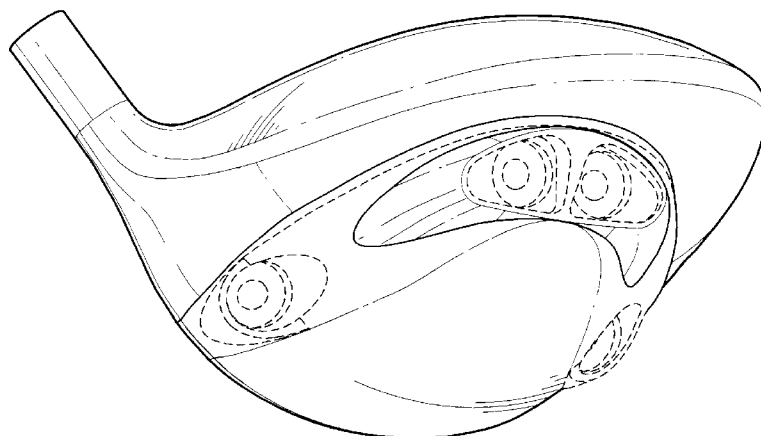
FIG. 7 is a top left perspective view of the golf club head of FIG. 1.

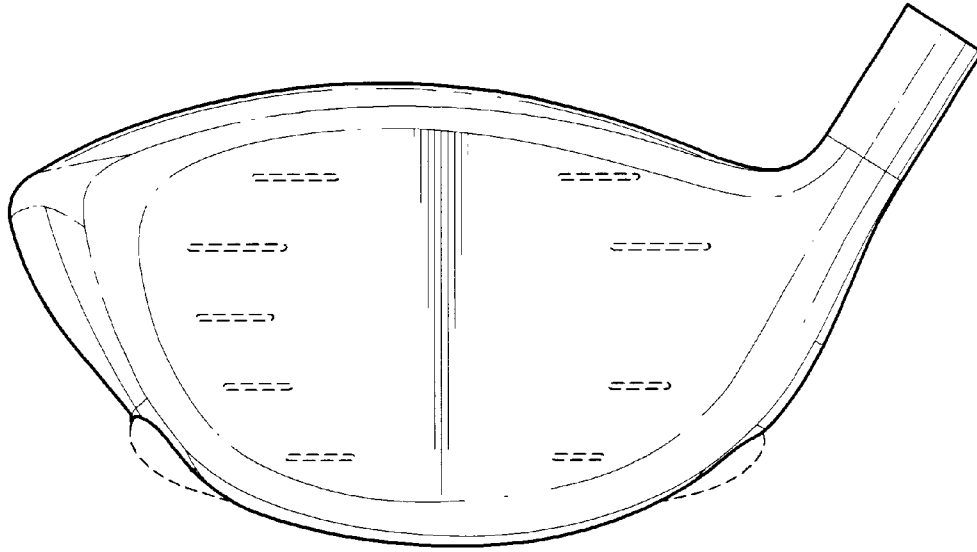

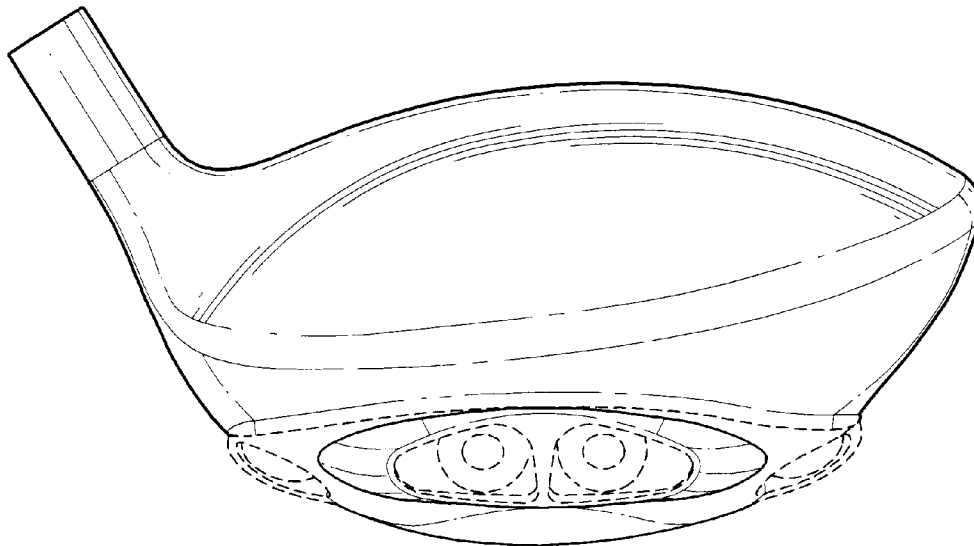

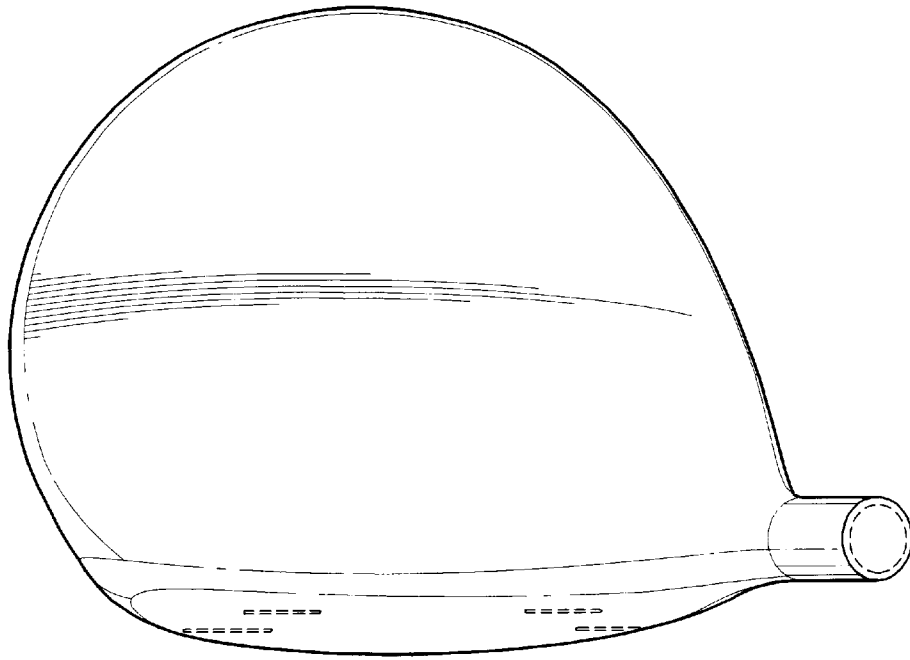

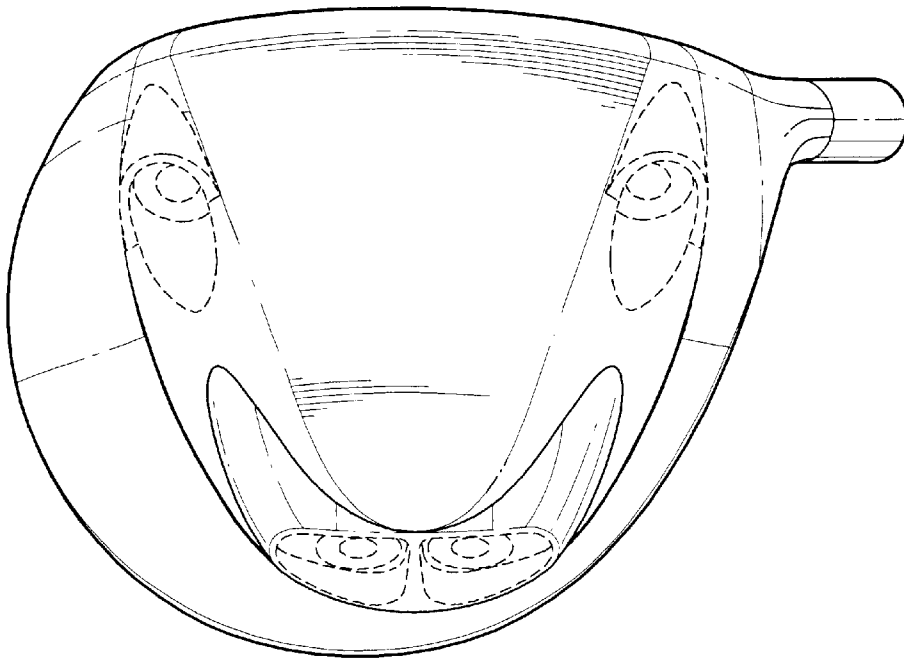

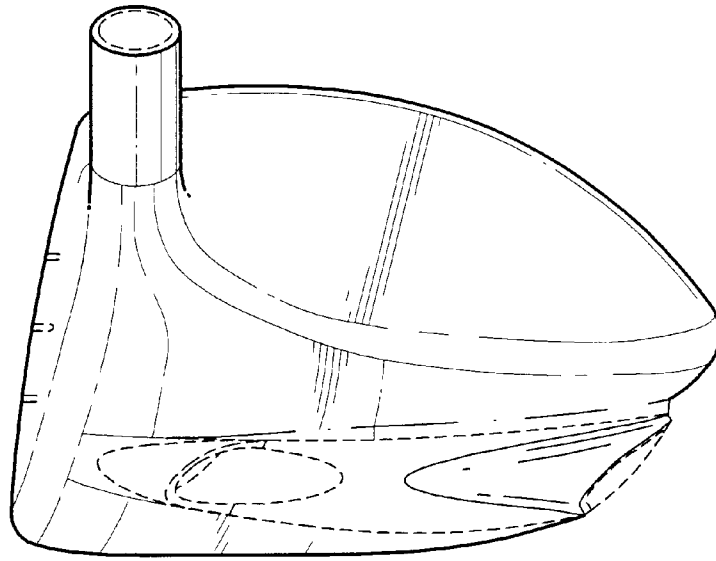

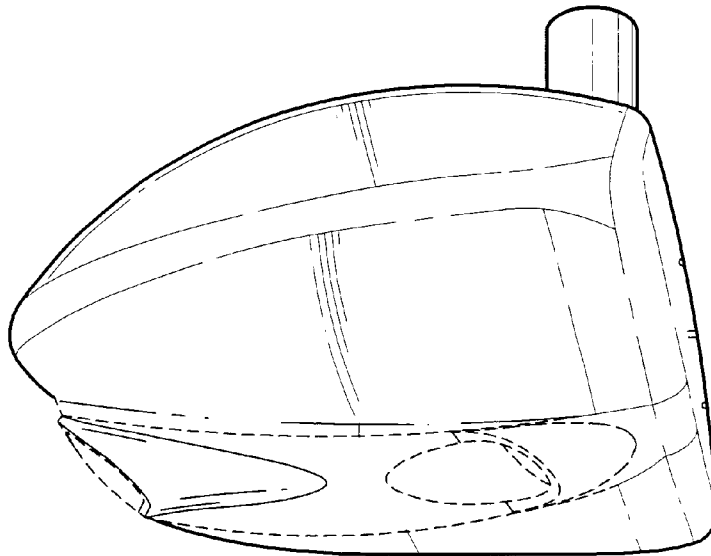

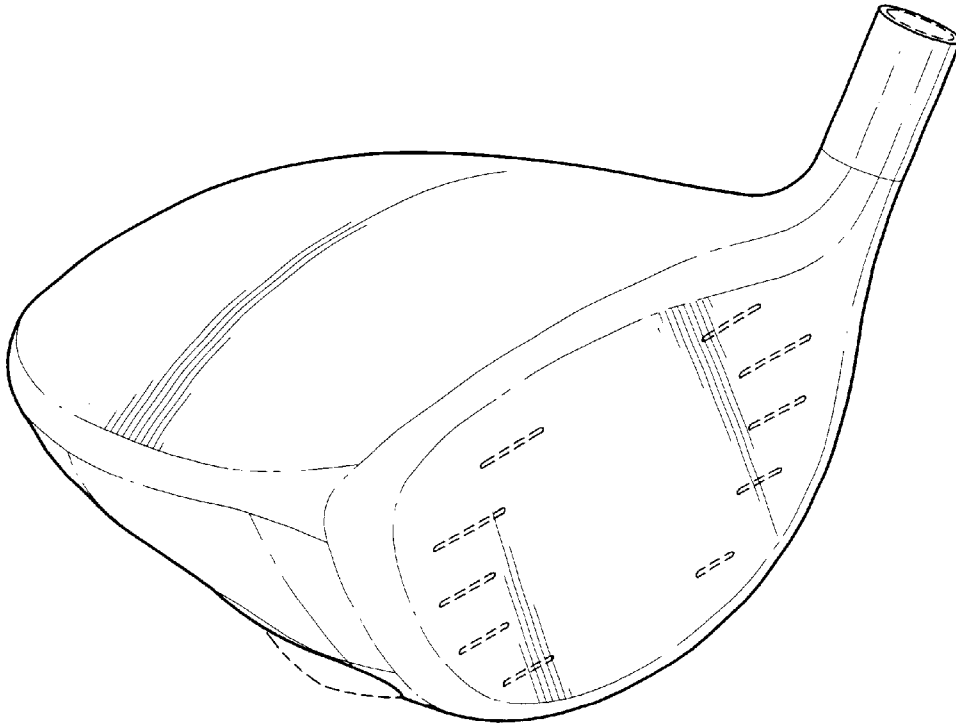

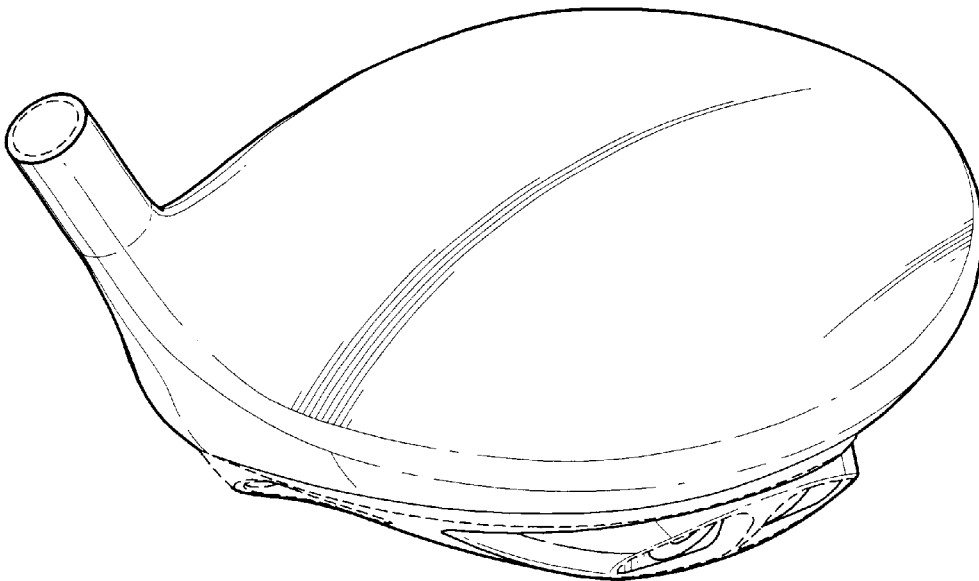

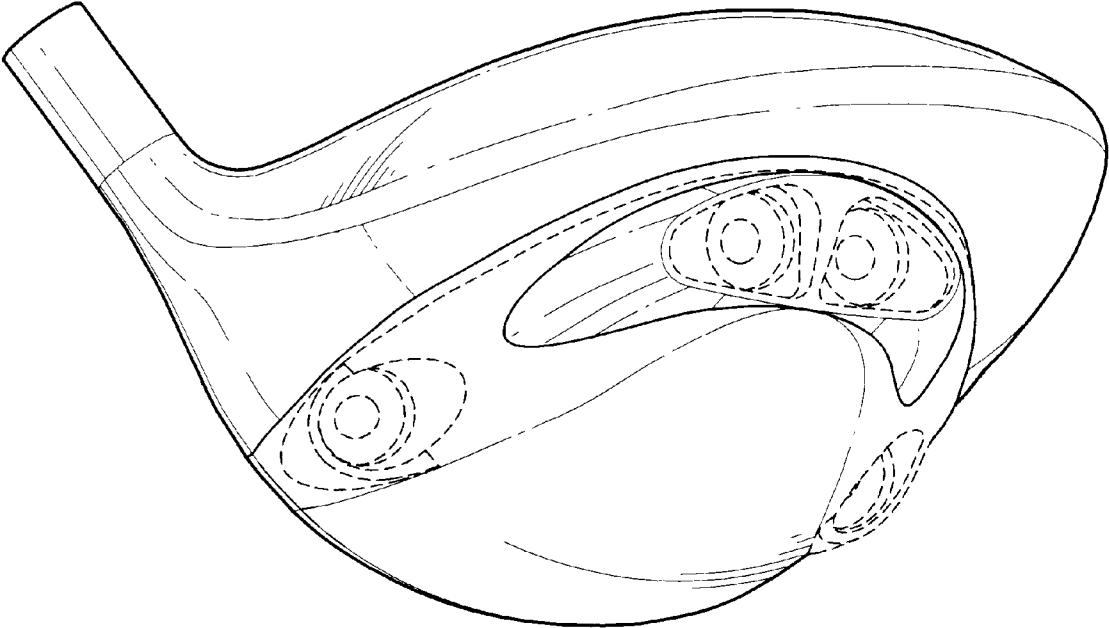
