FIG. 8 is a cross-sectional view of the stock adapter for a rifle taken at line 8—8 of FIG. 6.

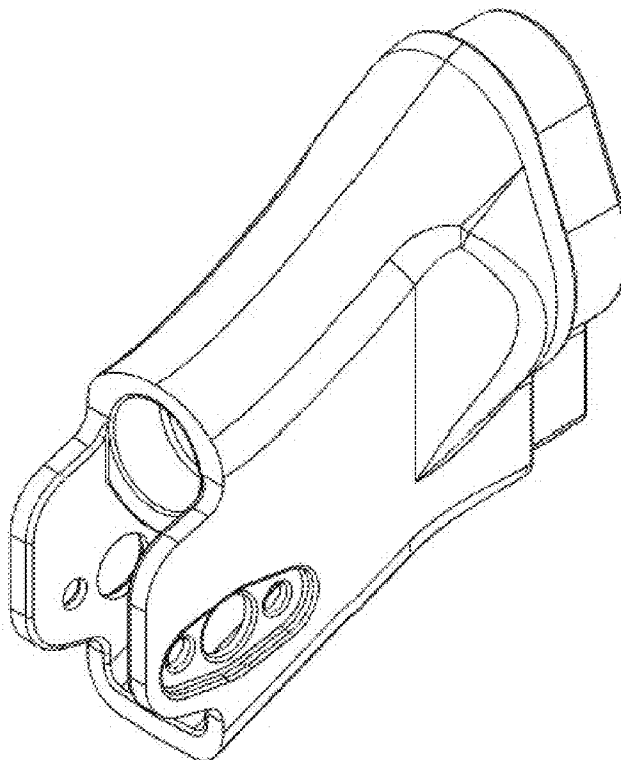
The broken line showing of portions of the stock adapter shown in FIG. 6 is included for the purpose of illustrating environment and forms no part of the claimed design.

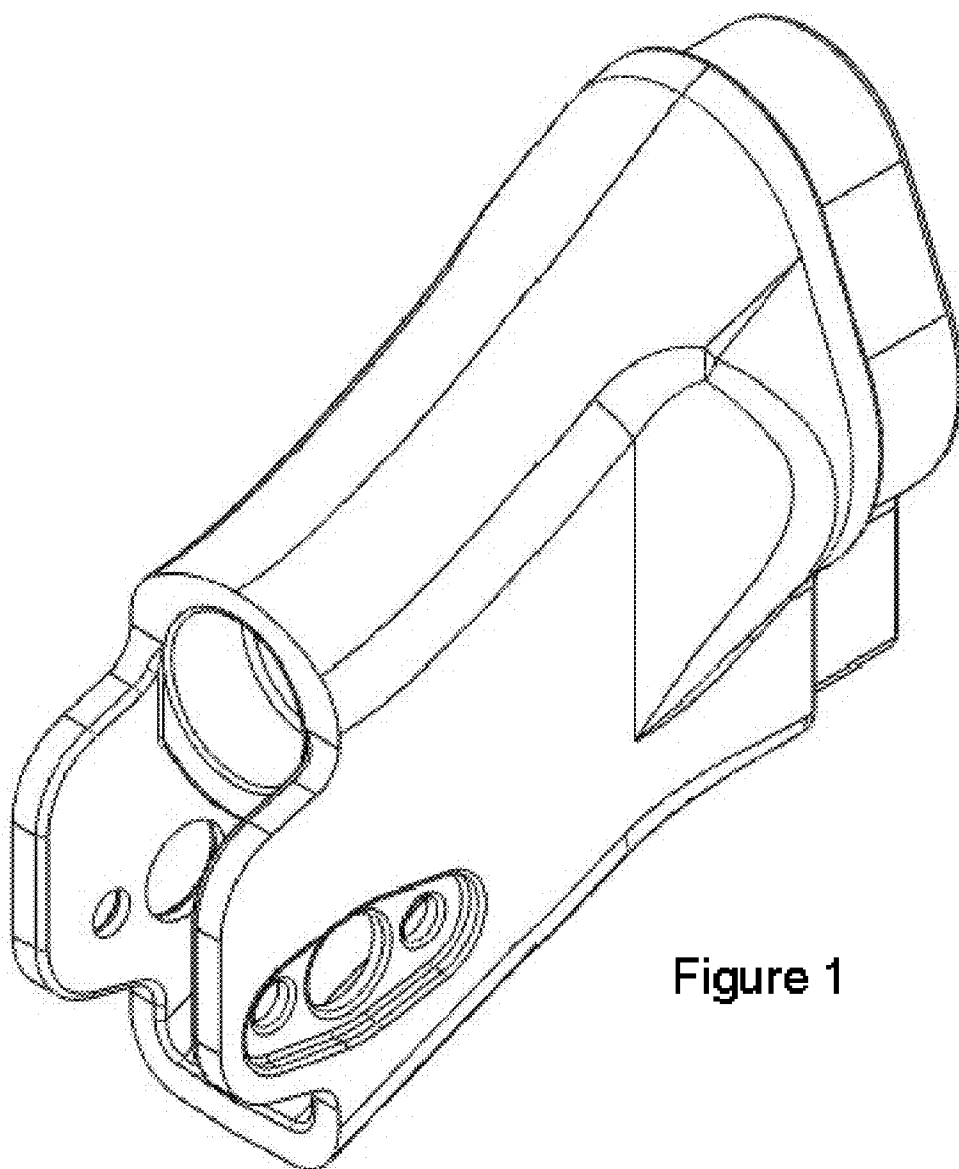

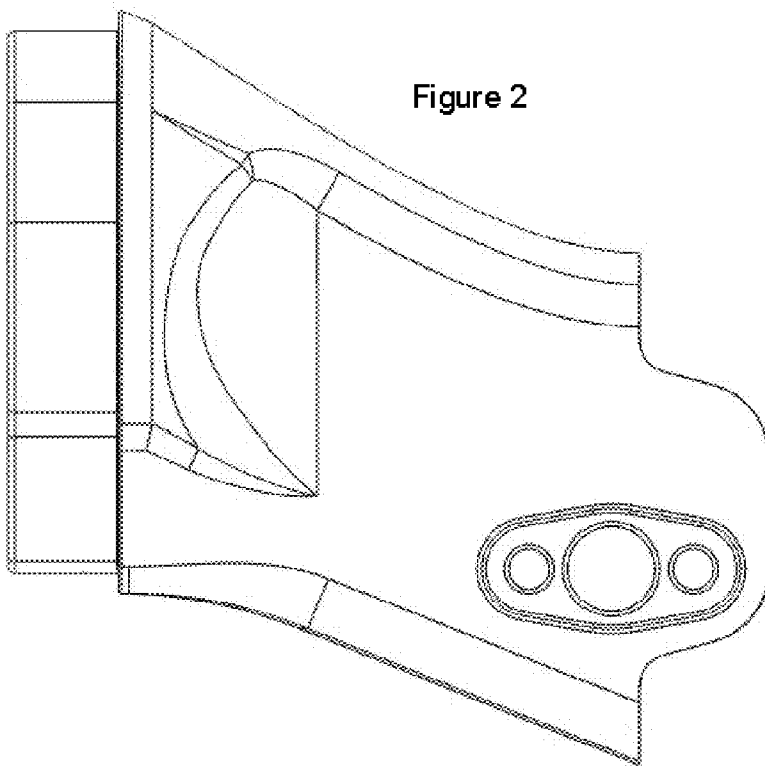

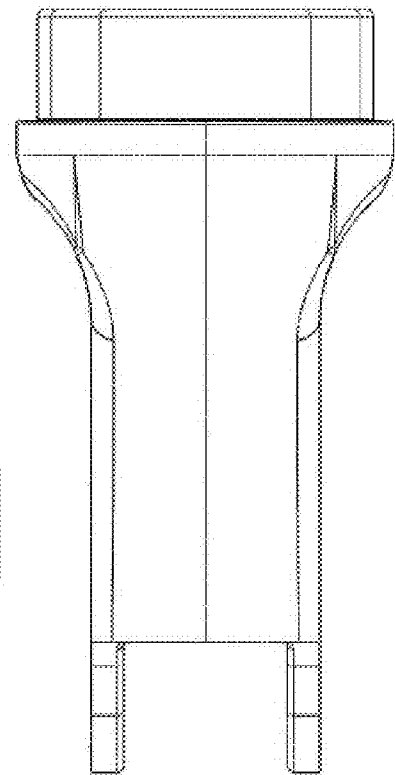

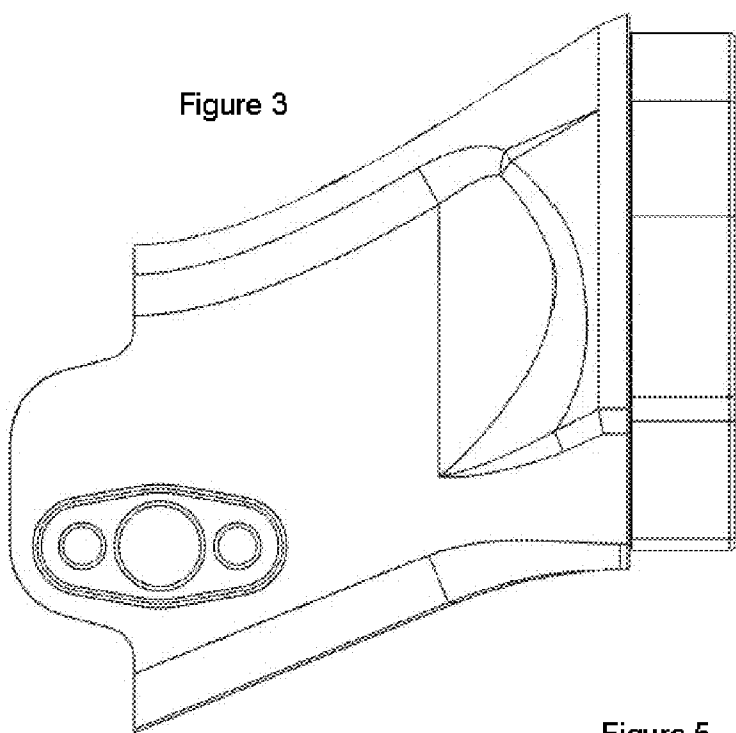
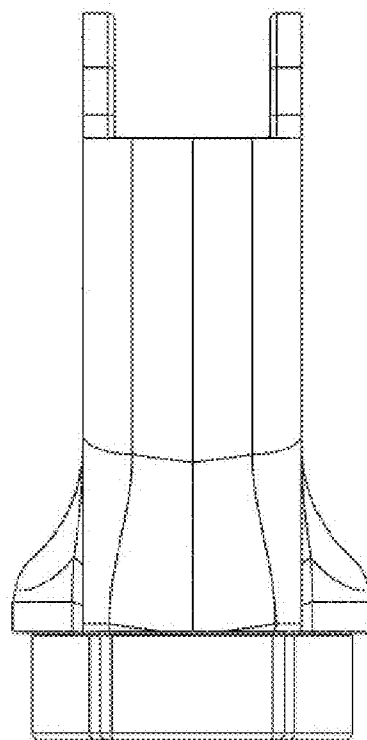

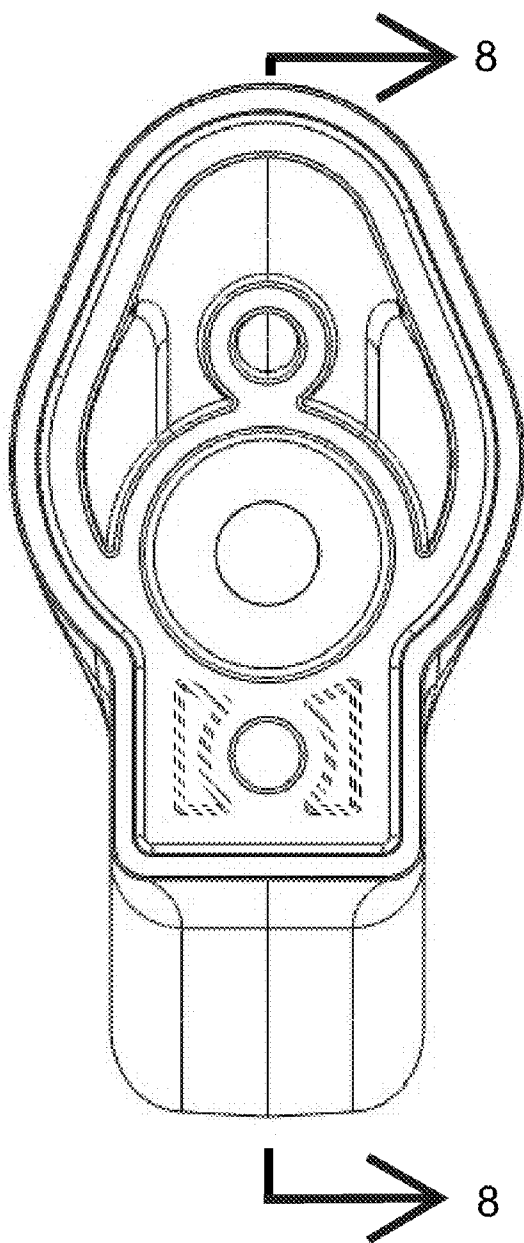

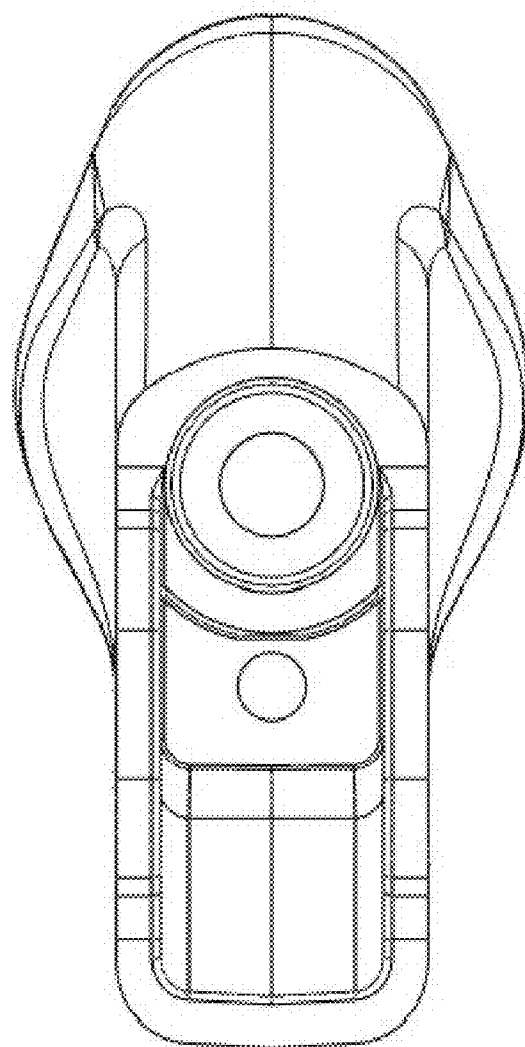
