The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a bottle showing my new design;

FIG. 2 is a front elevation view thereof, the right side, left side and rear elevation views being identical;

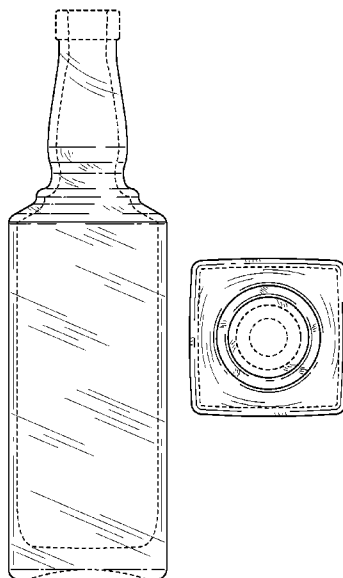
FIG. 3 is a front and side elevation view thereof;

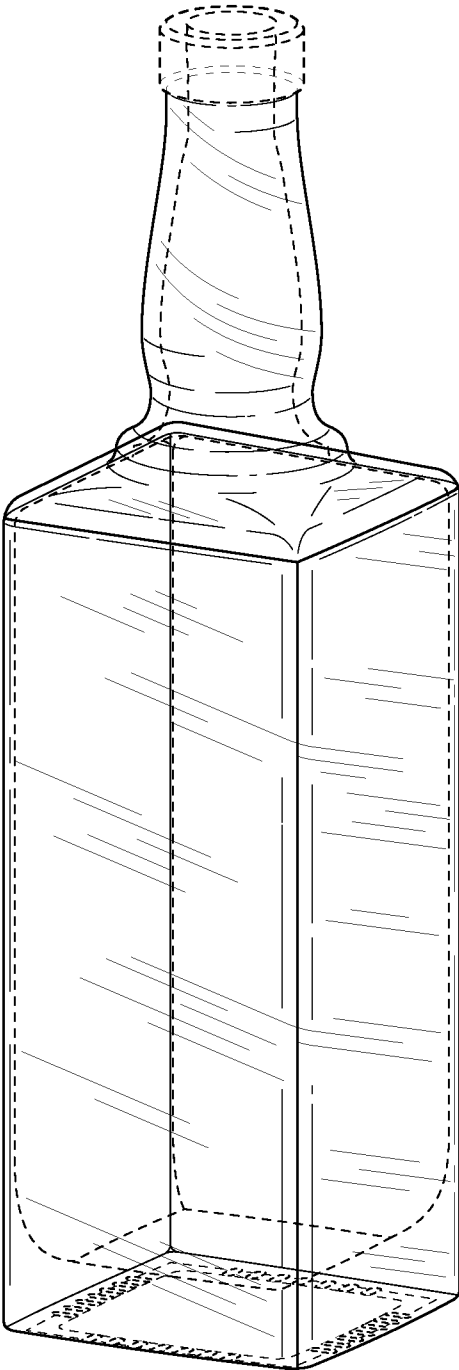

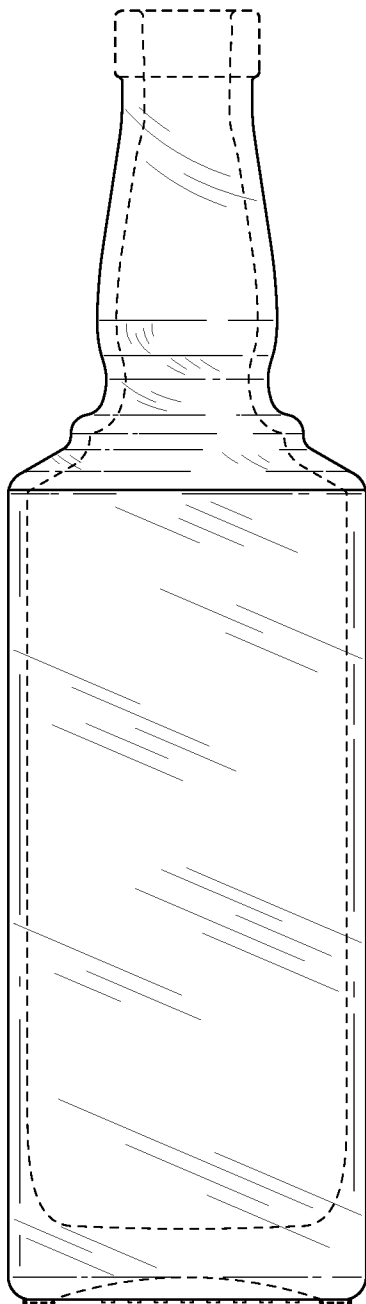

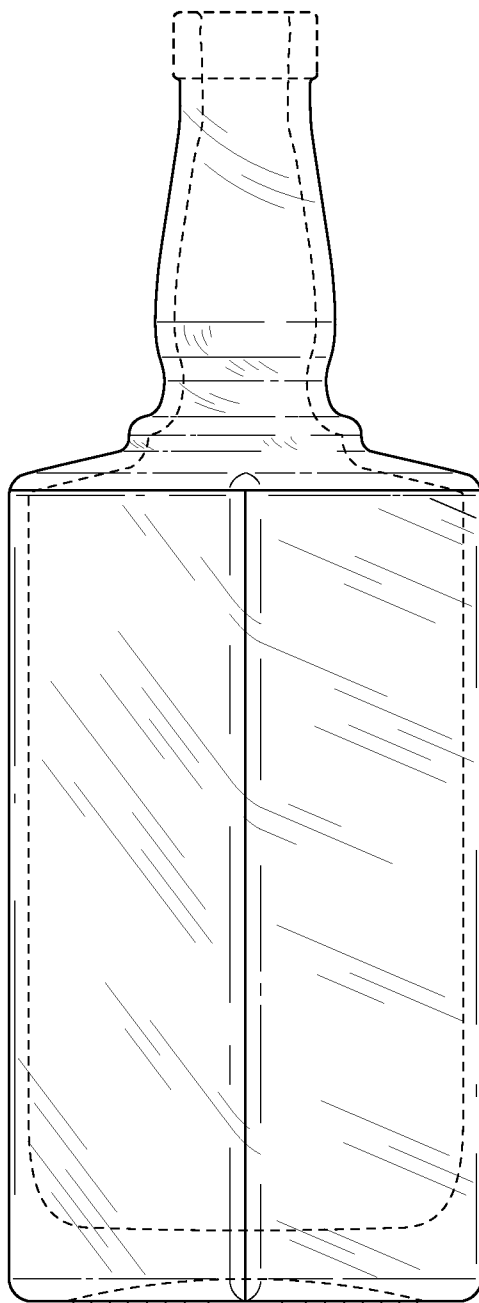

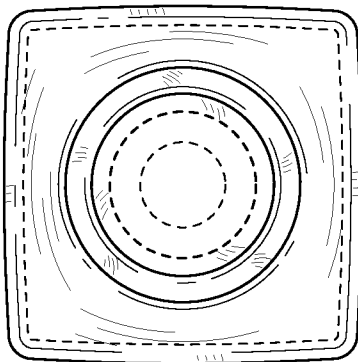

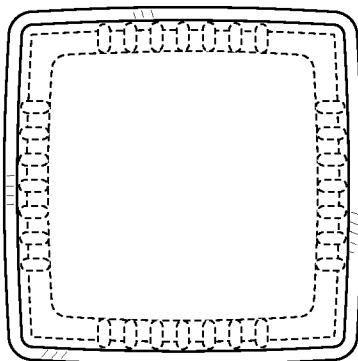
