FIG. 3 is a bottom view thereof;


FIG. 4 is a right view of the right shoe;


FIG. 5 is a left view of the left shoe;

FIG. 6 is a front view of a pair of spiked shoe protectors; and,


FIG. 7 is a back view thereof.













