(57) **CLAIM**

We claim the ornamental design for an applicator, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a topical applicator showing the new design;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a front elevation view thereof, the rear elevation view being a mirror image of the front elevation view;

FIG. 4 is a right side elevation view thereof, the left side elevation view being a mirror image of the right side elevation view;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and

FIG. 7 is a cross-sectional view thereof; taken along either line 7-7 of FIG. 4.

FIG. 8 is a top perspective view of an alternate embodiment of a topical applicator showing the new design;

FIG. 9 is a bottom perspective view thereof;

FIG. 10 is a front elevation view thereof, the rear elevation view being a mirror image of the front elevation view;

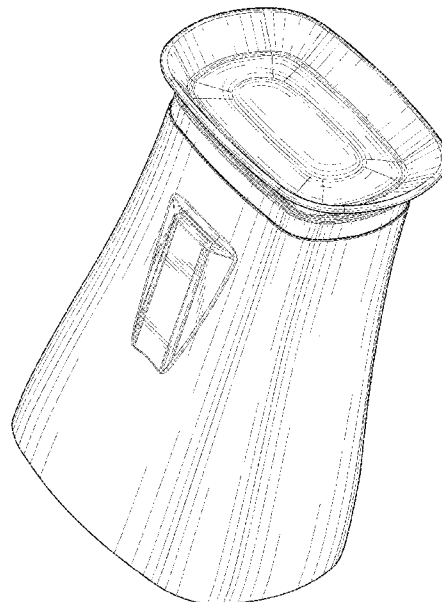
FIG. 11 is a right side elevation view thereof, the left side elevation view being a mirror image of the right side elevation view;

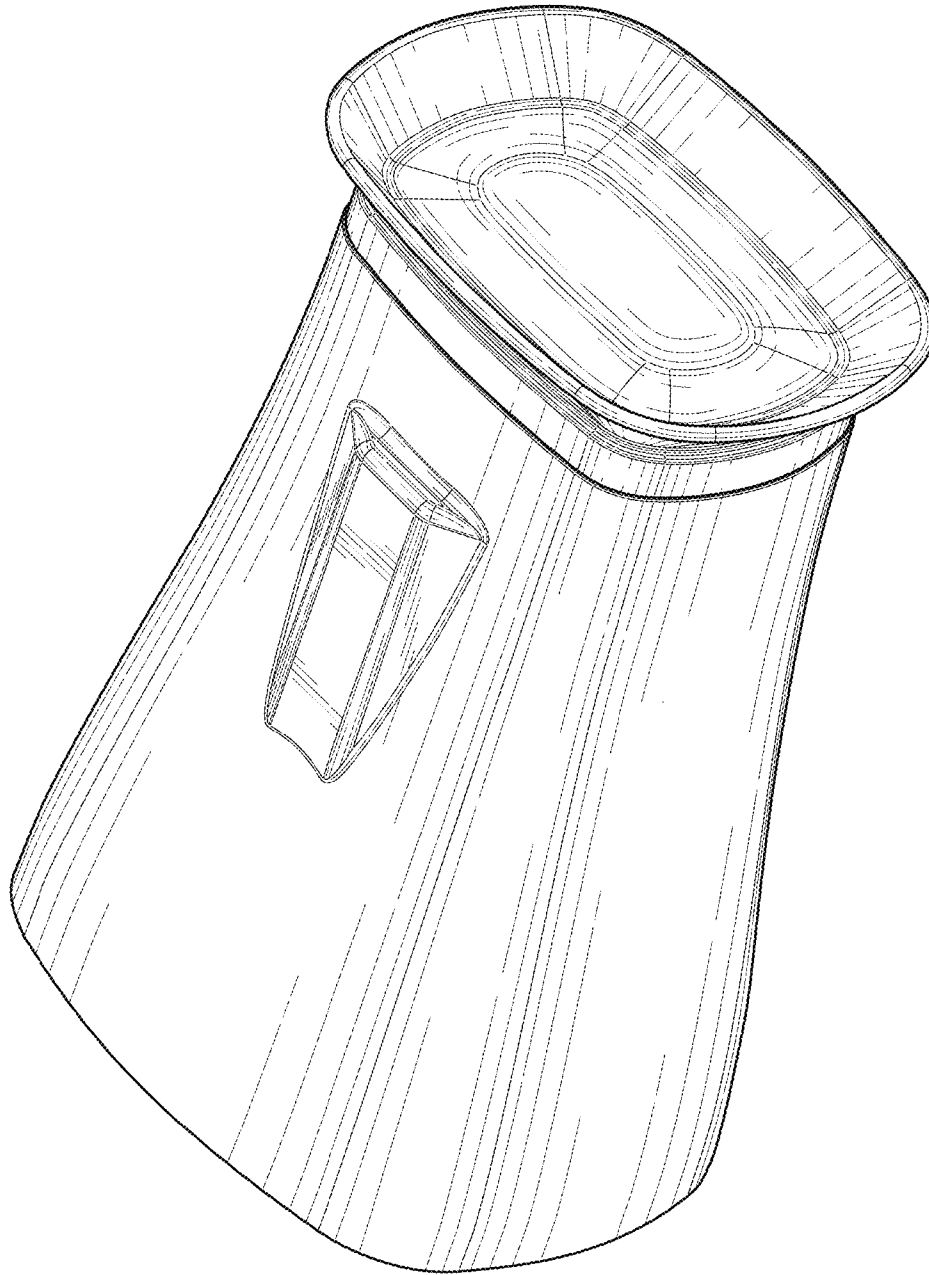

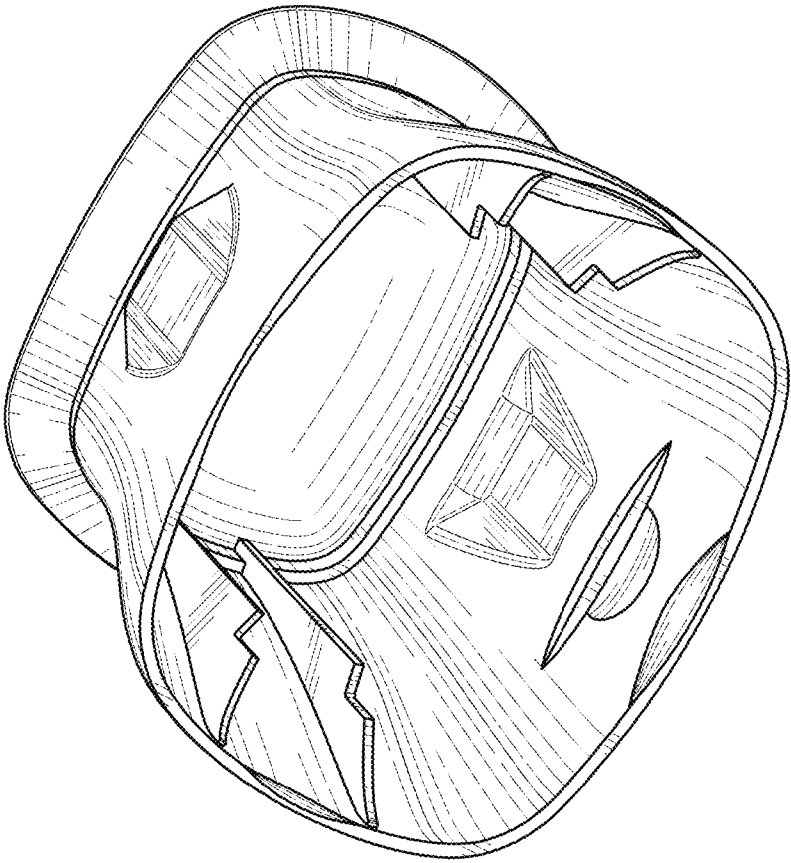

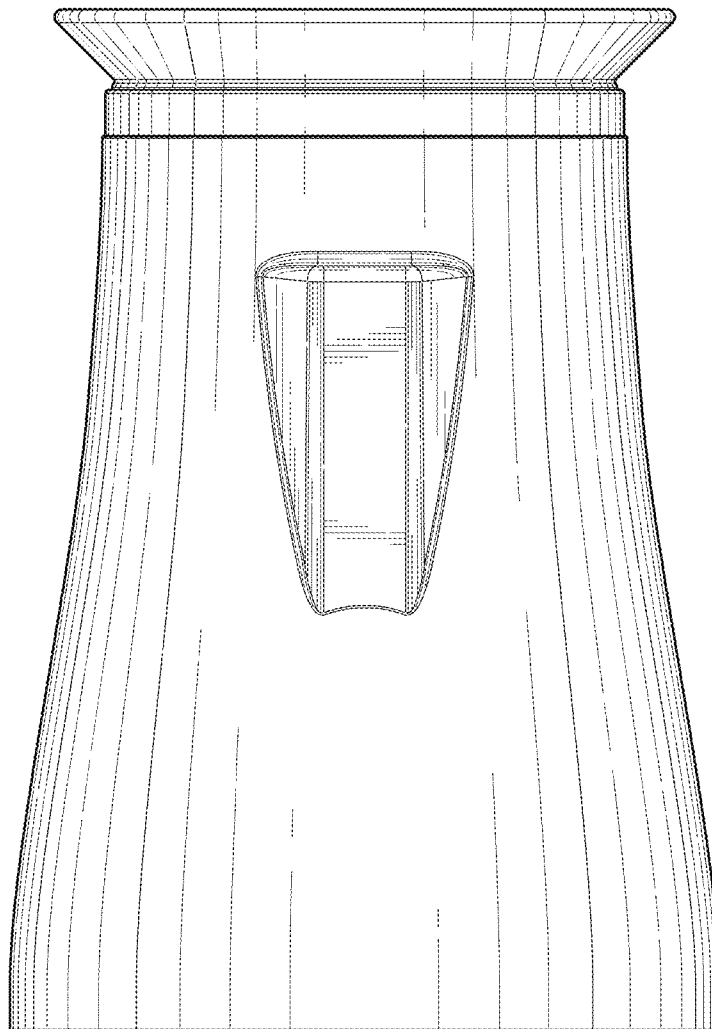

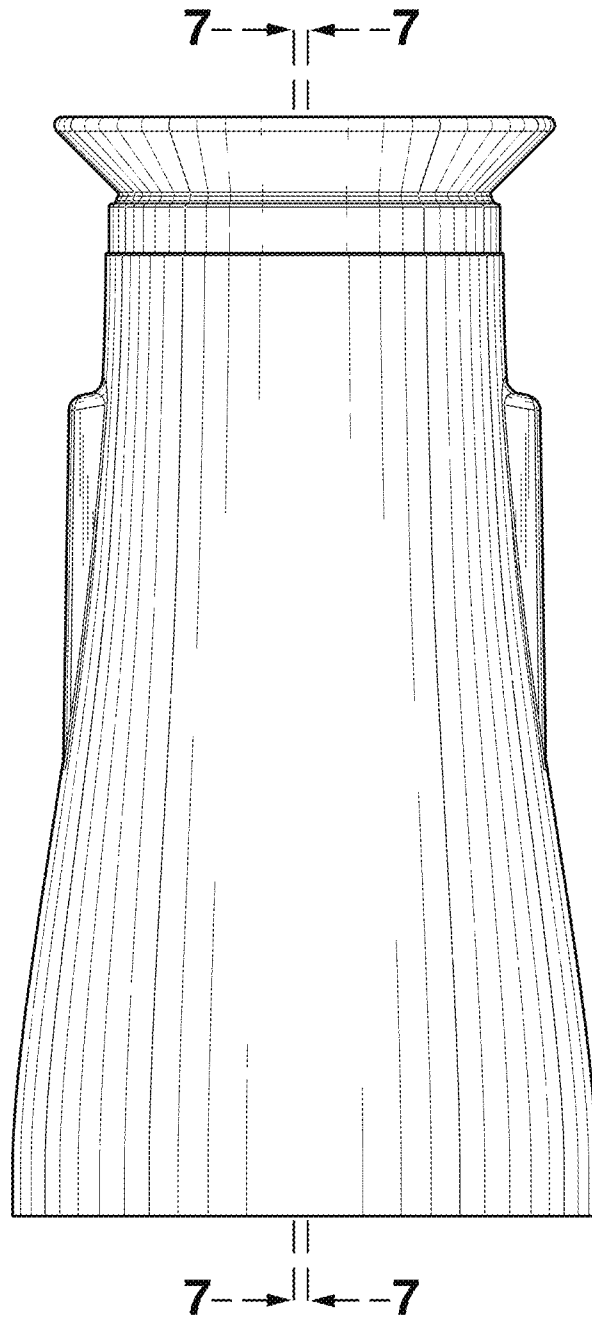

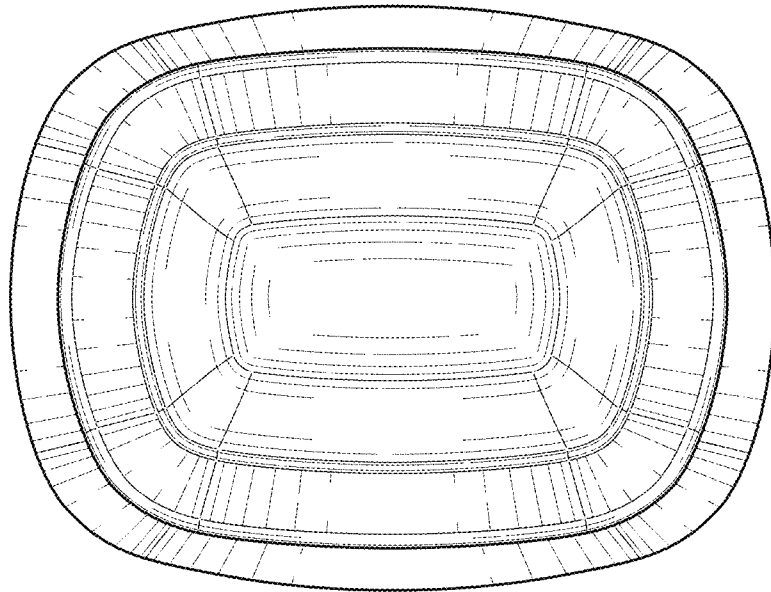

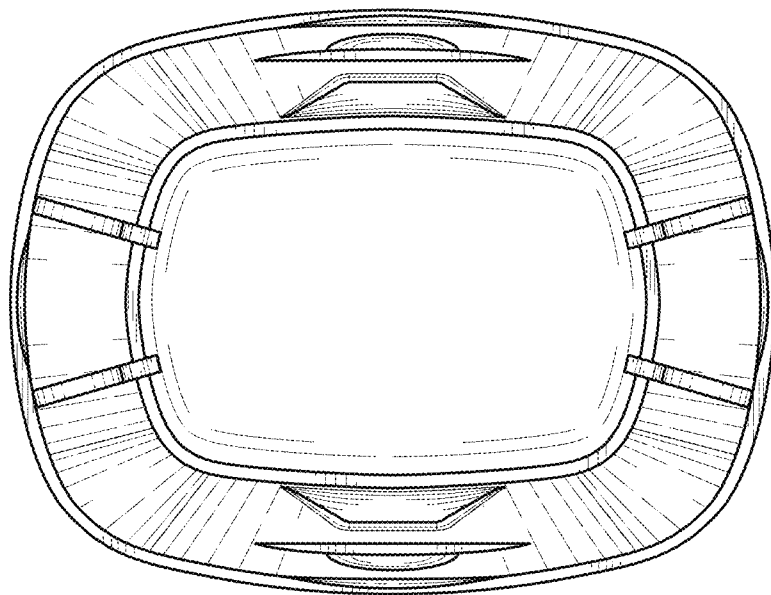

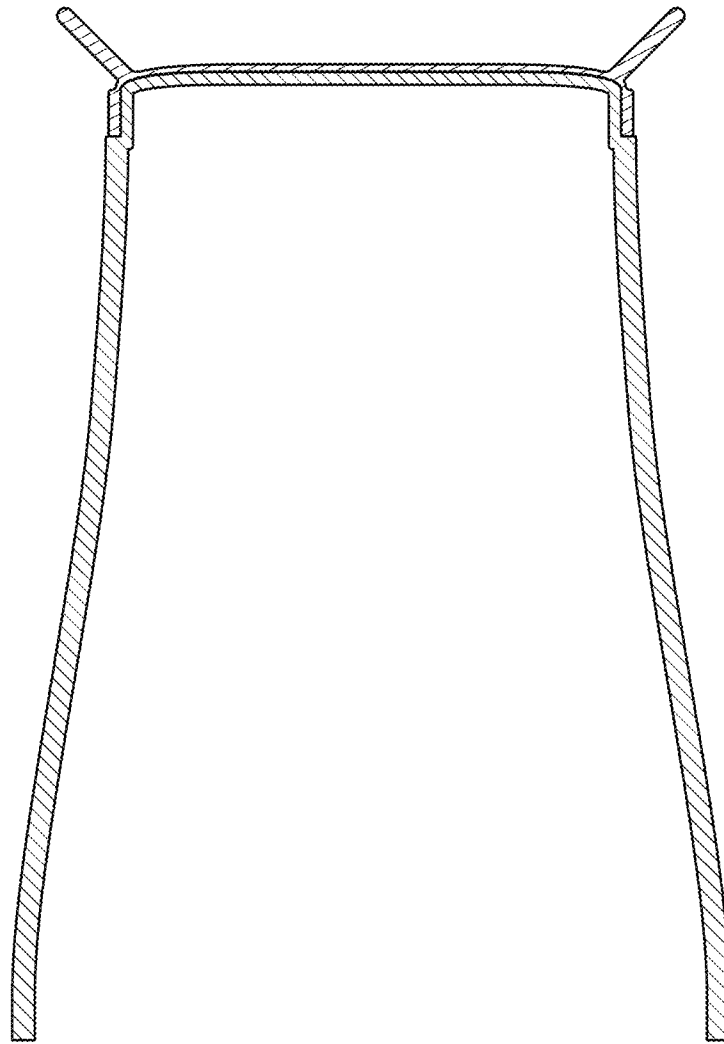

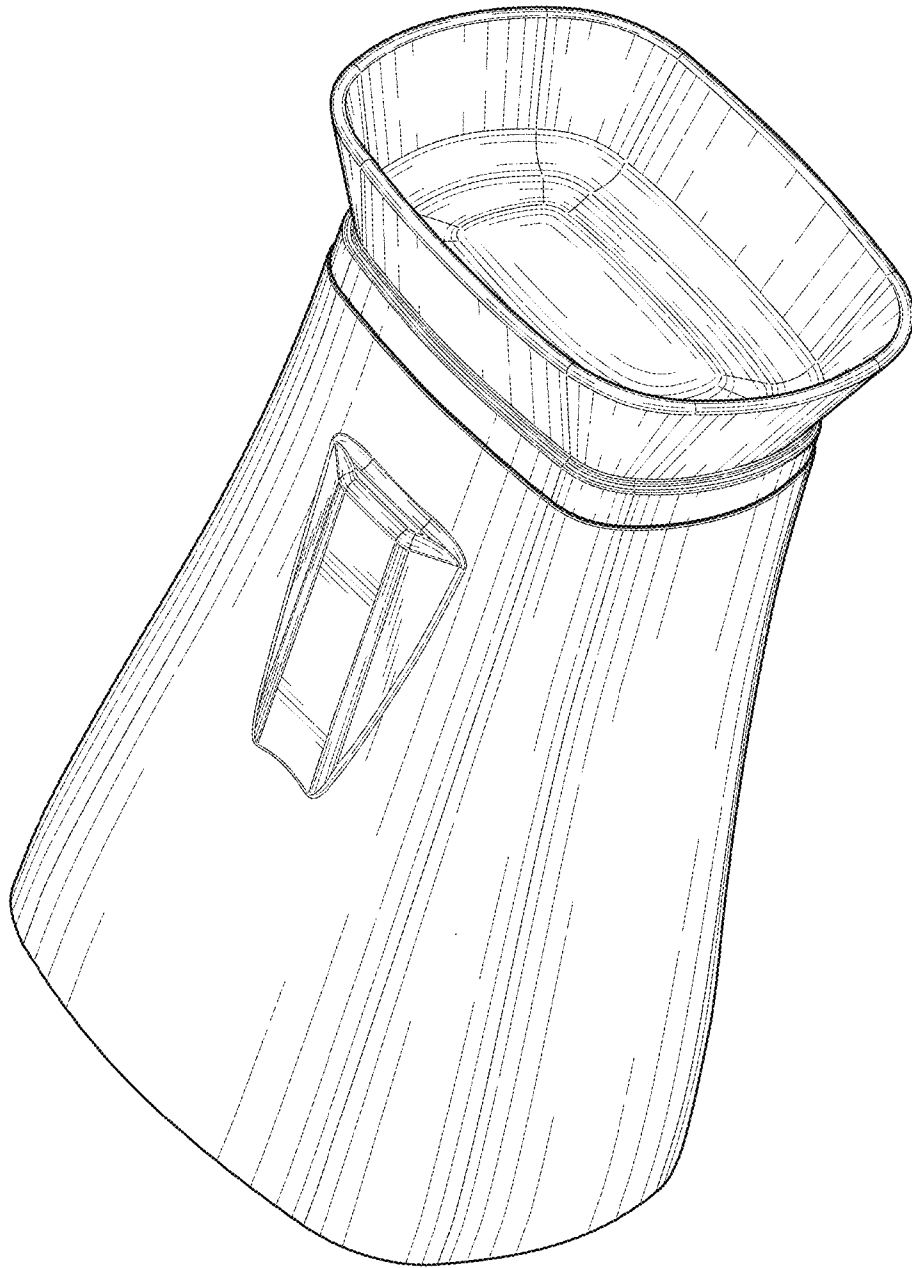

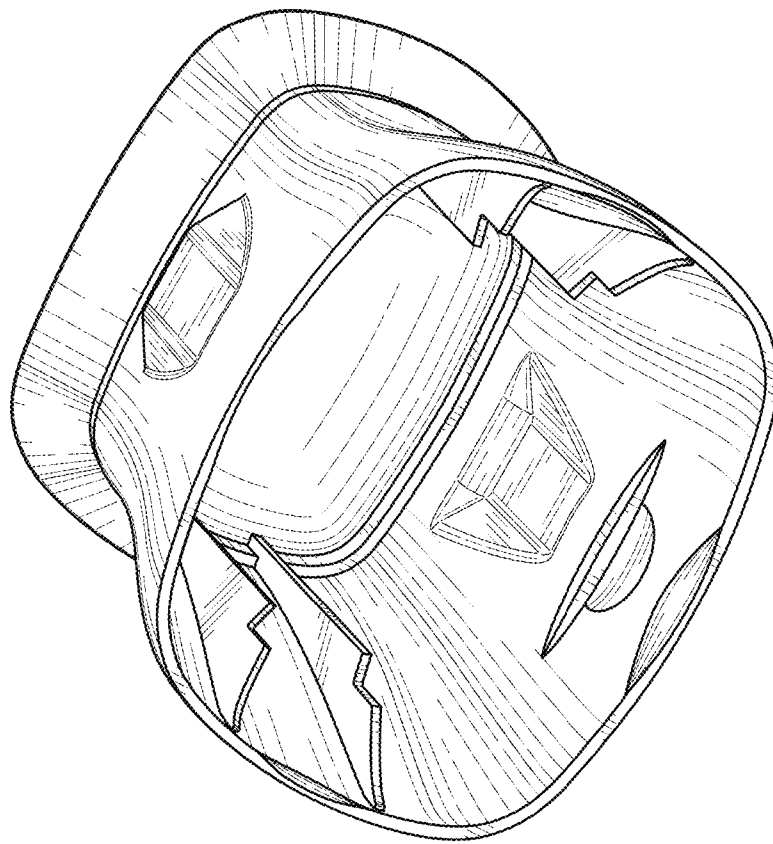

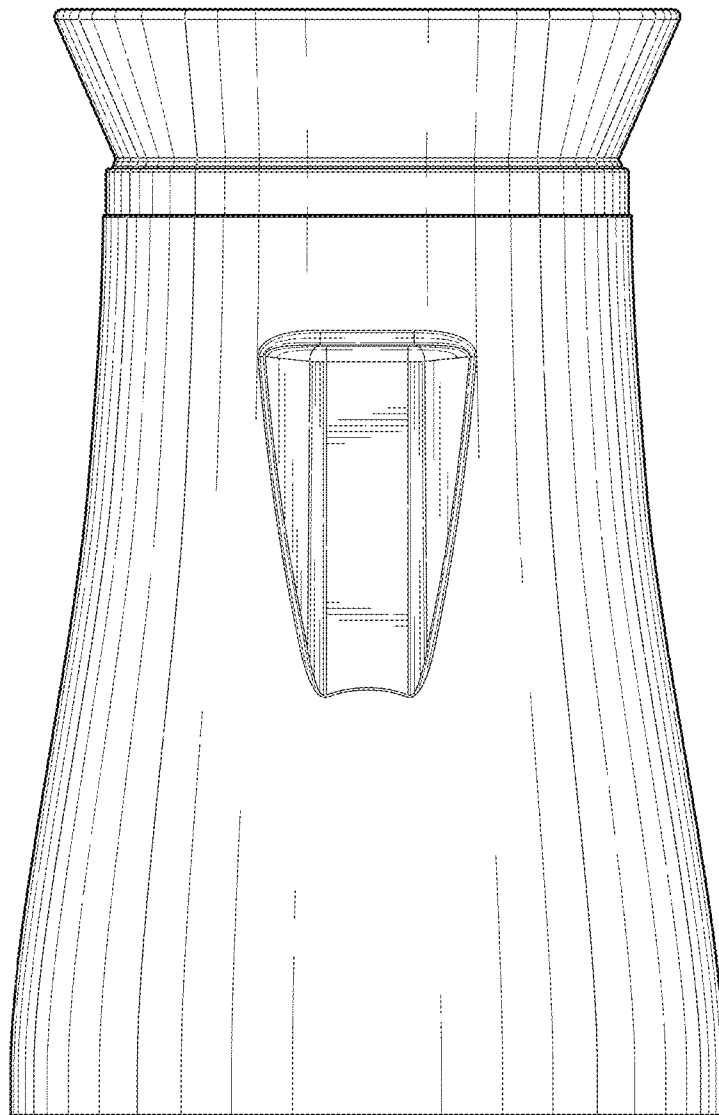

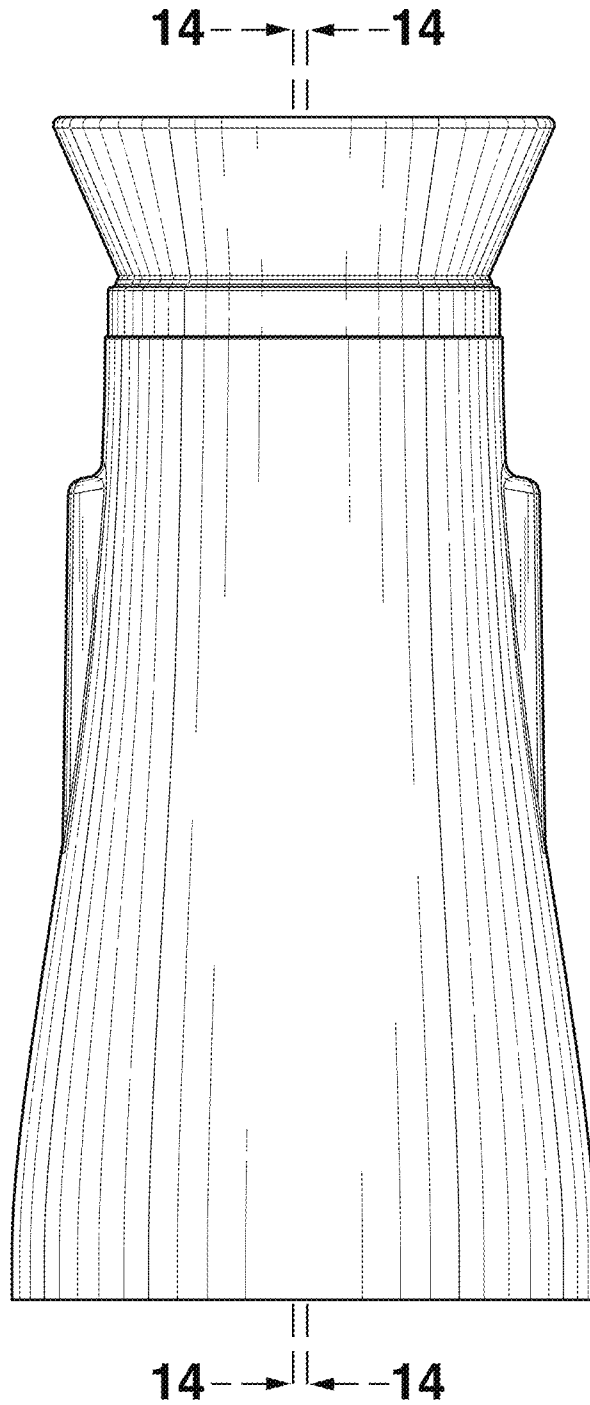

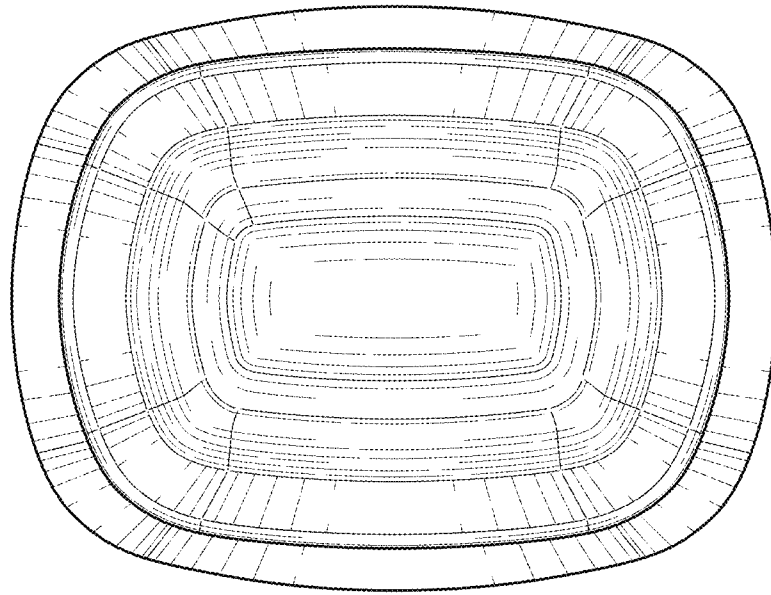

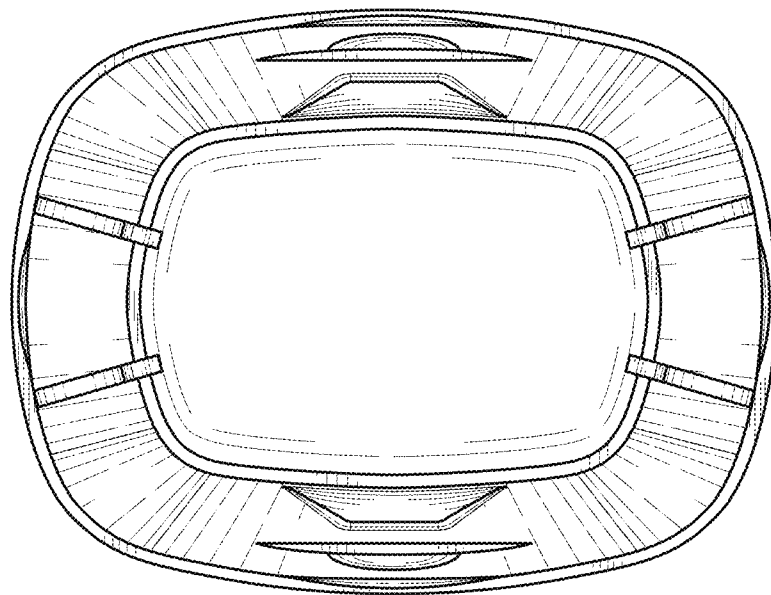

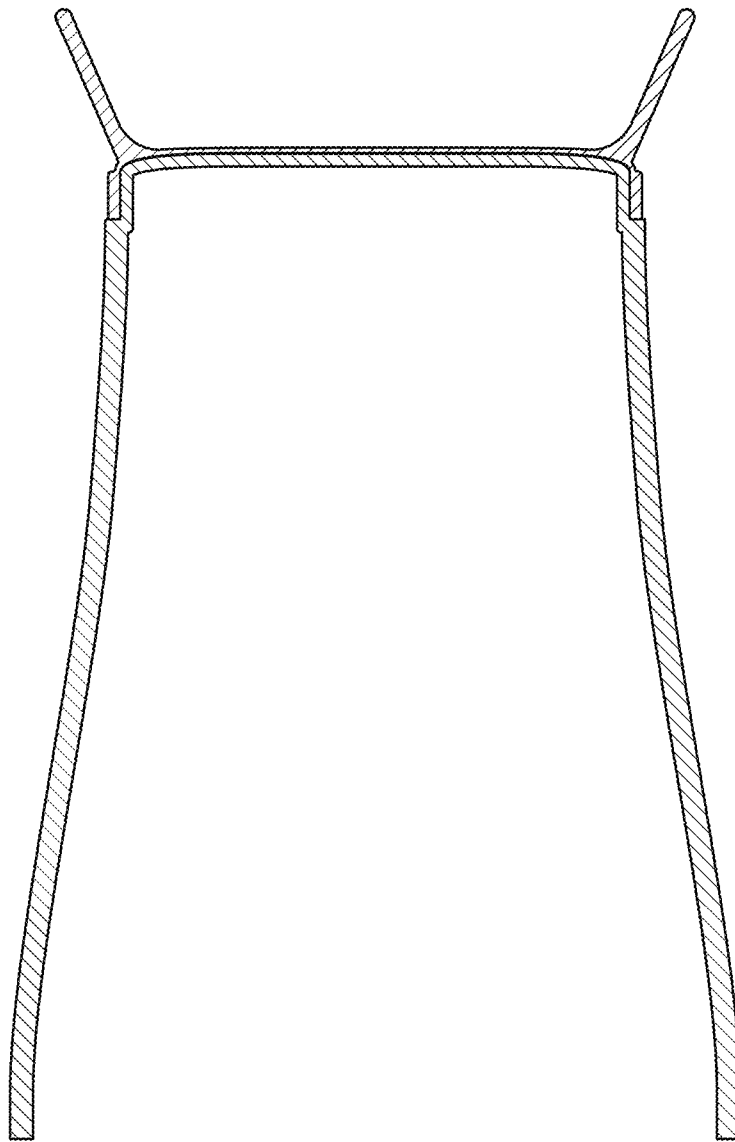
