(57) **CLAIM**

The ornamental design for a hinge for furniture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, front and right side of a hinge for furniture showing my (our) new design;

FIG. 2 is a perspective view of the top, rear and left side thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom view thereof;

FIG. 9 is a cross-sectional view thereof;

FIG. 10 is a partially enlarged view thereof, at the call-out box shown in FIG. 6;

FIG. 11 is a front view thereof, where an arm portion is rotated; and,

FIG. 12 is a perspective view thereof, in a position of use.

The broken lines in the drawings illustrate portions of the hinge for furniture which form no part of the claimed design.

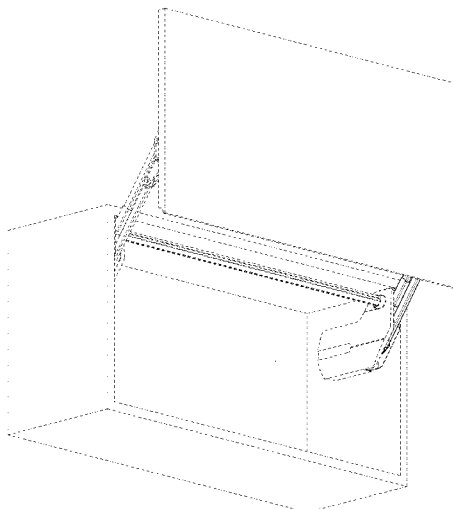
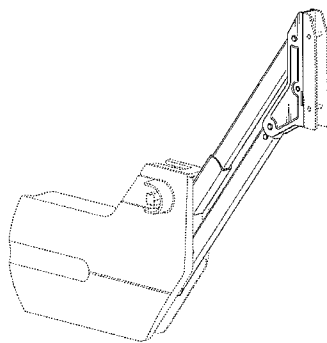

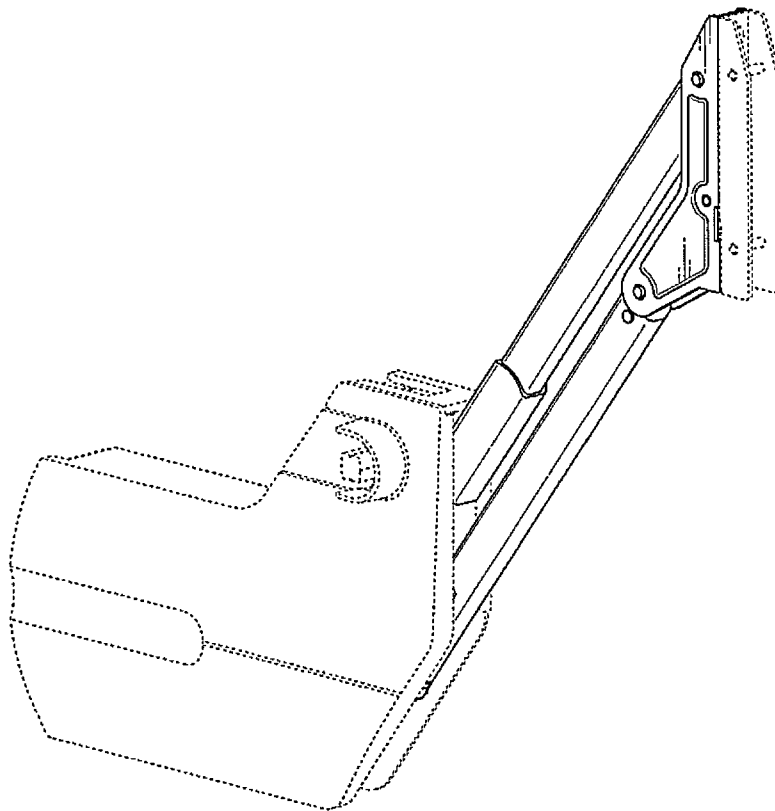

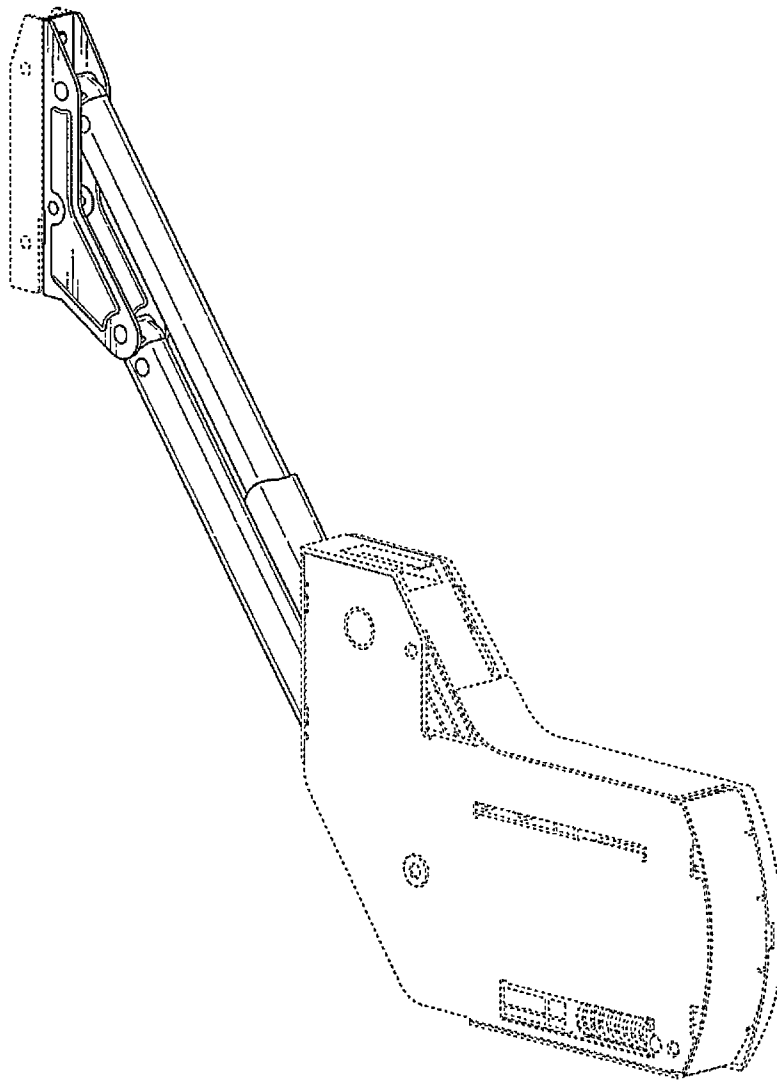

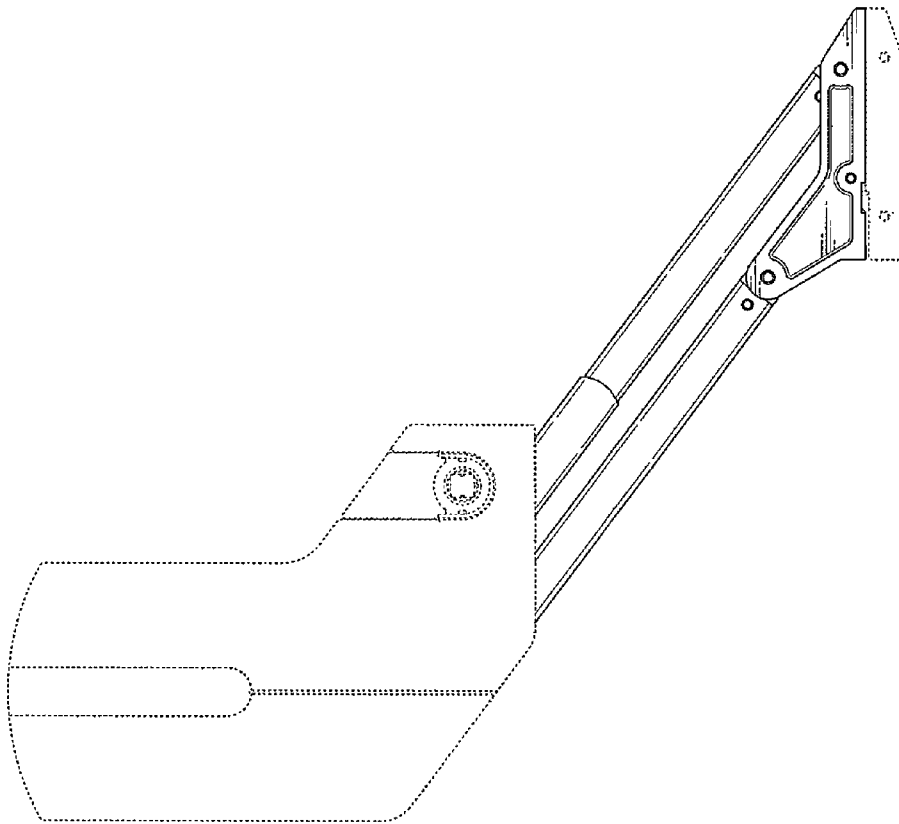

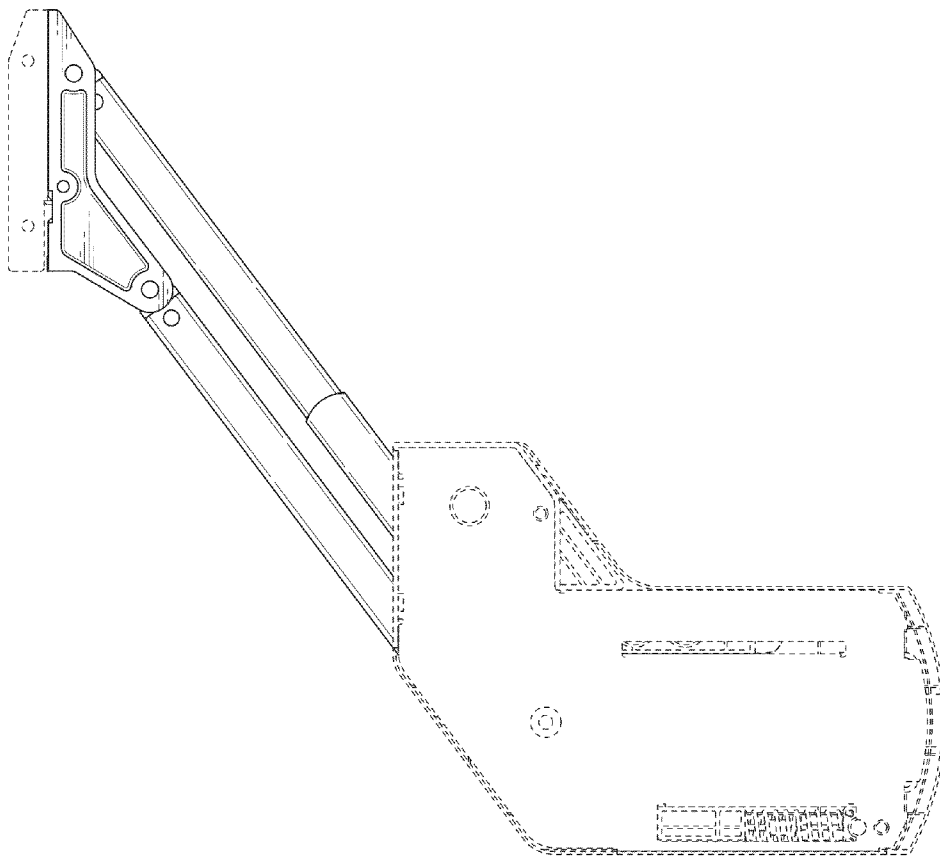

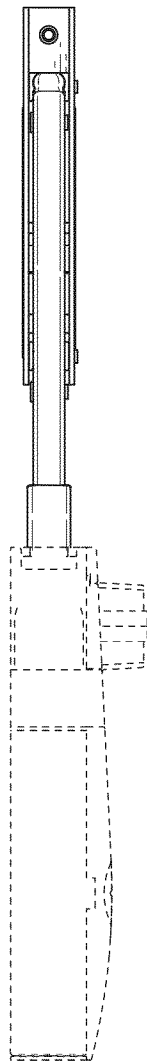

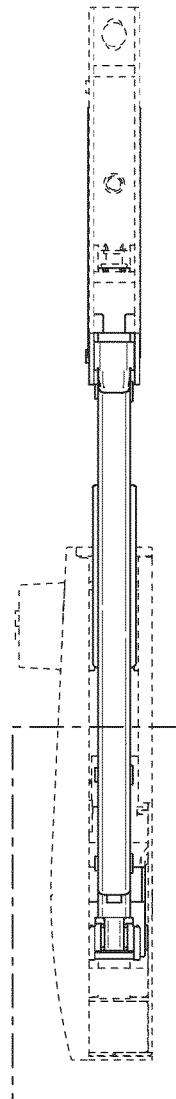

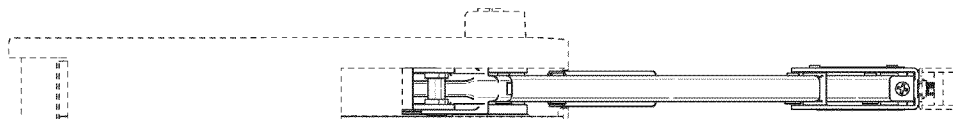

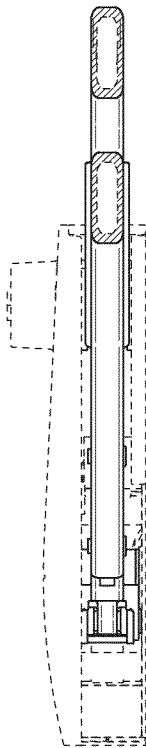

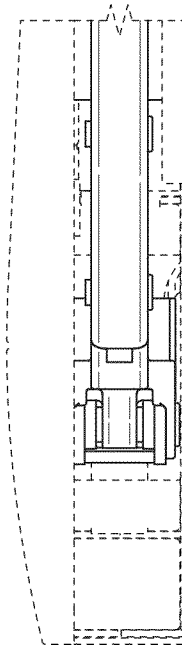

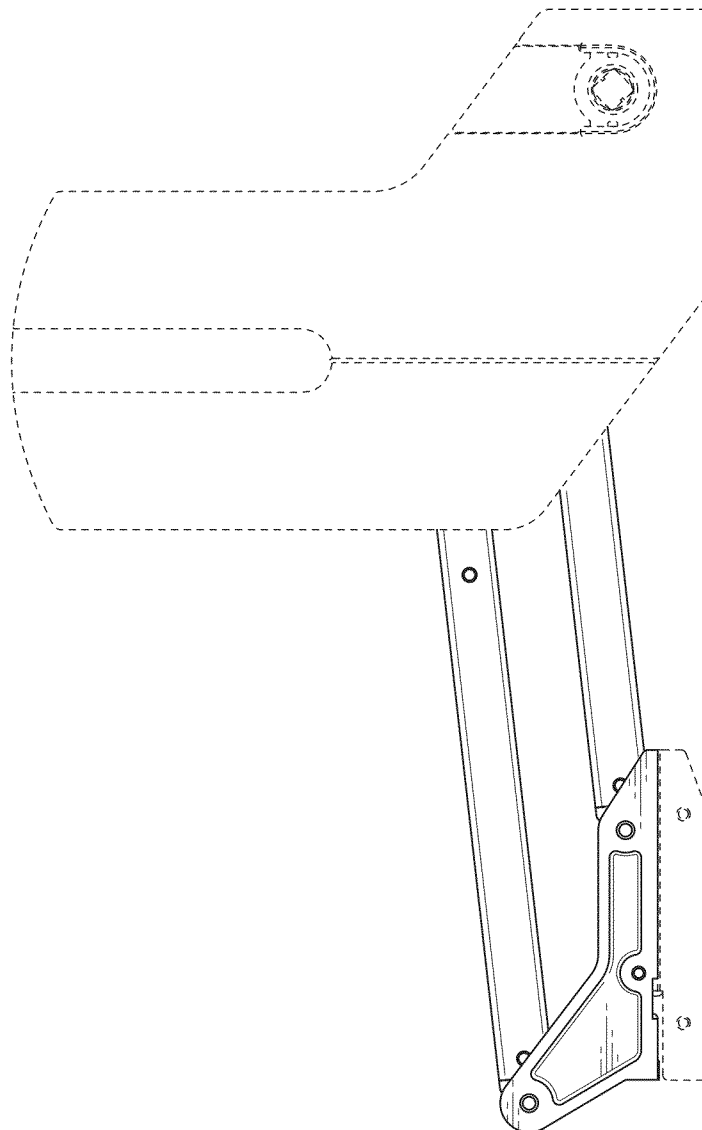
