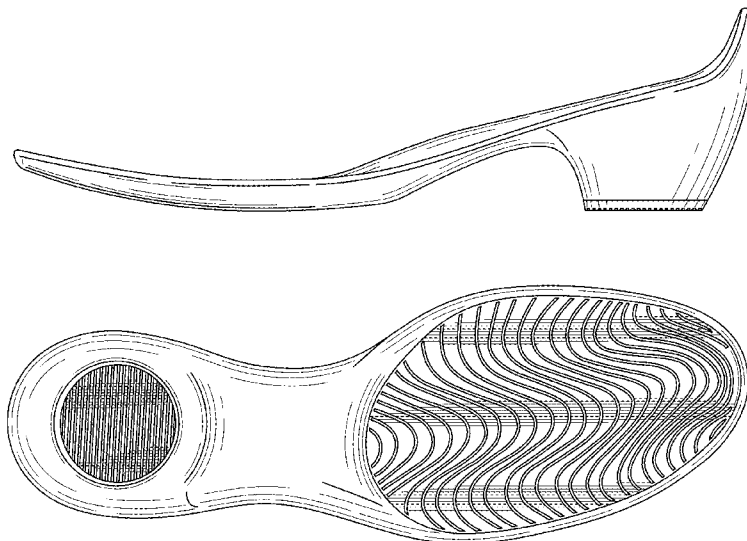
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top, right-hand side perspective view of a sole comprising a new, original and ornamental design;

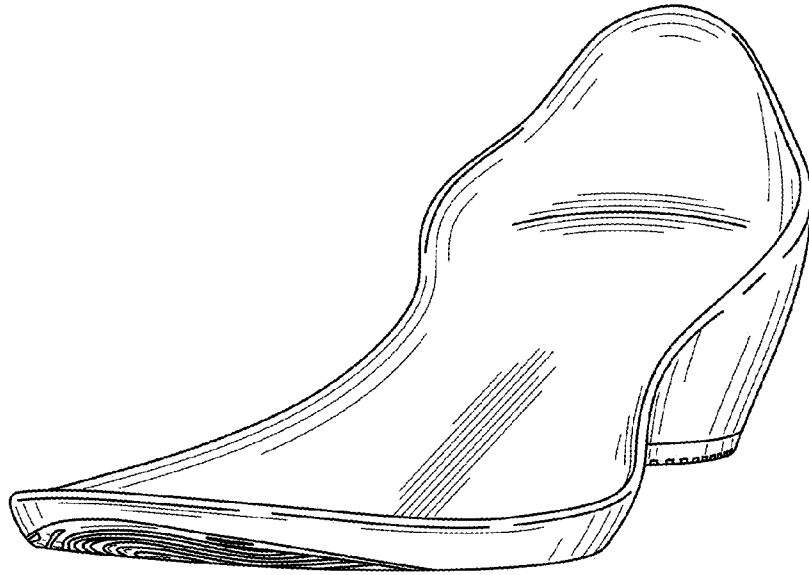

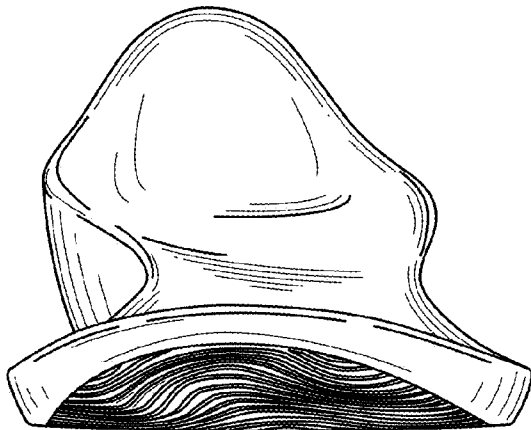

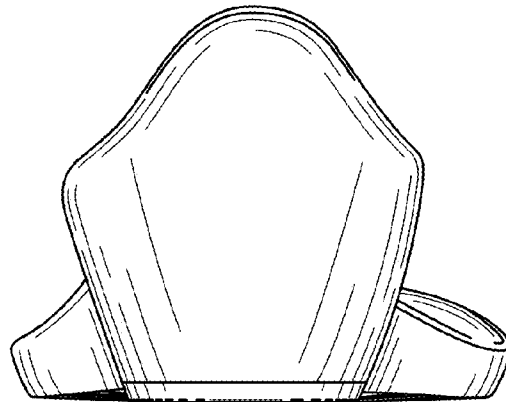

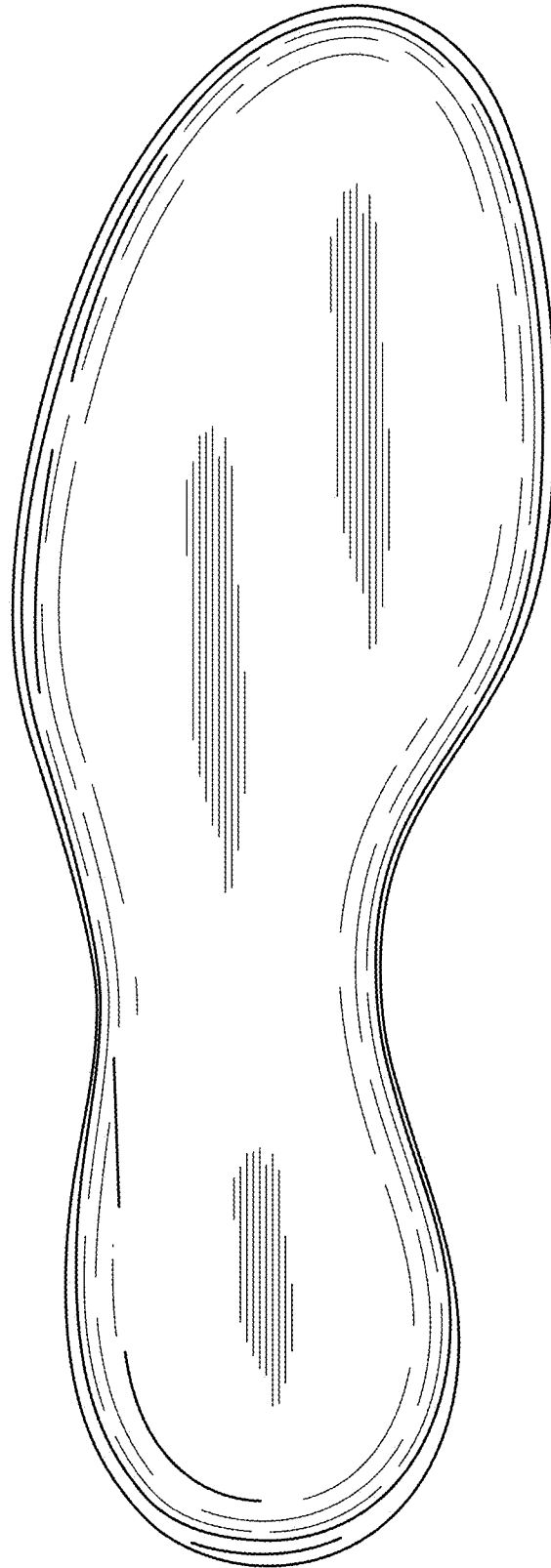

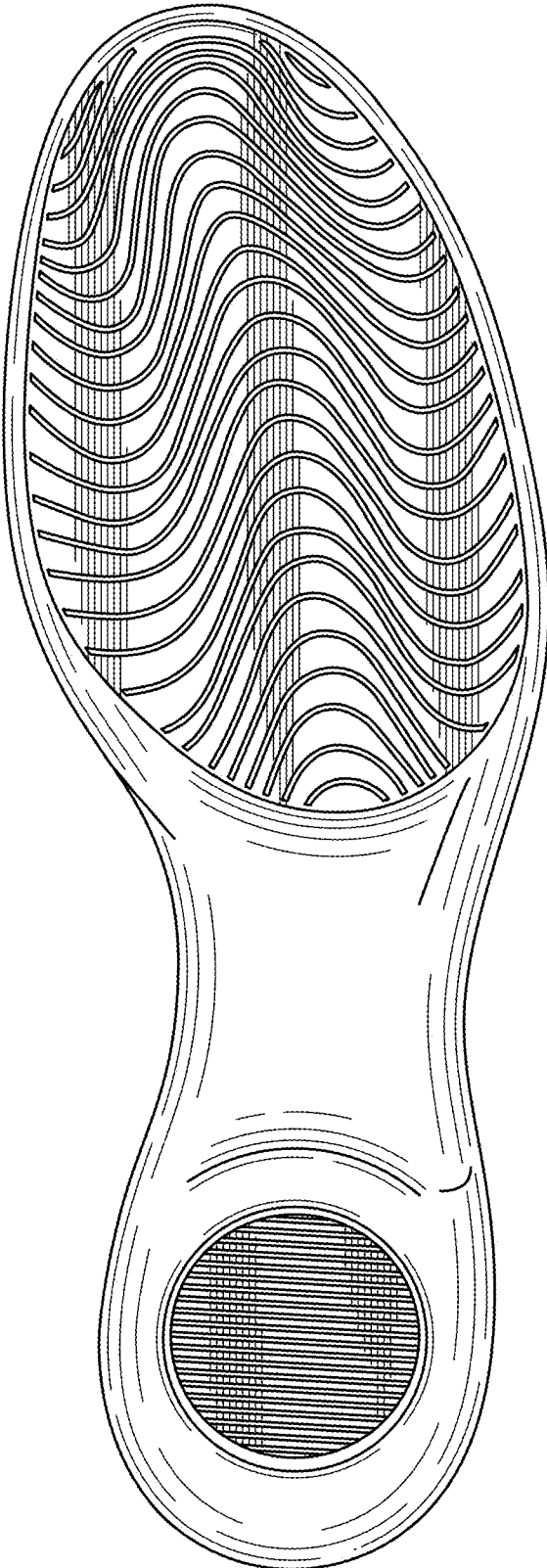
