(57) **CLAIM**

The ornamental design for a headset, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of a headset; FIG. 2 is a bottom, back, right side perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a back view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof.

The broken lines adjacent the contour surfaces represent the bounds of the claimed design, while all other broken lines are directed to portions of the headset that form no part of the claimed design.










