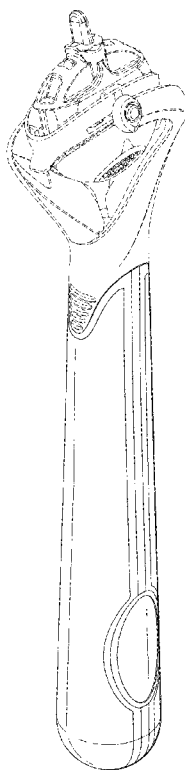
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a handle for a razor of the present invention;
FIG. 2 is a front view thereof;

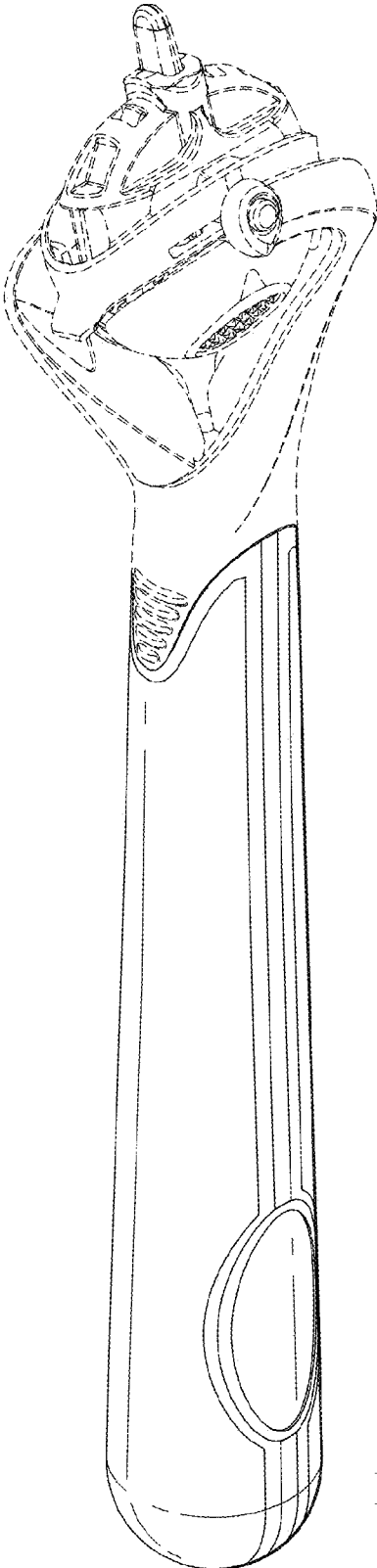

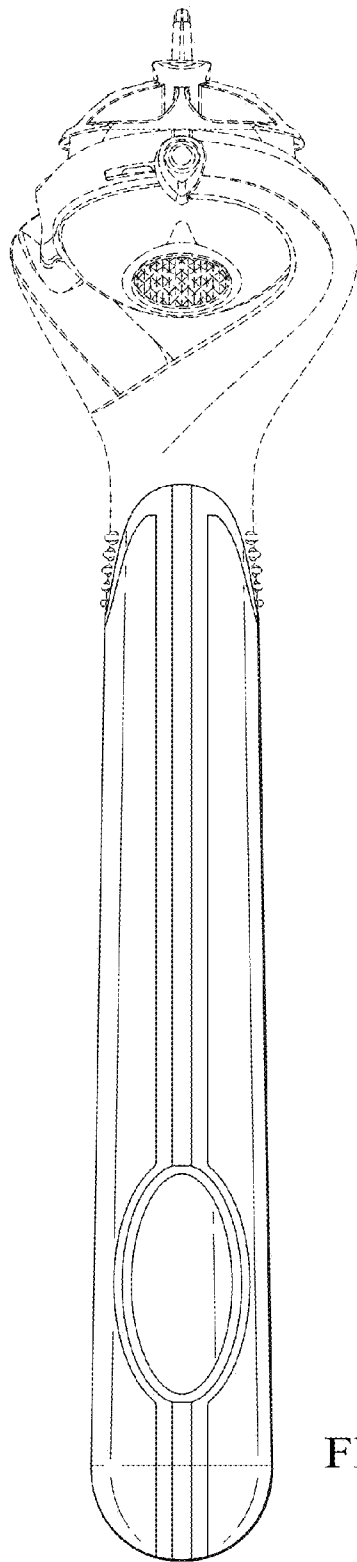

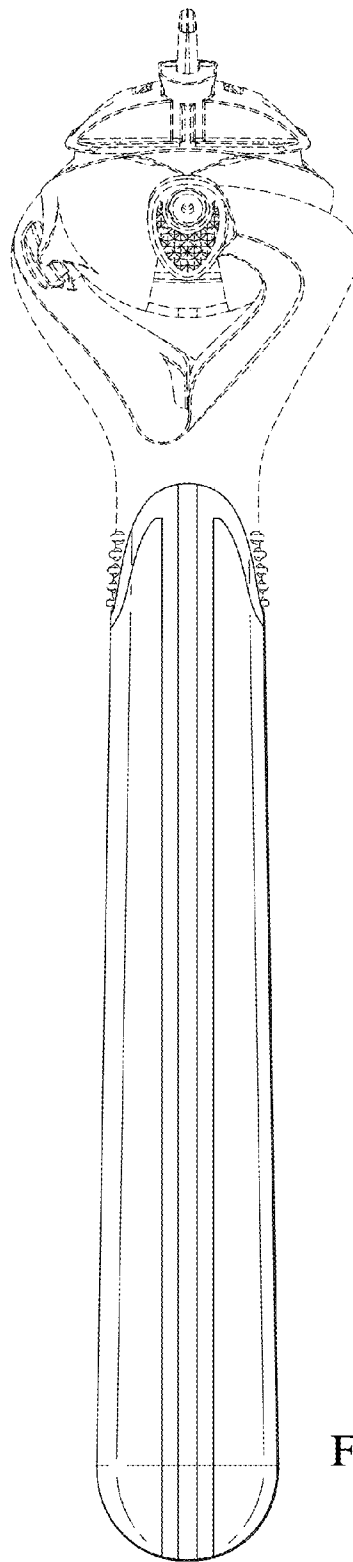

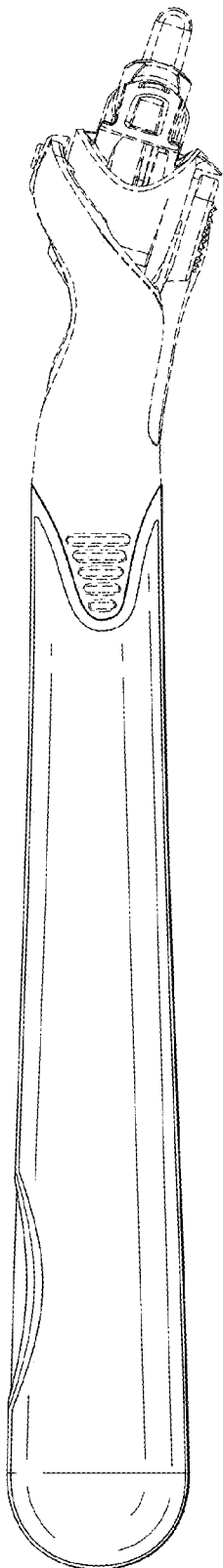

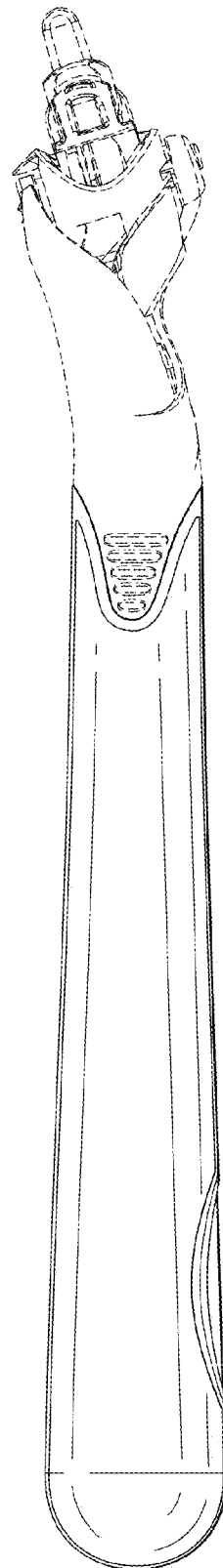

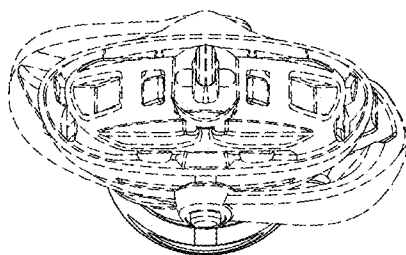

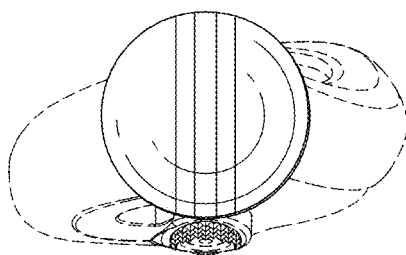
