FIG. 7 is a bottom plan view of a carriage wheel shown in FIG. 1.

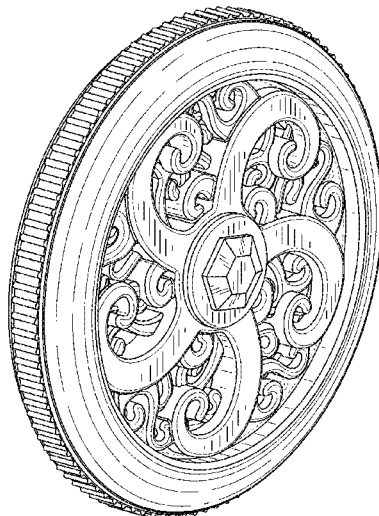

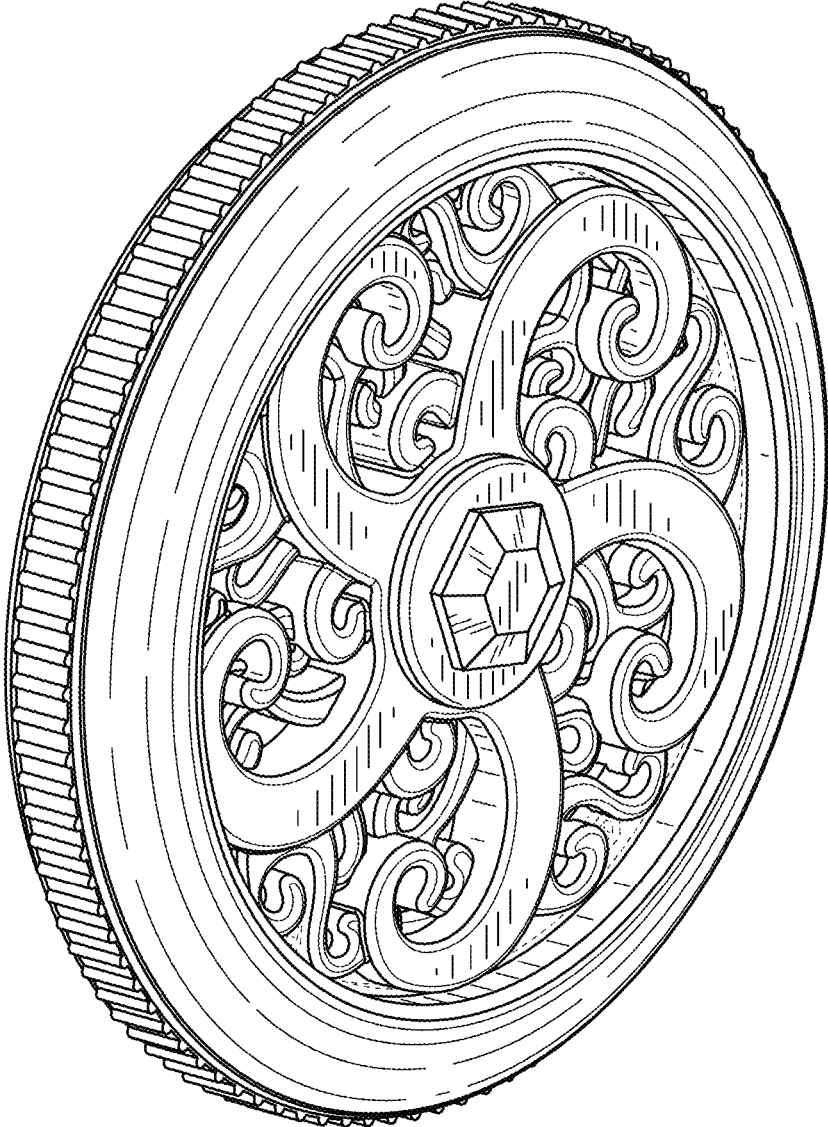

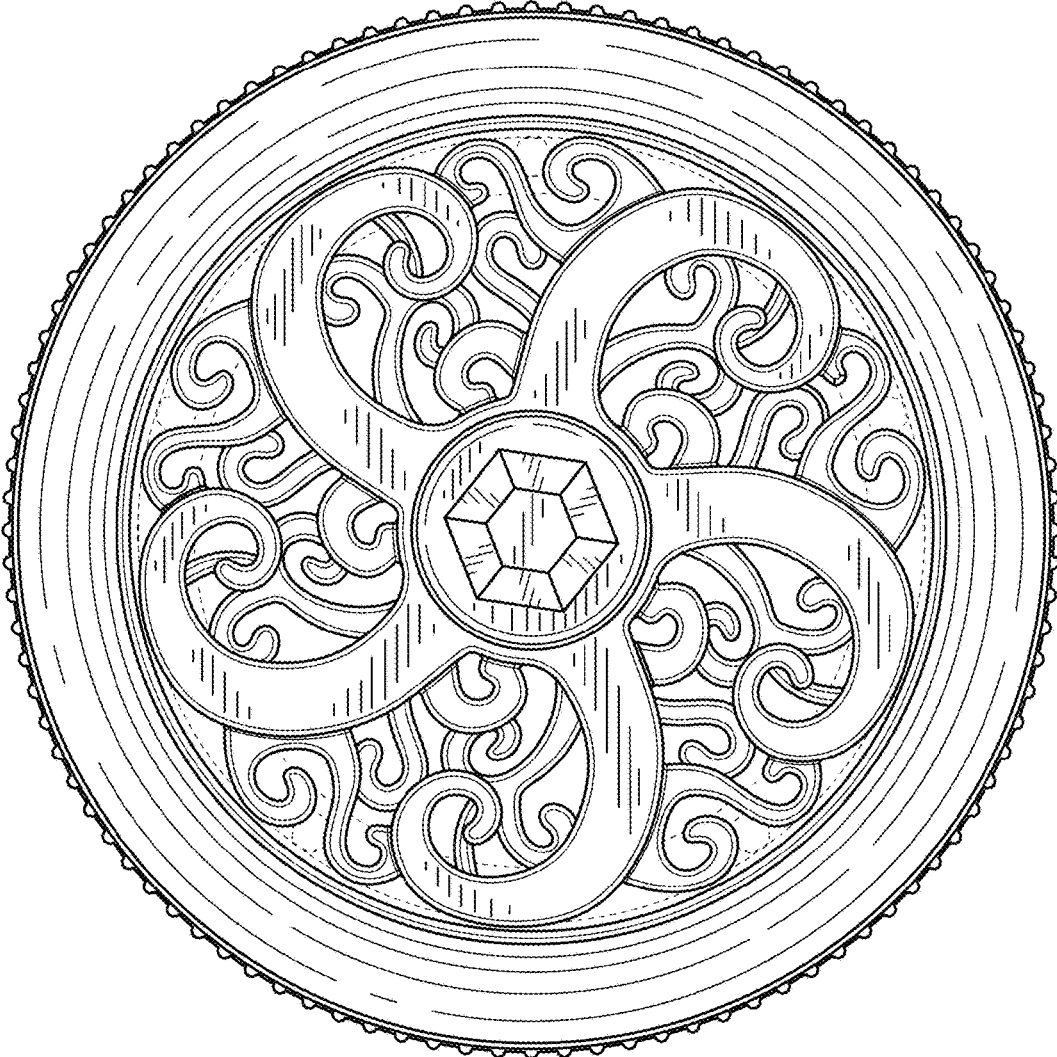

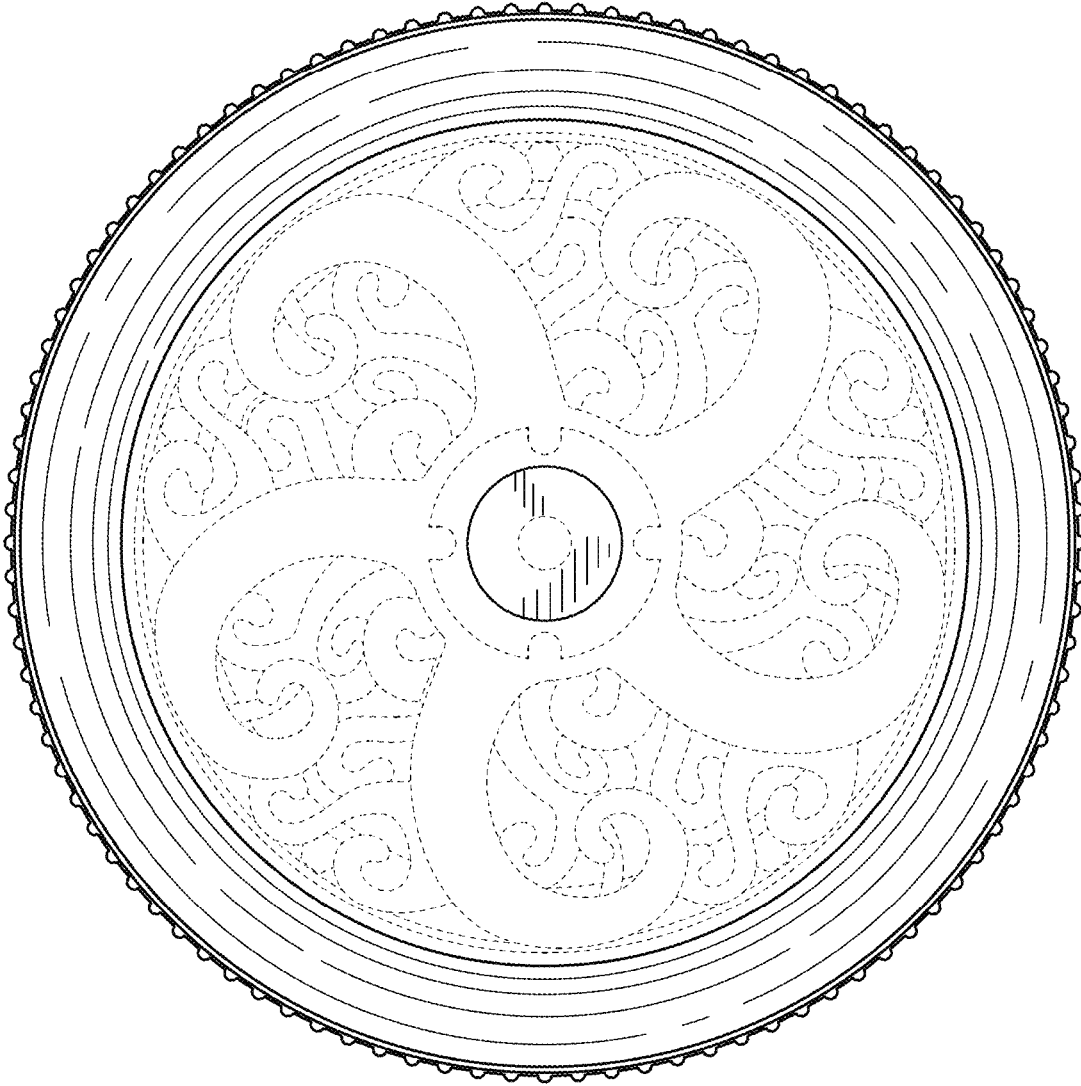

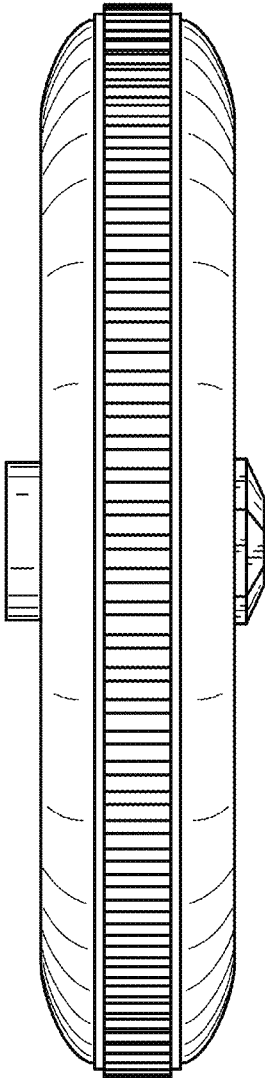

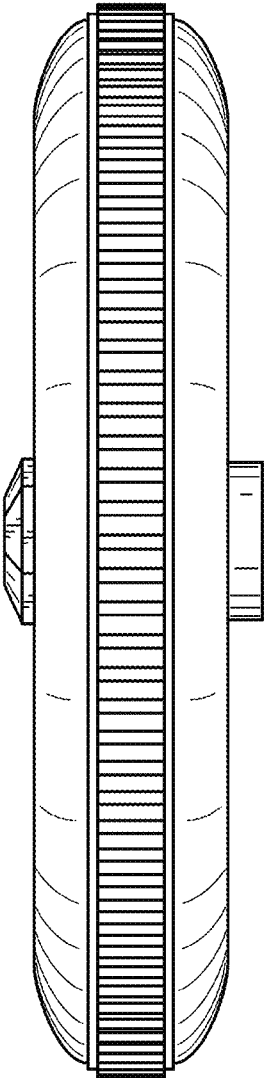

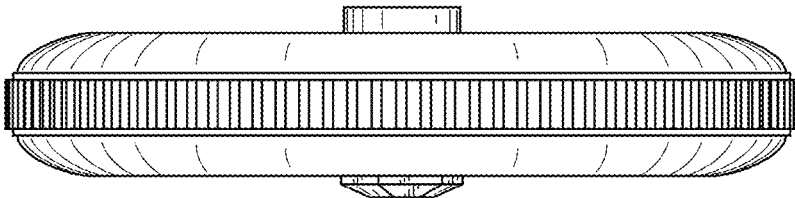

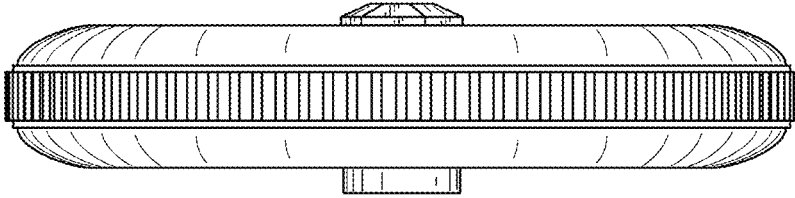
