The ornamental design for a surface cleaning apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right-side perspective view of a surface cleaning apparatus showing our new design according to a first embodiment;
FIG. 2 is a front view of the surface cleaning apparatus of FIG. 1;
FIG. 3 is an enlarged top view of the surface cleaning apparatus of FIG. 1;
FIG. 4 is a left side view of the surface cleaning apparatus of FIG. 1; and,
FIG. 5 is a rear view of the surface cleaning apparatus of FIG. 1.
Portions of the surface cleaning apparatus shown in broken lines form no part of the claimed design. Unshaded portions adjacent to solid line material form no part of the claimed design.










