(57) **CLAIM**

The ornamental design for a disc media player, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a disc media player, with media stick mounted, showing our new design;

FIG. 2 is a front, top, and right side perspective view of a disc media player, with media stick unmounted;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a left elevation view thereof;

FIG. 6 is a right elevation view thereof;


FIG. 7 is a top plan view thereof; and,

FIG. 8 is a bottom plan view thereof.

The simple dashed broken line portions of FIGS. 1-8 are included to show unclaimed subject matter only and form no part of the claimed design.










