The ornamental design for a muzzle brake, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of a muzzle brake according to the present disclosure.

FIG. 2 is a top, back, right perspective view of the muzzle brake of FIG. 1.

FIG. 7 is a top view of the muzzle brake of FIG. 1.


FIG. 8 is a bottom view of the muzzle brake of FIG. 1.




















